Section 1 – Summary

This report asks the Panel to consider the application for a Review received from the Metropolitan Police Service under s.51 of the Licensing Act 2003 ("the Act").

The application relates to Seán Óg, 108 High Street, Wealdstone, Harrow, HA3 7AH.

The review has been submitted as a result of undermining the licensing objectives of prevention of crime and disorder and public safety.

Section 2 – Report

- 2.1 An application has been received on behalf of the Metropolitan Police Service under s.51 of the Licensing Act 2003 ("the Act") to review the premises licence for Seán Óg, 108 High Street, Wealdstone, Harrow, HA3 7AH., currently held by Paul Martin Nee.
- 2.2 The Licensing Objectives to which the review applications relate to are:
 - Prevention of Crime and Disorder;
 - Public Safety;
- 2.3 The Metropolitan police have submitted the review following ongoing issues with the premises which they have previously sought to resolve informally. Including:
 - 13 August 2018, Officer witnessed issued with the CCTV system
 - 05 January 2019, A written warning issued in relation to issues with the CCTV recording system and refusals log
 - 31 January 2020, a further written warning for issues with the CCTV system
 - 24 February 2022, a final warning issued for conducting alleged licensable activities without a valid authorisation (trading past their licensed hours).
- 2.4 On 11 March 2023 a serious incident of violence took place inside the premises. This incident occurred after the premises should have been closed according to the licence conditions and included evidence from parties that licensable activities were alleged to be occurring after the permitted hours.
- 2.5 The Application to review the premises licence was received on the 6 April 2023. The application has been advertised in accordance with the prescribed regulations

Description of premises

- 2.6 The premises are located on the busy highway of High Street, Wealdstone. The premises is a public house which conducts its main business from the ground floor and it is also advertising that it has a rooftop garden
- 2.7 An image of the premises and a location map are provided at Appendix 6.

Licensing history

- 2.8 A premises licence was first granted in 2005 by way of a conversion application made under the transitional provisions under the Act. The licensing authority received an application to transfer the licence and to vary the designated premises supervisor to Mr Paul Martin Nee on 7 August 2017. After this time, no further applications have been received.
- 2.9 The current premises licence including operating hours, conditions and plan are attached at Appendix 2.

Representations

- 2.10 The authority has received one representation from Alan Riley, Licensing Officer on behalf of the Licensing Authority in its capacity as a responsible authority. The representation is based on the undermining of the prevention of crime and disorder, the prevention of public nuisance and the public safety objectives.
- 2.11 The representation explains that the metropolitan police and Licence Authority have issued warnings to the current licence holder regarding the undermining of licensing objectives and breach of conditions. The representation shows additional history including a letter of warning in 2017 shortly after transfer of the licence. The warning letter is attached to his representation under AR1.
- 2.12 The Licensing Officer states that despite several attempts made by two responsible authorities, the licence holder has consistently failed to comply with requirements.
- 2.13 Due to consistent failures, and lack of confidence in the licence holder and the bar manager, the Licensing Officer recommends that the Committee consider revocation of the licence.

Officer observations

- 2.14 The applicant alleges that during several visits by the police to ensure compliance, the licensee has not been able to uphold one or more of the four licensing objectives. That licensing objectives are being undermined and conditions are not being complied with (including the times for licensable activities and hours open to public). This is despite trying to work with the licence holder on several occasions and issuing warning letters.
- 2.15 The applicant has put forward conditions that may be considered appropriate to be placed on the licence if the Panel is minded to consider this as an appropriate option. They also suggest a reduction in hours. The Licensing Officer's representation identifies further history with the premises and suggests that if the Panel are minded; that revocation of the licence should be considered.

- 2.16 It is noted by officers that during the latest incident of grievous bodily harm that took place at the premises, Mr Nee was not present. The incident took place beyond the hours authorised by licence. As the premises was still trading after authorised hours, this is a breach of Part 7 - s.136 (unauthorised licensable activities) of the Act.
- 2.17 The Panel must, having regard to the application and any relevant representations, determine the appropriate outcome for the hearing which may include:
 - to modify the conditions of the licence;
 - to exclude any of the licensable activities from the scope of the licence;
 - to remove the designated premises supervisor;
 - to suspend the licence for a period not exceeding 3 months;
 - to revoke the licence
 - to allow the licence to remain in its existing state
- 2.18 Under the Act, if the Panel takes a step under (a) or (b above), it may specify that the modification or exclusion is to have effect for a period up to three months if it considers this to be appropriate.

Licensing policy

2.19 In considering the Application for Review as set out in Appendix 1, the Panel will consider the relevant section for reviews in the statement of licensing policy attached to this report at Appendix 4. The Panel has discretion to depart from the guidelines, which are designed with consistency and transparency of decision-making in mind.

Statutory guidance

2.20 Paragraph 10.27 of the Statutory Guidance (December 2022) under section 182 of the Act states in part:

"The main purpose of the 'designated premises supervisor' as defined in the 2003 Act is to ensure that there is always one specified individual among these personal licence holders who can be readily identified for the premises where a premises licence is in force. That person will normally have been given day to day responsibility for running the premises by the premises licence holder...".

- 2.21 The whole of Section 11 of the Statutory Guidance (December 2022) which covers reviews is attached to this report at Appendix 5.
- 2.22 In addition to determining the application in accordance with the legislation, Members must have regard to the
 - Common law rules of natural justice (i.e. ensuring a fair and unbiased hearing etc.);
 - Provisions of the Human Rights Act 1998;
 - Considerations in section 17 of the Crime and Disorder Act 1998.

- 2.23 The Panel must also act appropriately with regard to the European Convention for the Protection of Human Rights and Fundamental Freedoms implemented under the Human Rights Act 1998, particularly articles 6 (relating to the right to a fair trial); article 8 (protection of private and family life); and article 1 of the First Protocol (protection of property).
- 2.24 The Panel, when exercising its powers, must consider section 17 of the Crime and Disorder Act 1998 which states:

'without prejudice to any other obligation imposed on it, it shall be the duty of each authority to which this section applies to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.'

2.25 Full copies of the Council's Statement of Licencing Policy, hearing procedure and statutory guidance to the Act will be available at the Panel Hearing or in advance if so required.

3. Alternative Options considered

3.1 Not applicable.

4. Legal Implications

- 4.1 The Licensing Authority is required to hold a hearing to consider the review application and any relevant representations made. The hearing must be held in accordance with the Act and the Licensing Act 2003 (Hearings) Regulations 2005.
- 4.2 The Licensing Panel is required to give appropriate weight to the review application, representations (including supporting information) presented by all the parties, the Guidance issued pursuant to section 182 of the Licensing Act 2003, the Council's Statement of Licensing Policy and the steps (if any) that are appropriate to promote the four licensing objectives
- 4.3 The Licensing Panel shall determine the application in accordance with S.52 of the Act.
- 4.4 The Panel should also note:
 - clear reasons must be given for the decision.
 - any additional or modified conditions should be practicable and enforceable.
- 4.5 The applicant for the review, the premises licence holder and any person who made relevant representations would have the right of appeal to a magistrates' court on one of the grounds provided in schedule 5 to the Act.

Sea'n O'g (previously trading as TJ's sports bar) is a small size bar in a busy high street in Wealdstone Harrow.

The times for hours open to public and the playing of recorded music are: Monday to Friday 10.30 am to 00.30 hours Saturday/Sunday 10.30am to 01.30 hours.

The hours for the sale of alcohol are: Monday to Friday 11.00am to 00.00 hours Saturday 11.00 to 01.00 hours Sunday 11.30 hours till 01.00 hours.

A copy of the premises licence is attached to this review application.

Sea'n O'g was the scene of a violent incident of grievous bodily harm (GBH) that took place on Saturday the 11th of March 2023 just before 02.00 am whilst the premises was open and trading, when its permitted hours are to stop serving at 01.00 hours and to be closed by 01.30 hours.

On 13 August 2018, Officer 662QA (PC Patrick Moran – Police Licensing Officer) visited the premises at 11:53 hours and amongst other matters, he reported that the CCTV not recorded previous days due to a water leak over the recording machine. He also reports that the fire alarm was faulty.

On 5/1/2019, the venue was given a written warning by PC Downes for three breaches of annex two: condition 4 (a monitored central station alarm will be installed, operated and maintained), condition 5 (CCTV will be installed operated and maintained and kept for 31days), and condition 6 (a record of age-related refusals will be kept and made available to officers of the police or local authority).

On 31/01/2020, another written warning was given by PC Cowley for another breach of condition 5 in annex 2.

On 24/02/2022, a final warning regarding staying open past its hours was given by PC Darwood 2158NW.

A copy of each warning is attached for reference.

Please provide as much information as possible to support the application: (please read guidance note 3)

On 11/03/2023, The premises of Sea'n O'g has come to notice once again following an incident of GBH that took place on 11/03/2023, where there was a fight between two groups of at least six persons.

Following enquiries into the incident, it was noted that it took place between 01:47 hours and 01:52 hours. The premises license states that the premises should stop serving alcohol at 01:00 and to be closed at 01:30 hours on Friday and Saturday into the early hours of Sunday.

CCTV footage clearly shows people inside the venue with drinks, sitting at tables, and others standing/walking around.

One of the victims of the assault stated he arrived at the venue to meet his brother at 01.45 hours and was ordering two pints of larger at the bar for himself and his brother when he was aware of an unknown male swearing at his brother. The male then started to push his brother in an attempt to confront him, so he stepped in to try and calm the situation which failed, and a fight ensued.

From the CCTV footage you can see a male forced to the floor and kicked. Others joined in and punched each other, and a chair was used to hit a male. The fight continues over to the pool table. A male holding a sharp object then assaulted two men, causing puncture injuries to the neck/head area and slashing another person's hands as he tried to defend himself. The footage also shows that there are chairs being thrown and pool cues were used to hit/assault persons involved. You can also hear music being played in the background. Two males and two females then exited the bar via the front doors. The bar manager, Miss O'Sullivan, dialled 999 and requested an ambulance and told the second group to remain inside the venue to avoid further assault/injury. The paramedics arrived and administered first aid to the victims to treat stab wounds to the neck and head area, as well as cuts to hands. On the paramedic's arrival, the paramedics called for police assistance. It is noted that Mr Paul Nee who is the DPS and Licensee was not present at the premises at this time and Miss O'Sullivan was the only staff member present.

On 16/03/2023, PS Clarke, PC Cowley, and Mr Ash Waghela from Harrow Council visited Sea'n O'g and spoke to Miss O'Sullivan. The DPS, Mr Nee, was not present due to childcare. The venue had been closed for a few days due to the crime scene and they had painted the floors to the rear of the premises, so we stayed in the main bar area. We asked what had happened that night and Miss O'Sullivan told us a version of events, adding that the groups were regulars and that she had no reason to have been concerned. When asked about the closing times, Miss O'Sullivan was not sure and had to obtain a copy of the license. Having looked, she admitted that she had misunderstood the times and accepted that the venue should have been closed at the time the incident occurred.

It was discussed whether the bar would consider reducing its hours to prevent further issues past midnight. The following day, PS Clarke and Ash Waghela met on MS teams to discuss this issue further with Miss O'Sullivan. PS Clarke advised that they shut at 23:00 hours. Miss O'Sullivan offered to stop entry into the pub at 23:00 and to stop serving at 23:30 hours, with closing at 00:00 hours. Miss O'Sullivan also stated that they would be employing a glass collector to assist them so she would not be alone.

The concern with the venue is that it operated outside of its permitted hours. Had it been shut, the incident would not have occurred. They had to be reminded of the hours and did not seem to realise they were in breach of their license, despite two previous warnings. It is also concerning that one person runs the bar and has to deal with any incidents on their own.

Both Harrow Council and the Police licensing team have tried to engage with the PLH, Mr Nee, after incidents, to prevent crime and disorder and promote public safety. When I spoke to Mr Nee, he did not seem overly concerned about the incident or previous warnings. It appeared that his main priority was to keep a late-night license in order to remain afloat.

The Police seek a review of the premises license to reduce the risk of this type of incident from taking place again. Suggested amendments would be:

- 1. Reduction of closing hours to 23:00 hours on each day.
- 2. Removal of the pool cues when the table is not in use and the cues to be issued and returned behind the bar after each use.
- 3. Security Industry Authority approved security to be employed should the pub be open past 23:00 hours.

4. A register/log containing the names, badge number, dates and times of duty of security staff and any incidents that occur shall be kept and made available to Police and licensing authority.

- 5. The bar/serving area to be secured so that the public cannot gain entry, i.e. a lockable door/hatch.
- 6. More than one person to work at the venue past 19:00 hours.
- 7. A new DPS installed who will be in attendance for most of the hours that the venue is open/trading.
- 8. Polycarbonate glasses to be used after 19:00hrs. All bottles decanted as glassware was potentially used as a weapon.
- 9. The premises will not allow entry to patrons one hour before the end of licensable activities.

10. An incident log shall be kept at the premises for at least 12 months and examined on a regular basis by the DPS, and the date and time of each examination will be endorsed in the register. The register shall be made available immediately on request to an authorised officer of the licensing authority or Police which will record the following:

A: All crimes reported to the venue, or by the venue to police.

B: All ejections of patrons.

C: Any complaints received.

D: Any incidents of disorder.

E: Any visits by a relevant authority or emergency service.

To remove the CCTV condition from Annex 2 of the licence and replace this with:

The CCTV system to be maintained and operated in good order and to the satisfaction of the Metropolitan Police's reasonable requests. The medium upon which the images are recorded will be clearly identifiable, stored securely and retained for a period of not less than 31 days and will be made available to Police and Licensing Authority Officers immediately upon request.

Such footage must be provided in an immediately viewable format and must include any software etc. which is required to view the footage. Any discs, portable drives or other storage media onto which the footage is transferred must be provided by the premises.

A member of staff who is trained to operate the system and supply the footage must be present at the premises at all times when licensable activities are taking place.

The Designated Premises Supervisor or authorised person by him must ensure that the CCTV system is checked at least once every week by a suitably trained member of staff. This check must include the operation of the cameras, the recording facilities, the facilities for providing footage and the accuracy of the time and date.

It is also recommended that the sale of alcohol stops at least 30 minutes before the terminal hour for hours open to public to allow for drinking up time.



I am writing in reference to the recent allegation of criminal damage at your establishment – TJ's Sports Bar, 108 High Street, Wealdstone, HA3 7AH on Thursday the 26th of December 2019 at 01.49 hours.

METROPOLITAN

POLICE

I submitted a written request for the CCTV making two trips to your venue to obtain the footage. I spoke with a member of your bar staff (Paul) who informed me that he had passed on the request to you.

On the 13th of January 2020 I spoke with Joanna O'Sullivans who told me that the CCTV system was broken over the Christmas period due to water damage and that your venue would not be able to supply any CCTV footage for the festive period. Joanna went on to say that the system had since been fixed but was only capable of recording for 14 days now.

I pointed out the conditions on your premises Licence which state on annex 2 of the premises licence as follows

Condition 5: CCTV will installed, operated and maintained according to the specification of the Metropolitan Police. Images will be securely stored, kept for a minimum of <u>31 days</u> and be made available to officers of the police or local authority upon request.

Whilst the damage to your CCTV system was unfortunate it does amount to a breach of your current conditions. I also note that on two previous visits to your establishment faults were evident with your CCTV system, on a visit conducted by PC Downes on the 19th of December 2018 she was informed that the CCTV only recorded for 28 days and not 31 as above. On the 13th of August 2018 PC Moran requested to view footage from the 12th of August 2018 and was told the CCTV system was not working due to a water leak which damaged the CCTV.

Another point of concern is your trading hours on Christmas day, according to your premises licence your hours are 12 noon to 3pm followed by 3pm to 2230pm. The officers who reported the crime in the early hours of Boxing Day 26th December 2019 at 01.49am asked your staff what time you were trading too. The officers were informed that the venue was having a private party/lock in. It is noted that you had no arrangement such as a temporary event notice in place for this event.

I must point out that any breaches of the premises Licence amount to an <u>offence</u> under s.136 Licensing Act 2003, which carries an unlimited fine and/or up to 6 months imprisonment.

This letter is a final written warning. The Metropolitan Police as a Responsible Authority under the Licensing Act 2003 reserves the right to initiate a Review of your Premises License and take enforcement action with reference to the commission of offences under the 'Act'



I have previously visited your venue alongside Harrow Councils Licensing Team and made you aware of some incidents and complaints regarding disorder and anti-social behaviour from your patrons. These incidents have occurred at the venue above where you are the current Premises Licence Holder (PLH) one such incident required your establishment to provide CCTV to Police as per Annex 2 of your licence.

The incident on the 20th February 2022 has caused GBH level injuries to the victim and as such your CCTV has been downloaded and reviewed. Analysis of this CCTV has shown you operating and selling alcohol for an hour after you are licensed to do so whilst also allowing patrons to leave the premises with glasses in hand.

I must point out that any breaches of the Premises Licence amount to an <u>offence</u> under s.136 Licensing Act 2003, which carries an unlimited fine and/or up to 6 months imprisonment.

This letter is a final written warning. Sean O'g crime report 2003###/23 11th March 2023 summary of report.

At 0218hrs on 11th March 2023 Police and LAS were called to Sean Og public House, 108 High Street, Harrow to reports of a fight between several people with reported injuries. Upon arrival police located 3 Albanian males inside the pub with varying degrees of injuries.

One of the males had a very serious cut to his neck believed to be arterial bleed and cuts to his head, arm and hands. A second male has cuts to his body and neck but not as serious as the first. A third male has cuts to his hands and body. These males were assessed at the scene by LAS.

2 more males were located nearby on Canning Road and both from the travelling community. They had cuts and blood on them. Enquires with CCTV identified these males to be related to the fight and both arrested for GBH. In total 5 persons were taken to hospital as follows: 2 x males to St Mary's hospital, 2 x NPH, and 1 x Ealing Hospital. Crime scenes are currently in place covering the following locations: From 'Sean Og 'public House / 'Mere' Food Centre JCT Grant Road and along the road to Town Centre, High Road/Green Leaf Way however as of 0537hrs scaled back to cover just the public house.

CID - SOCO scene guidance

Suspect party (Irish males) were sitting at the bar. One of them was drinking from a Strongbow can and one out of a glass, both of which remain on the bar by a mobile phone which belongs to one of the suspects. Victim party (Romanian males) were sitting further along the bar towards the back of the pub, opposite the Stella tap.

Items to consider seizing / swabbing:

(Outside) Broken pool cue - this has been moved from the road by the pavement curb to just inside the scene to preserve.

(Inside) Multiple broken pool cues - on pool table, on floor by sofa, on floor by pool table, leaning against the wall by the toilets. Broken chair legs. Broken glasses - on floor by pool table, on floor by bloodied clothing, on floor by pale coloured coat. Mobile phone on bar. Chanel scarf under table by pool table. Glass with liquid in next to mobile phone on bar. Strongbow can near mobile phone.

CCTV UPDATE

Two SIM cards have been removed from two of the newer cameras from inside the Sean Og pub. These were able to be removed from the scene with the landlady's consent. These cameras face the pool table and the bar. I have reviewed some of this footage and identify the clip which captures the beginning to the end of the incident. This has been added under the BWV section and the SIM cards handed to ET. The other cameras in the pub are older and therefore require downloading with a USB.

Joanne O'Sullivan stated that two Irish guys were with two women in the bar. Next to them were a few Romania guys. One of the Irish guys made a joke to the Romanian guys about his keys being dropped on the floor. The Romanian looked down and then everything kicked off.

O'Sullivan thinks that words were said between parties in the bathroom earlier in the night. Both groups had been drinking for a considerable time. O'Sullivan repeatedly told the Romanian guys to sit down. A blond Romanian guy put the bar flap down and told O'Sullivan to stay there.

Things were being thrown across the room, everyone was throwing punches and it was chaos. The two Irish women were screaming and begging their partners to leave. The Irish men left from the front and then O'Sullivan instructed the Romanians to leave out the back so that they wouldn't cross paths. O'Sullivan stated that she put different items of clothing on his's neck putting pressure on the injury to stem the bleeding and called 999.

Whilst all parties were known to O'Sullivan and were regulars in her pub, they did not know each other.



Annex 1 – Mandatory Conditions

Mandatory conditions where licence authorises supply of alcohol:

1 No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

2. Every supply or sale of alcohol made under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where licence requires door supervision:

Where one or more individuals are required to be at the premises to carry out a security activity, such individual(s) must be licensed by the Security Industry Authority.

The Licensing Act 2003 (Mandatory Licensing Conditions) (Amendment) Order 2014

1. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

(a)games or other activities which require or encourage, or are designed to require or encourage, individuals to—

(i)drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii)drink as much alcohol as possible (whether within a time limit or otherwise);

(b)provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

(c)provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d)selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

(e)dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

3. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

(a)a holographic mark, or (b)an ultraviolet feature.

4. The responsible person must ensure that-

(a)where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

(i)beer or cider: 1/2 pint;

(ii)gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii)still wine in a glass: 125 ml;

(b)these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c)where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

Mandatory Condition order 2014

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purposes of the condition set out in paragraph 1-

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979

(b) "permitted price" is the price found by applying the formula-

P = D + (DxV)

where---

(i) P is the permitted price,

(ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a

capacity which enables the member or officer to prevent the supply in question; and

(e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Mandatory conditions where licence authorises exhibition of films:

(1) The admission of persons under the age of 18 years to exhibitions of films must be restricted in accordance with any recommendation made by the British Board of Film Classification, except where condition 2 applies.

(2) The admission of persons under the age of 18 years to exhibitions of films must be restricted in accordance with any recommendation made by the relevant licensing authority regarding the film in question

Annex 2 - Conditions consistent with the operating Schedule

1. Doors and windows to kept closed during performances of live music

2. Air conditioning to be in use during performances of live music

3. Noise and vibration shall not be allowed to emanate from the premises so as to cause nuisance





The following is a brief history of the premises from the date of the transfer to the current licensee.

08/08/2017, Premises transferred to the current licensee.

21/12/2017, Premises was inspected by licencing officer D Fergus. Please see for details of issues and breaches of conditions namely

1. The full premises licence was at the premises however a summary of the licence was not on display, as required under section 57 of the Act.

26/3/2018 (15:00pm) - Street Trading Visit - Visited the premises as there are 2 'A' Boards placed on the public highway. Joint visit with Neil G. Spoken with the manager - Ms Johanna O'Sullivan. Tel: **Explained the regs.**, application form, sketch, fees, public notice form. Advised that only 1 board permitted per single business. Instructed to remove both boards until the licence is granted for one. Form given and photo taken.

05/04/2018, unlicenced street trading at the premises, 2 A boards on site however, only one is permitted per premises providing that an appropriate licence is acquired.

14/10/2018, complaint received from resident, it was reported that there were issues with noise and ASB reported that there was damage to property ref CAD 7651410 13/10/2018.

10/08/2019, incident reported at the premises resulting in a broken window reported to police by Jo O'Sullivan {premises manager}.

19/06/2019-16/10/2019, Issues reported to the police with regards to large groups of males smoking drugs outside the premises and walking into the premises with lit tobacco/ marijuana cigarettes to use the toilet. Investigation into these issues highlighted issues with the CCTV system that were similar to those warned about in DF's warning letter 21/12/2017. Letter sent by PC Downs 05/01/2019 (see AR2)

26/12/2019, 01:49 Report of criminal damage at the premises logged with the police. All Licensable activities at the premises should have ceased at 22:30 on the 25/12/2019. As a result of this report on the 31/01/2020 a warning Letter was sent to the premises with regards to the over running of hours and also detailing issues with the CCTV being damaged and only set to record for 14 days not the 31 as required. (previously advised of this back in previous warning letter dated 21/12/2017). Additionally, the fire extinguishers were also untested. (See AR3 for letter sent).(AR3.1 Email from D Cowley to licencing).

12/06/2020, licence amendment change of name from TJ's to Sean OG.

20/02/2022, incident of Violence reported at the premises as part of the investigation it was found that there were unauthorised licensable activities at the premises by way of over running the timings as permitted by the licence. As a result of this a warning letter was sent by PC Darwood dated 24/02/2020. (see AR4)

11/03/2023, at 02:18 police and ambulance service were called following a report of a stabbing in the premises. (See AR5)

16/03/2023 13.06 hours Licensing officer Visit with PC Darren Cowley and SGT James Clarke. Met with Johanna O'Sullivan at the premises. Mr Paul McNee was not present as he had childcare commitments. Ash Wagela's Officer Notes from this meeting (AR6) In short; PC Cowley advised that the CCTV shows that there were customers still on the premises between 01:45 and 02:00 on Saturday 11/3/2023 and this was when the fight took place. Johanna says that the customers were trying to help stop the fight. Then she went on to say the trouble started from a joke and then tension built up and things got out of hand. She also confirmed that she was the only member of staff on the premises at the time. PC Cowley suggested that the premises should start to take last orders at 23:00 hours and close at 23:30 hours to prevent further incidents. Sgt Clarke would prefer the premises to close at 23:00 hours.

17/03/2023, A Microsoft teams meeting was held with Johanna O'Sullivan, Sgt James Clarke and I to discuss further steps. Sgt Clarke advised again that although we cannot force the premises to close at an earlier time that what is stated on the licence, he would prefer that the premises close daily at 23:00 hours. Johanna was opposed to this as it would affect her income.

06/04/2023, review application received.

As a responsible authority I note that this review application is warranted and support it fully. The Licensee has consistently shown his lack of ability to follow existing conditions and the current timings of the licence. I note that Joanna Sullivan was the only member of staff that was present at the time of the latest incident. Should the panel consider removing the Current DPS Paul McNee, Joanna Sullivan should not be considered as a suitable replacement. History shows she has been at the premises as Bar manager whilst offences have been repeatedly committed. The implementation of additional conditions or a reduction of time permitted to carry out licensable activities would be a waste of time and cause further issues.

As per my chronology above and the history of the premises. As the licensee and his management continue to ignore the current conditions and licence timings, I recommend that this licence be revoked.



I am writing in reference to the recent allegation of criminal damage at your establishment – TJ's Sports Bar, 108 High Street, Wealdstone, HA3 7AH on Thursday the 26th of December 2019 at 01.49 hours.

I submitted a written request for the CCTV making two trips to your venue to obtain the footage. I spoke with a member of your bar staff (Paul) who informed me that he had passed on the request to you.

On the 13th of January 2020 I spoke with Joanna O'Sullivans who told me that the CCTV system was broken over the Christmas period due to water damage and that your venue would not be able to supply any CCTV footage for the festive period. Joanna went on to say that the system had since been fixed but was only capable of recording for 14 days now.

I pointed out the conditions on your premises Licence which state on annex 2 of the premises licence as follows

Condition 5: CCTV will installed, operated and maintained according to the specification of the Metropolitan Police. Images will be securely stored, kept for a minimum of <u>31 days</u> and be made available to officers of the police or local authority upon request.

Whilst the damage to your CCTV system was unfortunate it does amount to a breach of your current conditions. I also note that on two previous visits to your establishment faults were evident with your CCTV system, on a visit conducted by PC Downes on the 19th of December 2018 she was informed that the CCTV only recorded for 28 days and not 31 as above. On the 13th of August 2018 PC Moran requested to view footage from the 12th of August 2018 and was told the CCTV system was not working due to a water leak which damaged the CCTV.

Another point of concern is your trading hours on Christmas day, according to your premises licence your hours are 12 noon to 3pm followed by 3pm to 2230pm. The officers who reported the crime in the early hours of Boxing Day 26th December 2019 at 01.49am asked your staff what time you were trading too. The officers were informed that the venue was having a private party/lock in. It is noted that you had no arrangement such as a temporary event notice in place for this event.

I must point out that any breaches of the premises Licence amount to an <u>offence</u> under s.136 Licensing Act 2003, which carries an unlimited fine and/or up to 6 months imprisonment.

This letter is a final written warning. The Metropolitan Police as a Responsible Authority under the Licensing Act 2003 reserves the right to initiate a Review of your Premises License and take enforcement action with reference to the commission of offences under the 'Act'





I am writing this letter to you in connection with an incident of violence that occurred on the morning of the 20th February 2022, originating from your venue;

SEAN OG, 108 High Street, Wealdstone, Harrow, Middlesex, HA3 7AH.

I have previously visited your venue alongside Harrow Councils Licensing Team and made you aware of some incidents and complaints regarding disorder and anti-social behaviour from your patrons. These incidents have occurred at the venue above where you are the current Premises Licence Holder (PLH) one such incident required your establishment to provide CCTV to Police as per Annex 2 of your licence.

The incident on the 20th February 2022 has caused GBH level injuries to the victim and as such your CCTV has been downloaded and reviewed. Analysis of this CCTV has shown you operating and selling alcohol for an hour after you are licensed to do so whilst also allowing patrons to leave the premises with glasses in hand.

I must point out that any breaches of the Premises Licence amount to an <u>offence</u> under s.136 Licensing Act 2003, which carries an unlimited fine and/or up to 6 months imprisonment.

This letter is a final written warning. The Metropolitan Police as a Responsible Authority under the Licensing Act 2003 reserves the right to initiate a Review of your Premises License and take enforcement action with reference to the commission of offences under the 'Act'; Action which we will undertake should any further incidents occurr.

Sean O'g crime report 2003###/23 11th March 2023 summary of report.

At 0218hrs on 11th March 2023 Police and LAS were called to Sean Og public House, 108 High Street, Harrow to reports of a fight between several people with reported injuries. Upon arrival police located 3 Albanian males inside the pub with varying degrees of injuries.

One of the males had a very serious cut to his neck believed to be arterial bleed and cuts to his head, arm and hands. A second male has cuts to his body and neck but not as serious as the first. A third male has cuts to his hands and body. These males were assessed at the scene by LAS.

2 more males were located nearby on Canning Road and both from the travelling community. They had cuts and blood on them. Enquires with CCTV identified these males to be related to the fight and both arrested for GBH. In total 5 persons were taken to hospital as follows: 2 x males to St Mary's hospital, 2 x NPH, and 1 x Ealing Hospital. Crime scenes are currently in place covering the following locations: From 'Sean Og 'public House / 'Mere' Food Centre JCT Grant Road and along the road to Town Centre, High Road/Green Leaf Way however as of 0537hrs scaled back to cover just the public house.

CID - SOCO scene guidance

Suspect party (Irish males) were sitting at the bar. One of them was drinking from a Strongbow can and one out of a glass, both of which remain on the bar by a mobile phone which belongs to one of the suspects. Victim party (Romanian males) were sitting further along the bar towards the back of the pub, opposite the Stella tap.

Items to consider seizing / swabbing:

(Outside) Broken pool cue - this has been moved from the road by the pavement curb to just inside the scene to preserve.

(Inside) Multiple broken pool cues - on pool table, on floor by sofa, on floor by pool table, leaning against the wall by the toilets. Broken chair legs. Broken glasses - on floor by pool table, on floor by bloodied clothing, on floor by pale coloured coat. Mobile phone on bar. Chanel scarf under table by pool table. Glass with liquid in next to mobile phone on bar. Strongbow can near mobile phone.

CCTV UPDATE

Two SIM cards have been removed from two of the newer cameras from inside the Sean Og pub. These were able to be removed from the scene with the landlady's consent. These cameras face the pool table and the bar. I have reviewed some of this footage and identify the clip which captures the beginning to the end of the incident. This has been added under the BWV section and the SIM cards handed to ET. The other cameras in the pub are older and therefore require downloading with a USB.

Joanne O'Sullivan stated that two Irish guys were with two women in the bar. Next to them were a few Romania guys. One of the Irish guys made a joke to the Romanian guys about his keys being dropped on the floor. The Romanian looked down and then everything kicked off.

O'Sullivan thinks that words were said between parties in the bathroom earlier in the night. Both groups had been drinking for a considerable time. O'Sullivan repeatedly told the Romanian guys to sit down. A blond Romanian guy put the bar flap down and told O'Sullivan to stay there.

Things were being thrown across the room, everyone was throwing punches and it was chaos. The two Irish women were screaming and begging their partners to leave. The Irish men left from the front and then O'Sullivan instructed the Romanians to leave out the back so that they wouldn't cross paths. O'Sullivan stated that she put different items of clothing on his's neck putting pressure on the injury to stem the bleeding and called 999.

Whilst all parties were known to O'Sullivan and were regulars in her pub, they did not know each other.

16/3/2023 13.06 hours

Visit with PC Darren Cowley and SGT James Clarke.

Met with Johanna O'Sullivan at the premises. Mr Paul McNee was not present as he had childcare commitments.

Darren advised about the hours for licensable activities and hours open to public on the premises licence and that the premises have been exceeding these hours. This is a breach of condition despite warning letters being issued previously. She walked over to the premises licence summary which was displayed next to the bar and came back and said that she did not realise what the times were, and she has made a mistake.

Breach of Section 136

Johanna could not provide the part A of the premises licence upon request.

Breach of Section 135

The police officers spoke to Johanna about the serious incident regarding a GBH/attempted murder between the late hours of 10/3/2023 and 11/3/2023 where a fight had broken out at the venue and there was a stabbing as a result.

Johanna was the only member of staff at the venue at the time of the incident taking place. When the ambulance staff - paramedics arrived, due to the gravity of the situation, the paramedics called the police. Johanna told the police that they cannot afford more staff.

After confirming that the time on the CCTV system was accurate, the police informed Johanna that the sale of alcohol terminates at 01:00 hours and hours open to public terminate at 01:30 hours from Friday into Saturday. PC Cowley advised that the CCTV shows that there were customers still on the premises between 01:45 and 02:00 on Saturday 11/3/2023 and this was when the fight took place. Johanna says that the customers were trying to help stop the fight. Then she went on to say the trouble started from a joke and then tension built up and things got out of hand. She also confirmed that she was the only member of staff on the premises at the time.

PC Cowley suggested that the premises should start to take last orders at 23:00 hours and close at 23:30 hours to prevent further incidents. Sgt Clarke would prefer the premises to close at 23:00 hours.

I informed Johanna that the rooftop garden was being advertised outside and this should not be used by the premises as it does not appear on the plans attached to the premises licence - this is a breach of regulations about plans.

14 Enforcement protocol

14.1 Licence reviews

To maintain a degree of consistency and transparency in decision-making, the Licensing Panel will be referred to the guidelines in appendix 1 when considering a review of a premises licence or club premises certificate. Each application for a review will be considered on its own merits and the Panel may depart from the guidelines should they have good reason to do so. The licensing authority reserves the right to amend and republish these guidelines in the light of operational experience.

14.2 Other enforcement powers

The licensing authority will work with other enforcement agencies and take a proportionate, risk-led approach to proactive and reactive enforcement.

- 14.3 Whilst the licensing authority will investigate complaints about unlicensed activities or licensed premises, it will also encourage self-resolution, mediation or referral to other agencies if that is more appropriate.
- 14.4 Complaints against licensed premises will be investigated promptly, having regard to feasibility. It must be noted that the licensing officers have limited statutory powers and that complete satisfaction to all parties may not be achieved. Regard will be given to all the events and wishes, and a resolution will be sought that is proportionate in the circumstances. The requirements of one individual cannot take precedence over others. Any decision taken on enforcement will be guided by our corporate enforcement policy and will not be driven by the wishes of any individual or group.
- 14.5 In most cases, advice or a written warning will be given for first and minor breaches. The table below is *indicative* of our approach to ensuring compliance and enforcing the Act in relation to first or single contraventions:

11. Reviews

The review process

- 11.1 The proceedings set out in the 2003 Act for reviewing premises licences and club premises certificates represent a key protection for the community where problems associated with the licensing objectives occur after the grant or variation of a premises licence or club premises certificate.
- 11.2 At any stage, following the grant of a premises licence or club premises certificate, a responsible authority, or any other person, may ask the licensing authority to review the licence or certificate because of a matter arising at the premises in connection with any of the four licensing objectives.
- 11.3 An application for review may be made electronically, provided that the licensing authority agrees and the applicant submits a subsequent hard copy of the application, if the licensing authority requires one. The licensing authority may also agree in advance that the application need not be given in hard copy. However, these applications are outside the formal electronic application process and may not be submitted via GOV.UK or the licensing authority's electronic facility. The applicant must give notice of the review application to the responsible authorities and holder of the licence or certificate. The licensing authority is required to advertise a review application.
- 11.4 In addition, the licensing authority must review a licence if the premises to which it relates was made the subject of a closure order by the police based on nuisance or disorder and the magistrates' court has sent the authority the relevant notice of its determination, or if the police have made an application for summary review on the basis that premises are associated with serious crime and/or disorder.
- 11.5 Any responsible authority under the 2003 Act may apply for a review of a premises licence or club premises certificate. Therefore, the relevant licensing authority may apply for a review if it is concerned about licensed activities at premises and wants to intervene early without waiting for representations from other persons. However, it is not expected that licensing authorities should normally act as responsible authorities in applying for reviews on behalf of other persons, such as local residents or community groups. These individuals or groups are entitled to apply for a review for a licence or certificate in their own right if they have grounds to do so. It is also reasonable for licensing authorities to expect other responsible authority. For example, the police should take appropriate steps where the basis for the review is concern about crime and disorder or the sexual exploitation of children. Likewise, where there are concerns about noise nuisance, it is reasonable to expect the local authority exercising environmental health functions for the area in which the premises are situated to make the application for review.
- 11.6 Where the relevant licensing authority does act as a responsible authority and applies for a review, it is important that a separation of responsibilities is still achieved in this process to ensure procedural fairness and eliminate conflicts of interest. As outlined previously in Chapter 9 of this Guidance, the distinct functions of acting as licensing authority and responsible authority should be exercised by different officials to ensure a separation of responsibilities. Further information on how licensing authorities should

achieve this separation of responsibilities can be found in Chapter 9, paragraphs 9.13 to 9.19 of this Guidance.

- 11.7 In every case, any application for a review must relate to particular premises in respect of which there is a premises licence or club premises certificate and must be relevant to the promotion of one or more of the licensing objectives. Following the grant or variation of a licence or certificate, a complaint regarding a general issue in the local area relating to the licensing objectives, such as a general (crime and disorder) situation in a town centre, should generally not be regarded as relevant unless it can be positively tied or linked by a causal connection to particular premises, which would allow for a proper review of the licence or certificate. For instance, a geographic cluster of complaints, including along transport routes related to an individual public house and its closing time, could give grounds for a review of an existing licence as well as direct incidents of crime and disorder around a particular public house.
- 11.8 Where a licensing authority receives a geographic cluster of complaints, consideration may be given as whether these issues are the result of the cumulative impact of licensed premises within the area concerned. In such circumstances, the licensing authority may be asked to consider whether it would be appropriate to publish a cumulative impact assessment. Further guidance on cumulative impact assessments can be found in Chapter 14 of this Guidance.
- 11.9 Responsible authorities and other persons may make representations in respect of an application to review a premises licence or club premises certificate. They must be relevant (i.e., relate to one or more of the licensing objectives) and, in the case of other persons, must not be frivolous or vexatious. Representations must be made in writing and may be amplified at the subsequent hearing or may stand in their own right. Additional representations which do not amount to an amplification of the original representation may not be made at the hearing. Representations may be made electronically, provided the licensing authority agrees and the applicant submits a subsequent hard copy, unless the licensing authority waives this requirement.
- 11.10 Where authorised persons and responsible authorities have concerns about problems identified at premises, it is good practice for them to give licence holders early warning of their concerns and the need for improvement, and where possible they should advise the licence or certificate holder of the steps they need to take to address those concerns. A failure by the holder to respond to such warnings is expected to lead to a decision to apply for a review. Co-operation at a local level in promoting the licensing objectives should be encouraged and reviews should not be used to undermine this co-operation.
- 11.11 If the application for a review has been made by a person other than a responsible authority (for example, a local resident, residents' association, local business or trade association), before taking action the licensing authority must first consider whether the complaint being made is relevant, frivolous, vexatious or repetitious. Further guidance on determining whether a representation is frivolous or vexatious can be found in Chapter 9 of this Guidance (paragraphs 9.4 to 9.10).

Repetitious grounds of review

11.12 A repetitious ground is one that is identical or substantially similar to:

- a ground for review specified in an earlier application for review made in relation to the same premises licence or certificate which has already been determined; or
- representations considered by the licensing authority when the premises licence or certificate was granted; or
- representations which would have been made when the application for the premises licence was first made and which were excluded then by reason of the prior issue of a provisional statement; and, in addition to the above grounds, a reasonable interval has not elapsed since that earlier review or grant.
- 11.13 Licensing authorities are expected to be aware of the need to prevent attempts to review licences merely as a further means of challenging the grant of the licence following the failure of representations to persuade the licensing authority on an earlier occasion. It is for licensing authorities themselves to judge what should be regarded as a reasonable interval in these circumstances. However, it is recommended that more than one review originating from a person other than a responsible authority in relation to a particular premises should not be permitted within a 12 month period on similar grounds save in compelling circumstances or where it arises following a closure order or illegal working compliance order.
- 11.14 The exclusion of a complaint on the grounds that it is repetitious does not apply to responsible authorities which may make more than one application for a review of a licence or certificate within a 12 month period.
- 11.15 When a licensing authority receives an application for a review from a responsible authority or any other person, or in accordance with the closure procedures described in Part 8 of the 2003 Act (for example, closure orders), it must arrange a hearing. The arrangements for the hearing must follow the provisions set out in regulations. These regulations are published on the Government's legislation website (www.legislation.gov.uk). It is particularly important that the premises licence holder is made fully aware of any representations made in respect of the premises, any evidence supporting the representations and that the holder or the holder's legal representative has therefore been able to prepare a response.

Powers of a licensing authority on the determination of a review

- 11.16 The 2003 Act provides a range of powers for the licensing authority which it may exercise on determining a review where it considers them appropriate for the promotion of the licensing objectives.
- 11.17 The licensing authority may decide that the review does not require it to take any further steps appropriate to promoting the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular period of time. It is expected that licensing authorities will regard such informal warnings as an important mechanism for ensuring that the licensing objectives are effectively promoted and that warnings should be issued in writing to the licence holder.
- 11.18 However, where responsible authorities such as the police or environmental health officers have already issued warnings requiring improvement either orally or in writing that have failed as part of their own stepped approach to address concerns, licensing authorities should not merely repeat that approach and should take this into account

when considering what further action is appropriate. Similarly, licensing authorities may take into account any civil immigration penalties which a licence holder has been required to pay for employing an illegal worker.

- 11.19 Where the licensing authority considers that action under its statutory powers is appropriate, it may take any of the following steps:
 - modify the conditions of the premises licence (which includes adding new conditions or any alteration or omission of an existing condition), for example, by reducing the hours of opening or by requiring door supervisors at particular times;
 - exclude a licensable activity from the scope of the licence, for example, to exclude the performance of live music or playing of recorded music (where it is not within the incidental live and recorded music exemption)¹⁰;
 - remove the designated premises supervisor, for example, because they consider that the problems are the result of poor management;
 - suspend the licence for a period not exceeding three months;
 - revoke the licence.
- 11.20 In deciding which of these powers to invoke, it is expected that licensing authorities should so far as possible seek to establish the cause or causes of the concerns that the representations identify. The remedial action taken should generally be directed at these causes and should always be no more than an appropriate and proportionate response to address the causes of concern that instigated the review.
- 11.21 For example, licensing authorities should be alive to the possibility that the removal and replacement of the designated premises supervisor may be sufficient to remedy a problem where the cause of the identified problem directly relates to poor management decisions made by that individual.
- 11.22 Equally, it may emerge that poor management is a direct reflection of poor company practice or policy and the mere removal of the designated premises supervisor may be an inadequate response to the problems presented. Indeed, where subsequent review hearings are generated, it should be rare merely to remove a succession of designated premises supervisors as this would be a clear indication of deeper problems that impact upon the licensing objectives.
- 11.23 Licensing authorities should also note that modifications of conditions and exclusions of licensable activities may be imposed either permanently or for a temporary period of up to three months. Temporary changes or suspension of the licence for up to three months could impact on the business holding the licence financially and would only be expected to be pursued as an appropriate means of promoting the licensing objectives or preventing illegal working. So, for instance, a licence could be suspended for a weekend as a means of deterring the holder from allowing the problems that gave rise to the review to happen again. However, it will always be important that any detrimental financial impact that may result from a licensing authority's decision is appropriate and proportionate to the promotion of the licensing objectives and for the prevention of illegal working in licensed premises. But where premises are found to be trading irresponsibly, the licensing authority should not hesitate, where appropriate to do so, to take tough

action to tackle the problems at the premises and, where other measures are deemed insufficient, to revoke the licence.

Reviews arising in connection with crime

- 11.24 A number of reviews may arise in connection with crime that is not directly connected with licensable activities. For example, reviews may arise because of drugs problems at the premises, money laundering by criminal gangs, the sale of contraband or stolen goods, the sale of firearms, or the sexual exploitation of children. Licensing authorities do not have the power to judge the criminality or otherwise of any issue. This is a matter for the courts. The licensing authority's role when determining such a review is not therefore to establish the guilt or innocence of any individual but to ensure the promotion of the crime prevention objective.
- 11.25 Reviews are part of the regulatory process introduced by the 2003 Act and they are not part of criminal law and procedure. There is, therefore, no reason why representations giving rise to a review of a premises licence need be delayed pending the outcome of any criminal proceedings. Some reviews will arise after the conviction in the criminal courts of certain individuals, but not all. In any case, it is for the licensing authority to determine whether the problems associated with the alleged crimes are taking place on the premises and affecting the promotion of the licensing objectives. Where a review follows a conviction, it would also not be for the licensing authority to attempt to go beyond any finding by the courts, which should be treated as a matter of undisputed evidence before them.
- 11.26 Where the licensing authority is conducting a review on the grounds that the premises have been used for criminal purposes, its role is solely to determine what steps should be taken in connection with the premises licence, for the promotion of the crime prevention objective. It is important to recognise that certain criminal activity or associated problems may be taking place or have taken place despite the best efforts of the licence holder and the staff working at the premises and despite full compliance with the conditions attached to the licence. In such circumstances, the licensing authority is still empowered to take any appropriate steps to remedy the problems. The licensing authority's duty is to take steps with a view to the promotion of the licensing objectives and the prevention of illegal working in the interests of the wider community and not those of the individual licence holder.
- 11.27 There is certain criminal activity that may arise in connection with licensed premises which should be treated particularly seriously. These are the use of the licensed premises:
 - for the sale and distribution of drugs controlled under the Misuse of Drugs Act 1971 and the laundering of the proceeds of drugs crime;
 - for the sale and distribution of illegal firearms;
 - for the evasion of copyright in respect of pirated or unlicensed films and music, which does considerable damage to the industries affected;
 - for the illegal purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and propensity for crime of young people;
 - for prostitution or the sale of unlawful pornography;
 - by organised groups of paedophiles to groom children;
 - as the base for the organisation of criminal activity, particularly by gangs;

- for the organisation of racist activity or the promotion of racist attacks;
- for employing a person who is disqualified from that work by reason of their immigration status in the UK;
- for unlawful gambling; and
- for the sale or storage of smuggled tobacco and alcohol.
- 11.28 It is envisaged that licensing authorities, the police, the Home Office (Immigration Enforcement) and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence even in the first instance should be seriously considered.


Review of a premises licence following closure order or illegal working compliance order

- 11.29 Licensing authorities are subject to certain timescales, set out in the legislation, for the review of a premises licence following a closure order under section 80 of the Anti-social Behaviour, Crime and Policing Act 2014 or an illegal working compliance order under section 38 of and Schedule 6 to the Immigration Act 2016. The relevant time periods run concurrently and are as follows:
 - when the licensing authority receives notice that a magistrates' court has made a closure order it has 28 days to determine the licence review – the determination must be made before the expiry of the 28th day after the day on which the notice is received;
 - the hearing must be held within ten working days, the first of which is the day after the day the notice from the magistrates' court is received;
 - notice of the hearing must be given no later than five working days before the first hearing day (there must be five clear working days between the giving of the notice and the start of the hearing).

Review of a premises licence following persistent sales of alcohol to children

11.29 The Government recognises that the majority of licensed premises operate responsibly and undertake due diligence checks on those who appear to be under the age of 18 at the point of sale (or 21 and 25 where they operate a Challenge 21 or 25 scheme). Where these systems are in place, licensing authorities may wish to take a proportionate approach in cases where there have been two sales of alcohol within very quick succession of one another (e.g., where a new cashier has not followed policy and conformed with a store's age verification procedures). However, where persistent sales of alcohol to children have occurred at premises, and it is apparent that those managing the premises do not operate a responsible policy or have not exercised appropriate due diligence, responsible authorities should consider taking steps to ensure that a review of the licence is the norm in these circumstances. This is particularly the case where there has been a prosecution for the offence under section 147A or a closure notice has been given under section 169A of the 2003 Act. In determining the review, the licensing authority should consider revoking the licence if it considers this appropriate.
