A decision is significant if it involves expenditure or the making of savings of an amount in excess of £1m of capital or £500,000 of revenue or where savings or expenditure are less than these amounts but they constitute more than 50% of the budget attributable to the service in guestion; or
- (ii) be significant in terms of its effects on communities living or working in an area of two or more wards of the Borough.

A private meeting of the Cabinet is open only to Members of the Cabinet, other Councillors and Council officers.
