Healthwatch Harrow champions the voice of patients and ensures that their views and experiences of Health and Social Care are captured and fed back through the Trend Analysis Reports to commissioners in order to bring about change.

Our reports are produced on a quarterly basis and shared with the Health and Wellbeing board along with other key stakeholders. The key concerns consistently raised relate to GP access. The purpose of this report is to track progress from Q4 to Q1. It demonstrates that there has been progress in some areas but access is still a key issue.

NHS North West London primary care strategy is aligned to the ambitions outlined within the Fuller review:

- Accessible same day care including urgent care
- Improving Population Health and Wellbeing
- Enhancing Long Term Condition Management and preventative care

Whilst we continue to see an increase in the number of Face-to-Face appointments, we are working to ensure adequate provision of access to meet the needs of the population, ensuring the right balance of face to face and digital appointments are offered.

This report provides a comprehensive overview of Healthwatch analysis of patient experience of services and NHS North West London programme of work which will collectively help improve patient access and experience.
