JOINT COMMISSIONING STRATEGY FOR PEOPLE WITH LEARNING DISABILITIES AND AUTISTIC PEOPLE: 2022 to 2026

For Harrow to be a place where people with learning disabilities and autistic people of all ages live as equal citizens in a community that treats them with dignity and respect, and provides access to high quality services, that supports people to realise their ambitions.

- The Harrow Joint Learning Disabilities and Autism (LDA) Strategy 2016-2020 led to significant achievements
- With the Integrated Care Partnership (ICP) there is a renewed cooperation between Harrow Council and NHS North West London to work with people with learning disabilities (LD) and autistic people (ASD) to improve outcomes for citizens with LD or ASD.
- In 2021 wide engagement facilitated the development of the Joint All Age Learning Disabilities and Autism Strategy 2022-2026.
 - Questionnaires - 44 professionals and 122 citizens
 - Four online sessions - 115 participants
 - Workshop to support with the prioritising of the activities 90 participants
- The Strategy aims to ensure citizens recognise and or are supported to identify the positive outcomes they want to achieve to enable them to be as independent and included in the community as they want to be.

“ There needs to be greater training & awareness”

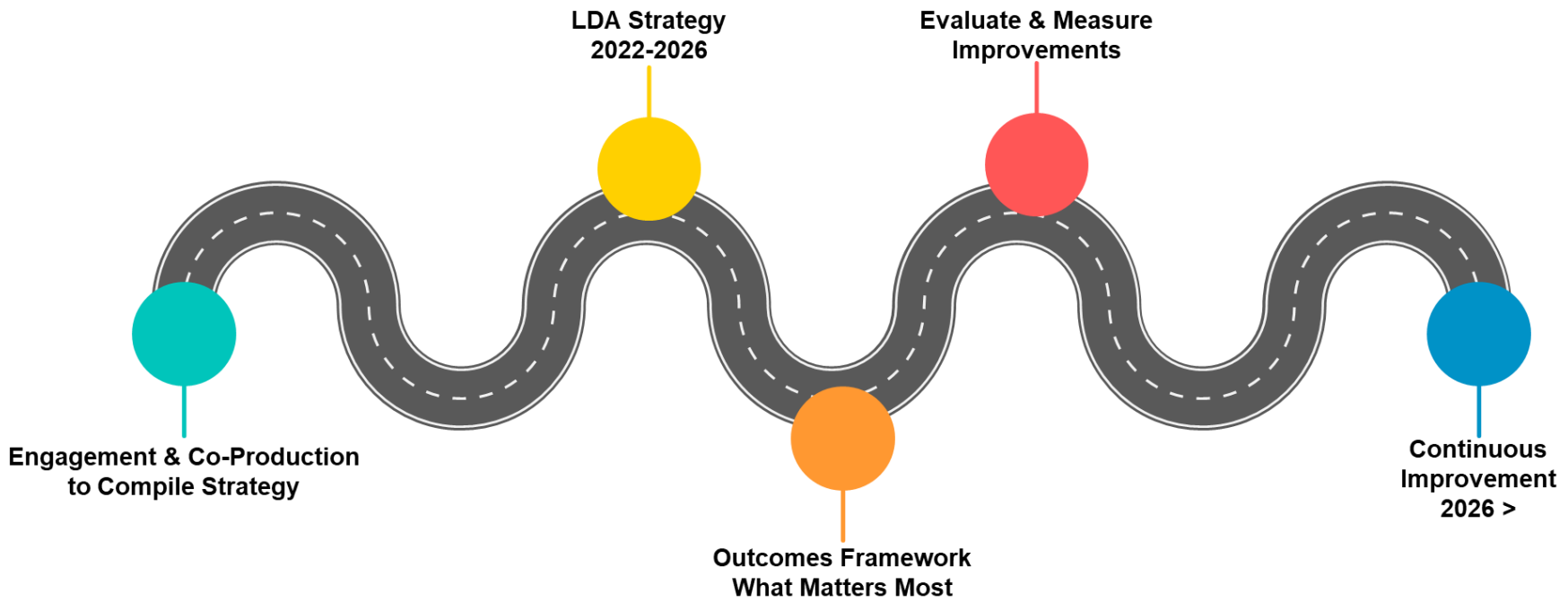
“There needs to be more for people who don’t meet SEND criteria”
