- Asked of: Councillor Manji Kara, Portfolio Holder for Community and Culture
- **Question:** "Do you believe that the use of the word "Purdah" in the run-up to the local elections is appropriate, bearing in mind the actual meaning of the word and the fact that both the current Leader of the Council and the current Mayor are female?"

- Question: "Please would you inform me of the cost, or of the estimated cost, to Harrow Council of the Public Inquiry into the refusal of planning permission for The Hive football club lights and stadium?"

take the necessary steps to place the victims of such circumstances into temporary accommodation at the very least?"
