"This document was put out to Public consultation on 30th March 2015: the closing date originally was 1st May, subsequently extended to 31st May.

We are told that this is a 'Draft' but that once the Consultation period has closed public representations on it will go to the LDF Committee and then direct to Cabinet - i.e. the substantive document will not be put out to (further) Consultation as has been the case ordinarily with Conservation Area documents in the past. This means that Officer's comments on the representations made by the public is what the Committee will consider and consultees will have no further opportunity to comment on those analyses presented to the Committee or on any suggested revisions.

We are also told that - once it is adopted the Document will carry material weight in dealing with Planning Applications for the area.
