Question 7:

"The last time Harrow Council froze council tax, was in 2014 when it was led by Cllr. Susan Hall and the Conservatives. After Labour's 3 successive council tax rises, adding over 11% to our residents' bills, will you rule out further council tax rises in 2018?"

Answer:

In answering this question, it's important to understand how the primary source of funding for Local Government, the Revenue Support Grant, has been significantly reduced since 2014 and how it will continue to reduce until 2019/12, alongside unprecedented growth in demand pressures, which has inevitably meant increasing Council Tax to protect front line services.

Question 8:

Do you believe that your department's budget was actually sound and realistic when you proposed it to Council in February and are you confident that you will contain your department's spending within the budgeted figure by the end of the current financial year?

Answer

In 2017/18 £2.9m of growth was included in the budget to support increased demand in children's services. Of this, £1m was for SEN Transport which is anticipated to be within budget this financial year. The remaining £1.9m was for social care staffing and children's placements & accommodation. However, since the budget was set in February, there has been a further increase in demand, in particular, for more costly children's placements and accommodation. There are a number of actions taking place to mitigate the pressures as far as possible and it is forecast that the Council wide budget will report a balanced position by the end of the year, whilst accepting that there will be pressures and opportunities across the directorates.
