THIS NOTE REFLECTS A CONSENSUS BETWEEN THE POLITICAL GROUPS ON THE PROCEDURES THAT WILL APPLY FOR THE DETERMINATION OF THE COUNCIL'S **BUDGET, COUNCIL TAX, CORPORATE PLAN, TREASURY MANAGEMENT STRATEGY** STATEMENT, CAPITAL PROGRAMME AND HOUSING REVENUE ACCOUNT BUDGET AND MEDIUM TERM FINANCIAL STRATEGY.

The Leader will move the Cabinet Recommendations and the Mayor **OPENING**

will then request any amendments.

AMENDMENTS Any amendments must be moved and seconded.

JOINT DEBATE It is desirable that the Council should hold one comprehensive debate

on its budget and Items 7 - 11, so all amendments will be considered to

have been moved together.

Should significant amendments be received the Mayor may propose an **ADJOURNMENT**

adjournment of up to thirty minutes to allow Members to read and

assimilate them.

EXTENDED SPEECHES Up to three identified Members of each Group will be allowed a total of

20 minutes to talk to the recommendation and respond to any

amendments. The order will be as follows:

(1) Labour (20 minutes)

Conservative (20 minutes) (2)

DEBATING RULES All other speakers will be restricted to the usual **3 minutes**. To conclude the debate the Groups will be allocated 1 winding-up speech of 5 minutes, in the following order:

- (1) Conservative
- (2) Labour

VOTING ON AMENDMENTS

Following the final winding-up speech, the Council will immediately move to voting on the amendments. <u>NO</u> further debate will take place between the voting on the amendments.

The amendments will be voted on in the following order:

- (1) Independent
- (2) Conservative
- (3) Labour

One separate vote will be taken on each amendment. If any amendment is carried it becomes the substantive proposal.

Following votes on each amendment the Council Meeting will have either:

- if an amendment has been carried, a new substantive Budget / Council Tax proposal / Corporate Plan proposal/ Treasury Management Strategy Statement proposal/ Final Capital Programme proposal/ Housing Revenue Account Budget and Medium Term Financial Strategy proposal; or
- if no amendment has been carried the original Recommendations.

DETERMINATION OF ITEMS 7 – 11

A new substantive Budget/Council Tax proposal (if an amendment has been carried) or the Cabinet Recommendation **if not amended** will be put to a formal vote of the Council to be adopted, without further debate. A record of all Members when voting on the Budget will be taken.

SUSPENSION OF COUNCIL RULES

The procedures set out above vary the rules regarding the moving of a recommendation from the Executive and the rules of debate. Council will be assumed to have endorsed under Rule 26.1 the partial suspension of the relevant rules for the limited purposes of items 7 – 11 on the Summons, taken as a single item.

Procedural motion to move *Motion 5 "Constitutional Amendment to Part 4D Executive Procedure Rules"* up the agenda to precede the budget debate and follow Item 6 Leader and Portfolio Holders' Announcements.

We propose a procedural motion to move Item *Motion 5 "Constitutional Amendment to Part 4D Executive Procedure Rules"* up the agenda to precede the budget debate and follow Item 6 *Leader and Portfolio Holders' Announcements.* This is to avoid the likelihood of the motion, as the last item, not being debated due to a guillotine. This motion highlights a fundamentally important issue for Harrow Council and the Young People of Harrow. We therefore need to ensure this is debated; especially as members of the Harrow Youth Parliament are present tonight.

RAF Northolt Motion

To be moved by Councillor Graham Henson and seconded by Councillor Primesh Patel:

"This Council notes:

- That RAF Northolt is the 4th largest airport in London.
- That it is becoming increasingly obvious to Harrow residents who live under the flight path of RAF Northolt that the number of flights to and from the airport has significantly increased;
- The findings of the "Project Ark" report, commissioned by the Ministry of Defence in 2012 to explore 'a range of options for the future development of RAF Northolt,' and 'conversion into a civilian operated airport';
- There is a planned £45 million renovation of the airport and no residents in Harrow have been consulted on the proposed improvements or changes;
- Figures released by Parliament show that in 2017
 - Only 18% of flights through RAF Northolt are military
 - Over 70% of flights were commercial
- That there are serious environmental impacts on the residents who live under the flight path of RAF Northolt
- That any increase in flights will have a further detrimental effect on the well-being of Harrow residents who live under the widening flight path.
- Additionally to RAF Northolt, any increase in flights from Heathrow will have a further detrimental effect on the well-being of Harrow residents who live under the widening flight path.

This Council believes:

No further increase in the number of commercial flights to and from RAF Northolt and Heathrow should take place without a thorough and transparent consultation, involving all the residents who live in the proximity of the airport and those who live under the flight path;

This Council resolves:

 To instruct the Chief Executive and the Leader of the Council to write to the Secretary of State for Defence, the Rt Hon Gavin Williamson MP, requesting:

- That the Ministry of Defence conduct a full consultation with Harrow residents about its plans to spend £45 million on renovating RAF Northolt and any future plans for the use of the airport.
- That the Ministry of Defence accepts the reduction to 5,000 movements for commercial aircrafts at RAF Northolt in order to improve the environment and reduce noise pollution;
- To instruct the Chief Executive and the Leader of the Council to write to the Secretary of State for Transport, the Rt Hon Chris Grayling MP, requesting:
 - That the department of Transport conduct a full consultation with Harrow residents about its plans for Heathrow and any future plans for the use of the airport.
- To instruct the Interim Chief Executive and the Leader of the Council to write to the Mayor of London, Sadiq Khan, requesting that he makes representations to the Ministry of Defence and the Department of Transport about the real concerns of Harrow residents who live under the flight path of RAF Northolt and Heathrow.
- To instruct the Interim Chief Executive and the Leader of the Council to take a lead on any consultations on RAF Northolt and Heathrow equally, as both issues should be treated equally with residents' views coming first.
- To further instruct the Interim Chief Executive and Leader of the Council to not publish the Council's position on these matters or publicly endorse any proposals until a full consultation has been carried out and residents' views have been heard.

Northwick Park: Save Our Services Motion

To be moved by Councillor Jeff Anderson and seconded by Councillor Sue Anderson

"This Council believes:

- Our local NHS in Harrow is under threat from an unfair funding settlement and a deficit that could see staff lose their jobs or services cut.
- Harrow Clinical Commissioning Group inherited a deficit of £18m from its predecessor Primary Care Trust when the Coalition Government's reforms were introduced in 2013. Since then, Harrow's NHS has received the lowest funding per head in London, and the deficit now stands at £20.1m.
- Northwick Park Hospital's funding problems run across various Governments as in 2009, North West London Hospitals NHS Trust, which runs Northwick Park Hospital faced a cash shortfall of £17 million. This was following the maternity unit being put in special measures in 2005 after it was revealed that the death rate for new mothers was far higher than the national average.
- In January (the latest figures available), 1 in 4 patients at A&E had to wait more than 4 hours. The upcoming closure of the Charlie Chaplin children's ward at Ealing Hospital means that from 30th June, children will not be admitted to A&E at Ealing, and will be diverted to other hospitals including Northwick Park.

This Council supports:

 Northwick Park Hospital is a life saving service for Harrow residents and we believe that it should be appropriately funded <u>across different Governments</u> to deal with an ageing and growing population;

This Council resolves:

 To instruct the Interim Chief Executive and the Leader of the Council to demand that the Rt Hon Jeremy Hunt, Secretary of State for Health and Social Care, ensures appropriate funding is provided to Northwick Park Hospital and the NHS."
