<b>1/02</b>	<p>An objection letter was received from Councillor Krupesh Hirani AM on the following grounds:</p> <ul style="list-style-type: none"> <li>• 3-7 storey buildings would be imposing on residents, neighbouring park and allotments; and not in keeping with the surrounding context.</li> <li>• Lack of social and affordable housing; and</li> <li>• Design of the flats are no fit for purpose (a one-bedroom flat will not accommodate family need);</li> <li>• Environmental impact of the development on mature trees and effect of the development on biodiversity and wildlife area.</li> </ul> <p>Officer comment: The above matters raised have been addressed within Sections 6.3, 6.5, 6.6 and 6.9 of the Officer’s Report to Planning Committee.</p> <p>It should however be noted that the LPA have recommended that planning permission is refused on the grounds of Affordable Housing, Ecology and Trees.</p> <p>With respect to the overall unit mix, scale, mass and height and its relationship with the surrounding context, public vantage points and neighbouring properties, the proposal is considered to be acceptable in respect of all these points.</p>
