**Question:** “It is clear from the Q1 Revenue & Capital Budget 2022-2023 Out-turn report that the cost of living crisis is hitting frontline statutory council services hard with rising demand and rapidly growing inflationary costs. What actions have been put into place to ensure the demand can be met in priority services within directorates, especially; Adult Social Care, Children’s Service and Residents facing hardship?”

**Question:** “Between February – May 2022, sewage samples in London Beckton Sewage Treatment Works suggest the discovery of a vaccine-derived Polio virus. Most people will be asymptomatic and some will have flu-like symptoms but for 1 in 100 to 1 in 1000 infections - the Polio virus attacks the nerves in the spine and base of the brain. This can cause paralysis, usually in the legs, that develops over hours or days. If the breathing muscles are affected, it can be life threatening. No specific therapy is

available against the virus, it can only be prevented by immunisation.

Is there any evidence of increased community-transmission of Polio in Harrow?"

**Question:** "Local schools have survived (ABC) Austerity, Brexit and COVID and now they have to cope with a growing funding crises. Harrow schools face unprecedented challenges; apocalyptic energy price hikes and cost pressures from unfunded but deserved public sector pay awards that were announced after budgets had been set. Schools have not seen an increase in core funding to meet these challenges and will have to decide about cuts to educational provision or having an unbalanced budgets.
