Question: "Pinner residents have raised with me their concerns regarding

speeding and poor sight lines at the Lyncroft Avenue / Cannon Lane junction. A combination of vehicles travelling at excessive speed on Lyncroft Avenue and poor sight lines for traffic exiting the junction southbound from Cannon Lane has left Pinner residents feeling unsafe. We've seen a spate of accidents and near-misses at the junction: most recently, on 14th May, a serious accident occurred when a car pulling out of the southbound junction and turning right onto Lyncroft Avenue

collided with a moped travelling east.

With that in mind, then, what steps will Harrow Council be taking

to improve sight lines at this dangerous junction and reduce

speeds on Lyncroft Avenue?"

"Residents around Greenford Road / Sudbury Hill have noticed a significant deterioration in their streets in recent months. They have reported an increase in littering, fly tipping and anti-social behaviour.

Sudbury Hill Residents are angry that their area seems to be an overlooked part of the borough in comparison to other high streets. They also note that the Ealing and Brent sides of Greenford Road are much better cared for and their Councils are more proactive in their responses to resident concerns.

Can the Portfolio Holder tell them how many Fixed Penalty Notices have been issued and paid - for littering, ASB and flytips in the Sudbury Hill community in the last 12 months.

Question: "Harrow's leafy green image can often mask some of the real

challenges facing residents.

Unemployment in Harrow has doubled since the

pandemic, 17.4% residents have no qualifications, much higher than the London average. Harrow is also a low-wage borough, with gross weekly earnings £514.20 - 37% less than the London

average of £815.90

The economic plan identifies that UK Shared Prosperity Fund has allocated 1.4m of funding to Harrow for local investment by

March 2025.

Can the Portfolio Holder identify specific projects that this money

will be spent on?
