Question: "The Portfolio Holder will be aware that the Council's

consultation on Discretionary Freedom Passes closed on 3 September. I am opposed to the proposals to cease issuing Freedom Passes for people with mental health issues and

phase out the existing passes. As a number of local

organisations and charities including Mind in Harrow have argued, freedom passes are an indispensable lifeline for some of the most vulnerable people in Harrow. They tackle loneliness,

support independence, and ensure fares aren't a barrier to passholders making crucial appointments. Pinner residents opposed to the proposals have raised with me their concerns that the feedback they have given via the consultation will be ignored, and that the Council will press ahead with the cuts regardless of the level of local opposition. To allay their concerns, then, I wonder what assessment Cllr Ashton has made of the potential merits of publishing the full criteria by

which a final decision will be made, so that Harrow residents can be assured their feedback will be given due weight?"
