1. <u>Attendance by Reserve Members:</u>

- (iv) if a Reserve Member whose intention to attend has been noted arrives after the commencement of the meeting, then that Reserve Member can only act as a Member from the start of the next item of business on the agenda after his/her arrival.

2. Right of Members to Speak:

To agree requests to speak from Councillors who are not Members of the Committee, in accordance with Committee Procedure 4.1.

- (b) all other Members present in any part of the room or chamber.
