17. MOTIONS:

The following Motions have been notified and will be moved and seconded by the Members indicated:-

(1) Retention of Cancer Services at Mount Vernon Hospital

To be moved by Councillor Chris Mote and seconded by Councillor Navin Shah:

"This Council supports the retention of cancer services at Mount Vernon Hospital and asks the Secretary of State for Health to listen, not only to the Council, but also to the many members of the public and the local MPs who have fought for many years to retain this valuable local service. We urge the Minister to finally resolve this matter by giving a pledge to keep the cancer services at Mount Vernon Hospital".

(2) Harrow Heritage Trust – A Proposal to set up a 'Harrow Heritage Buildings Commission'

To be moved by Councillor Navin Shah and seconded by Councillor Bill Stephenson:

"Council fully supports its priority of preserving Harrow's rich and varied heritage. Council is particularly concerned at the pressures being placed on our built heritage by intense development pressures throughout the Borough. With this in mind Council believes that in conjunction with local residents the Borough should take a much more pro-active stance in protecting and enhancing our heritage and buildings of value. To further this aim Council resolves to enter into discussions with Harrow Heritage Trust about the possibility of setting up a 'Harrow Heritage Buildings Commission' which would among other things:

- (i) actively identify buildings of local interest to be listed either locally or nationally (statutory listing),
- (ii) actively campaign both at London and national level for stronger powers to protect locally listed buildings,
- (iii) be consulted by the Council about any proposal to list or de-list any local buildings."

(3) Mayor of London and the Government initiative to provide support for young Londoners

To be moved by Councillor Bill Stephenson and seconded by Councillor Navin Shah:

"Council welcomes the joint initiative by the Mayor of London and the Government to provide a £60 million boost for young Londoners as announced in their 'London Youth Offer' on September 20. Council acknowledges that this two-year package aims among other things to encourage young people to get more involved in decisions about the provision of youth facilities and increase the range of services available to teenagers as well as providing additional resources for community Initiatives. We further note that this is a part of a whole range of measures from the Mayor of London and the Government to support young people in the London including, in particular, the Mayor's initiative to provide free travel on London buses for under eighteens."

(4) Capital Funding Initiative for Harrow Schools

To be moved by Councillor Bill Stephenson and seconded by Councillor Navin Shah:

"Council welcomes support by the Government for Harrow by providing significant capital funding for our schools year on year as well as investment for a number of major projects in Harrow such as Harrow Sixth Form Collegiate (£25 million), Harrow College (£80 million), Whitmore School (£30 million) etc. Council pays tribute to the unstinting efforts of its officers and its two local MPs in helping to obtain this very welcome funding."

(5) Safer Neighbourhood Teams in Harrow

To be moved by Councillor Graham Henson and seconded by Councillor Navin Shah:

"Council expresses its sincere appreciation to the Metropolitan Police Service and to the Mayor of London for their successful roll out of Safer Neighbourhood Teams in Harrow ahead of schedule.

The Safer Neighbourhoods Teams spend most of their time out on patrol in their local neighbourhoods meeting the local community and identifying and dealing with those crimes and issues which cause residents and stakeholders most concern.

This visionary scheme instituted by the Mayor of London has now become a proven and important asset in reducing the fear of crime in Harrow. It not only supports police on the beat but also helps to tackle the key day-to-day local problems of anti-social behaviour, graffiti, enviro-crimes as well as reassuring local communities by providing a visible presence on their streets."
