An application to transfer the premises licence issued under the Licensing Act 2003 in respect of "Funky Brownz' (formerly known as Spanish Arch PH), 28 Belmont Circle, Kenton Lane, Harrow, HA3 8RF, has attracted an objection notice from the Metropolitan Police, on the basis that granting it would undermine the crime prevention objective.

Section 2 – Report

Current situation

2.1 There is currently a premises licence in force at "Funky Brownz" (formerly known as Spanish Arch PH), 28 Belmont Circle, Kenton Lane, Harrow, HA3 8RF. Briefly the premises licence authorises the following licensable activities during the timings specified:

Sale of Alcohol and Regulated Entertainment:

- 2.2 On 3rd February 2011, an application was made to transfer the premises licence to Funky Brownz 2 Ltd (the applicant).
- 2.3 The Metropolitan Police have submitted an objection notice on the grounds that the exceptional circumstances of the case are such that the granting of the application would undermine the crime prevention objective. A copy of this notice is attached to this report.
- 2.4 The premises is situated at 28 Belmont Circle, Kenton Lane, adjacent to both commercial and residential properties. A map of the area is attached to this report.

Licensing Policy Implications

2.5 In relation to the Council's policy at paragraph 8.19, the applicants and the current premises licence holder have provided all relevant signatures and consents.

Legal Implications

2.6 The Licensing authority (in this case the London Borough of Harrow) is required to hold a hearing to consider the objection notice (and the transfer application) unless all parties agree that a hearing is unnecessary. The hearing must be held in accordance with the Licensing Act 2003 (Hearings) Regulations 2005.

- 2.7 The Licensing Panel is required to give appropriate weight to representations made by all parties, the Guidance issued pursuant to section 182 of the Licensing Act 2003, the Council's statement of licensing policy and the steps that are necessary to promote the crime prevention objective.
- 2.8 Having considered those relevant matters, the Licensing Panel can either:
 - a. Grant the application to transfer the premises licence;
 - b. Reject the application to transfer the premises licence if it considers it necessary for the promotion of the crime prevention objective.
- 2.9 It should be noted with all options that
 - Clear reasons should be given for the decision.
 - The applicant and the Metropolitan Police would have a right of appeal to a magistrates' court on one of the grounds provided in Schedule 5 to the Licensing Act 2003
- 2.10 In addition to determining the application in accordance with the legislation, Members must have regard to
 - The common law rules of natural justice
 - The provisions of the Human Rights Act 1998
 - The considerations in section 17 of the Crime and Disorder Act 1998
- 2.11 By section 6 of the Human Rights Act 1998, the Panel is required to act in a way that is compatible with rights under the European Convention for the Protection of Human Rights and Freedoms. The following provisions of the European convention seem relevant: Article 6 (right to a fair trial) Article 14 (prohibition of discrimination) and Article 1 of the First Protocol (protection of property).

Community Safety

2.12 In relation to section 17 of the Crime and Disorder Act 1998, this states:

'Without prejudice to any other obligation imposed on it, it shall be the duty of each authority to which this section applies to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.'

2.13 The Borough Commander, through Sergeant Davis, has submitted an objection notice against this application.

Financial Implications

2.14 There are no financial implications.

Risk Management Implications

2.15 If any party is aggrieved with the decision of the licensing panel on one of the grounds set out in Schedule 5 to the Licensing Act 2003, they can appeal to a Magistrates' Court. The Appeal period is 21 days from notification of the decision.

Police consider that there are exceptional circumstances regarding this application and consider that granting the application would seriously undermine the crime prevention objective.

The current Premises Licence for this premises (Spanish Arch Public House) enables opening until 0030 Monday to Tuesday, 0130 on a Thursday, 0200 on a Friday and Saturday and 0100 on a Sunday.

The premises operated as a Public House and has only one condition in Annex 2 & 3 , which is :

"The consumption of beverages in external areas of the premises shall cease after 2330".

Police have generally had no problems with the running of the premises under the old management regime.

The applicants who have submitted this Transfer application (FunkyBrownz) have apparently two other premises in North London.

One, in Haringey, is apparently shut.

The other , in Colindale, is situated at 63-65 The Hyde West Hendon London NW9 6LE

Under the same management and Licence Holders the premises has traded under the name Ash Bar/Waterfalls and Funky Brownz.

I have contacted the Police Licensing Sergeant for Barnet Borough- Sergeant Mark Altman - who has experience of dealing with this premises and he has informed me of the two Reviews of the Premises Licence and sent me supporting documents which I produce as exhibits.

The first document (CD/1) is an application for Review of the Licence by London Borough of Barnet Environmental Health Group Manager - Ralph Haynes, dated 10.09/2007

I note that the applicant explains the daily running and management structure and at the premises and refers to the owners son "Ash".

The second (CD/2) is a Representation in support of the above Review application which was completed by Sgt Altman on 3/10/2007.

Despite the seriousness of that situation in 2007, I now refer the panel to the next document (CD/3)- an application by Sgt Altman to London Borough of Barnet Licensing Authority under S.53A Licensing Act 2003 for an expedited Review of the Premises Licence (premises associated with serious crime & disorder), dated 23/03/2009.

I produce the Certificate under S.53A(1)(b) as CD/4

The information provided in support of a S.160 Closure document is CD/5 and the information document in support of the S.53A(1)(b) - which gives details of the Judge's Closure Order - is CD/6.

I produce the Licence (as at November 2009 - post Review hearings) as CD/7 and it can be seen in Annex 3 of the Premises Licence that it has taken the addition of 23 conditions , on top of the 18 conditions proffered in the Operating Schedule, to allow the management to hold onto its Licence and avoid having it revoked.

It can also be seen that the hours of premises opening and licensable activities are very similar to that of the Spanish Arch(this current Premises Licence).

I produce three(3) Companies House reports relating to Ash Bar Ltd (CD/8) , FunkBrownzLtd (CD/9) and FunkBrownz2Ltd (CD/10) to show the link to the applicant.

Additionally, the DPS variation (CD/11) combined with this Transfer application was to vary the DPS at the premises to Shrayash PATEL dob and recorded that he held a Brent Personal Licence. When my colleague - Sergeant John Crump completed a police national computer check on Mr Patel he saw that he was

For the following reasons:

Noise abatement notice served in April 21st was breached and I undertook a seizure of noise equipment on the 24th April. Since then the principal complainant has been away at weekends avoiding the Noise but due to further complaints I wrote and warned the licence holders on the 30th July and gave them an hours worth of advice on how to minimise the noise on the 10th August 2007. Complainant complained over the weekend 31st August see WK 200626243, 200625936 and 200714223 for full details enclosed

I have 2 good witness statements from my Noise officers (attached) detailing that after advising Mr Ash Patel and his father Raj on 31st August at 2335 that they had witnessed evidence of music and noise from high bass levels and noise from patrons smoking externally at neighbouring residential premises and a noise abatement notice was served. They left after being reassured by Ash Patel that the noise from smokers would be controlled by security and music would be turned down. But due to further complaints received noise nuisance was witnessed again at 0105 hrs on 1st September 2007 from music in the Ash Bar premises in neighbouring premises. The officers then went to speak to Mr Ash Patel and his Father the owner Raj Patel. Mr Raj Patel was under the influence of alcohol and accused my officers of being prejudiced/racist even though one of them is of mixed race. At 2:30am the complainant stated the level of music was ongoing at the same level as when a nuisance existed which also exceeds the hours allowed in their licence.

Mr Patel has also alleged the complainants ask for free drinks to placate them which

they deny.

On the 30th July I wrote and advised the Patel's on how to minimise noise and went to the bar and gave them free advice for an hour which they understood but have not adhered to infact since the smoking ban there is also noise from patrons outside sometimes over 10 people smoking externally and shouting above the music noise less than 6 metres from residents.

By his own omission Mr Raj Patel is a builder and he has bought this site to redevelop in a few years. In the meantime his son Ash who is very young and is a keen DJ who loves loud music and is obviously a bit deaf and seems to run the premises even though Mr. Raj Patel daughters V and R .Patel are the Premises licence holders who have the abatement notice served on them. Ash Patel (the bar is called after him) is not controlling the level of noise from the music which is audible till sometimes past 2:30am am next to a large residential block of flats. The threat of seizure does not work and the size of his speakers are massive so I would need to hire a removal firm and a possibly a mini Forklift to do a further seizure!!

My other options are a prosecution which I will pursue through legal however this can take six months therefore I request a formal review of the licence as they have been warned advised on numerous occasions and a serious noise nuisance still exists till 2am and can occur at least 3 nights.

Dear Mr Matuszek,

The Police representations are primarily concerned with the prevention of crime and disorder, although incidents of noise nuisance are frequently linked to this and as such may be a causal effect of the disorder.

The particular nuisance being caused has led to a number of calls being made to the Police and there are currently concerns that there is likely to be disorder when Police are requested to attend the premises to prevent a breach of the peace.

A statutory noise nuisance was served on the management of the premises by LBB after they had failed to address the issues following a number of warnings. The Police are concerned that the management of these premises having failed to comply with advice offered by Mr Haynes will be unable to properly control a venue with extended hours. The external Shisha area has also caused concern for Police and is likely to create an additional workload for patrolling officers. The following bullet point is duplicated from my representation to the sect 34 variation and is pertinent to this review:

• There are also concerns with regard to the Shisha Lounge. Which will be outside the rear of the premises and due to the recent legislation regarding smoking has to remain open to the elements for no less than 50% of the structure. Due to this it would be impossible to have any effective control of the escape of noise. The likely outcome being that Police will be called to the venue by irate residents and to ensure there is no breach of the peace. We have been encouraging venues to prevent persons taking drinks outside with them when they leave the confines of the premises to smoke, and have also advised that beer gardens and similar outdoor spaces should be closed for general usage at a set hour in the evening to prevent such noise nuisance. By only allowing persons outside to smoke they are less inclined to spend any great length of time in these areas, and as such there is far less risk of a noise nuisance.

A standard review would be inappropriate as it does not allow for the immediate enforcement of conditions by means of the "interim steps". These steps are required to ensure that the likelihood of any further disorder is greatly reduced pending the full review.

Since the 13th February 2009 there have been 11 calls to the location of **Funky Brownz**. **63 – 65 The_Hyde London NW9 6LE** relating to violent offences, disorder, offensive weapons. One male has been stabbed two Police officers assaulted. These have all involved people associated with the premises.

A seven point action plan was implemented on the 2nd March 2009 following concerns. Early indications are that they failed to follow this action plan resulting in last nights serious disorder.

The Police anticipate that there will be further violence tonight due to people returning to the venue to take retribution and due to the poor management of the premises it is unlikely that they will be able to prevent this disorder thus relying on the Police to sort out the problems and creating a significant risk to public safety.

For these reasons the Police respectfully request that a closure order is granted. Police will also be looking to the owners of these premises to voluntary close and or curtail their activities for the rest of the weekend.

There is also likely to be an application for a summary/expedited review of the premises licence.

Information & Crime Reports Funky Brownz 63 – 65 The Hyde London NW9 6LE

Since the 13th February 2009 there have been 11 calls to the location of Funky Brownz relating to violent offences, disorder and offensive weapons. One male has been stabbed two Police officers assaulted and CS spray along with batons have been deployed by Police Officers due to the level of disorder. These incidents have all involved people associated with the premises.

A seven-point action plan was implemented on the 2nd March 2009 following earlier concerns re the management at the premises, type of event being promoted, and increase in disorder.

Unfortunately it would seem that some of the Police recommendations were not complied with and serious disorder took place on the morning of Friday 20th March 2009. London Borough of Barnet CCTV picked up a fight shortly before 2am. It was apparent that a large number of people were involved. First officers on scene called for urgent assistance and the majority of the night duty team attended. Dog teams and officers from surrounding Boroughs supported them.

During the fighting CS spray was deployed against one male. A female officer whilst defending herself from an attack by a female armed with a bottle sustained an injury to her hand. A male officer was also kicked about the head by another female and has sustained bruising to the area adjacent to his left eye. Five people were arrested at the scene for offences of affray, assault on Police, offensive weapon and Public Order offences. Further enquiries are ongoing to identify and arrest other offenders.

Closure Order Sect 160 Licensing Act 2003

On the authority and information of Superintendent Tucker a closure order was granted by district judge Daber, at Hendon Magistrates Court, under sect 160 Licensing Act 2003. The Closure Order was effective for a period of 24 hours starting at 19:00hrs on Friday 20th March 2009 until 19:00hrs on Saturday 21st March 2009.

This order was applied for due to the Police concerns that there would be further violence that evening due to people returning to seek retribution, and that the management of the premises was not strong enough to prevent further disorder.



Annex 1 - Mandatory Conditions

- 1 No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2 Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3 Each individual employed in the role of guarding the premises against unauthorised access or occupation, against outbreaks of disorder or against damage must be licensed by the Security Industry Authority.
- 4 The admission of a child or young persons under the age of 18 to the exhibition of any film shall be restricted in accordance with any recommendations made by any film classification body and or persons designated as such by the Secretary of State under section 4 of the Video Recordings Act 1984.

Annex 2 – Conditions consistent with the operating schedule

- 5 This licence is granted in accordance with the published terms and conditions set out in the London Borough of Barnet's Entertainment Licensing Rules of Management for Places of Public Entertainment dated the 15th May 1989
- 6 The Premise Licence Holder and Premises Supervisor shall ensure that music provided at the premises shall not create any disturbance or annoyance to residents in the area. The Premise Licence Holder and Premises Supervisor shall monitor the music noise levels outside the premises, whenever the premises is in use under this licence, and take immediate action to reduce music levels so that music is inaudible in any residential premises.
- 7 The total number of persons present at any one time in the Function Room shall not exceed 150.
- 8 The total number of persons present at any one time in the Main Bar shall not exceed 100.
- 9 The premises shall be provided with adequate facilities to monitor and control the number of people present.
- 10 Staff are trained as appropriate in respect of relevant licensing law, the implementation of licence conditions, health safety, first aid, alcohol and drug awareness and conflict management.
- 11 Customers will not be permitted to take open glass containers outside the premises, as defined in the plan submitted with the operating schedule and approved by the Licensing Authority.
- 12 The consumption of alcohol will be restricted to those parts of the premises identified on the plan submitted with the operating schedule and approved by the Licensing Authority.
- 13 A summary of the Premises Licence will be displayed at each public entrance to the premises.
- 14 The applicant monitors the need for door supervisors and in so doing takes into account any advice given by the Police.
- 15 In line with our Alcohol and Social Responsibility Policy there will be no promotions that

encourage illegal, irresponsible or immoderate consumption.

- 16 Six SIA registered door supervisors are employed at busy times.
- 17 Bag searches are conducted at random
- 18 There will be at least one Personal Licence Holder on duty during permitted hours.
- 19 No adult entertainment (paid for by the company of a nude physical nature) is permitted at these premises. Any children under 16 remain the responsibility of the accompanying adult when using the premises (and/or exterior area). Staff are not allowed to be in sole supervision of children which remains the responsibility of the accompanying adult at all times.
- 20 The Designated Premises Supervisor/ Personal Licence Holder and staff will at all times remain aware of their responsibilities under this objective, including that alcohol shall not be sold to anyone under the age of 18. Staff on duty have been trained and made aware of these requirements and the need to demand an acceptable form of age I.D. (i.e. an accredited 'Proof of Age' card or 'new type' driving licence with a photograph or passport with (photograph) where considered appropriate.
- 21 Children under the age of 18 will only be allowed on the premises as long as they are accompanied by their parents or other adults as part of a 'family' taking a table meal.
- 22 Challenge 21 Scheme will be adopted. Customers who appear to be 21 years or less are to be challenged when attempting to purchase alcohol.

Annex 3 – Conditions attached after hearing by the licensing authority

- 23 No patrons allowed in the northern access area of the premises next to 69 The Hyde NW9 at any time.
- 24 No patrons to be admitted or readmitted to rear smoking area after 11pm on Sunday, Monday, Tuesday, and Wednesday or after midnight on Thursday, Friday and Saturday.
- 25 Security staff to regularly monitor rear smoking area after 9pm each night to ensure no noise from patrons is clearly audible at nearest residential premises situated at Malvern Court and 69 The Hyde NW9. The partition of the smoking area connected to the premises structure is to be extended (by the 9th October 2007) so there are no gaps from the doors, roof or partition where it connects to the site perimeter fence to minimise noise break out from patrons in the smoking area.
- 27 The License holder is to attend all pub watch meetings and arrange meetings with the Area residents Association on a quarterly (3-monthly) basis.
- 26 No empty bottles to be disposed of until after 10am the following morning.
- 28 SIA door supervisors will be employed on Thursday, Friday and Saturday from 8:30pm (20:30hrs) until 30 minutes after the premises have closed
- 29 The SIA door supervisors will wear a clearly identifiable jacket with high visibility (light reflective) panels.
- 30 5 SIA door supervisors will be employed at any time when the club is open.
- 31 If the club is closed then the requirement for SIA door supervisors may be reduced to 2. This reduction in doors supervisors is at the discretion and risk assessment of the premises licence holders and the Designated Premises Supervisor (DPS).

- 32 If the club is closed and the bar/restaurant also closes no later than 12:30am (00:30hrs) there shall be no requirement for door supervisors. This decision is at the discretion and risk assessment of the premises licence holders and the Designated Premises Supervisor (DPS).
- 33 A digital CCTV system is installed to the requirements of the Crime Prevention Officer and include:
 - a. Digital recording colour CCTV comprising a multi-camera system.
 - b. The head unit (recorder) for storing the images will store such data on a hard drive or a similar quality medium.
 - c. A CD or DVD burner will also form part of the system to facilitate copies of the images.
 - d. If the head unit (recorder) is kept at the premises it must be located in a secure cabinet or other secure area, preferably out of sight and reach of the public. The unit must be further secured by physical means to prevent anyone from merely picking up and removing the unit, e.g. a secure metal boot, or metal case strap, bolted to an immovable object like a wall or floor.
 - e. The quality of the images must be of a sufficiently high standard to allow identification of the subject matter.
 - f. Cameras will cover key areas identified by the operator and Police. These will include external cameras covering any outside area used by patrons of the premises, the external entrance and exit doors, clear headshots of persons entering the premises, approach route to the toilets, the bar and till areas and other areas not in full view from the bar.
 - g. Images must be retained for a period of 31 days before overwriting.
 - h. The images will be made available on reasonable demand by the Police and authorised officers of the London Borough of Barnet.
 - i. At all times when the premises are open there shall be at least one person who is capable of operating the CCTV system if required to do so by the Police or authorised officers of the London Borough of Barnet.
 - j. This system will be fully maintained at all times to ensure correct operation.
- 34 There shall be no entry to the premises one hour before the end of the licensable activities.
- 35 When the premises are open, staff will carry out security checks to the premises including the toilet areas. A log will be kept of those checks.
- 36 Regular checks of the toilets to be made and recorded, with intervals being no greater than one hour.
- 37 Police and London Borough of Barnet approved signs to be clearly displayed. The signs will be worded to advise clients that CCTV covers the premises and that there is zero tolerance to drugs and other criminal activity.
- 38 Besides any prosecution for offences, anyone barred from these premises will also be barred from all of the other premises in the pubwatch scheme.
- 39 When the "Club" section of the premises is open there shall be at least one Personal Licence Holder on duty during the hours, as shown on the licence, where the premises are open to the public.
- 40 Public transport information and taxi cab numbers will be available to all customers.
- 41 Acceptable forms of ID are (but not limited to) valid passport, photocard driving licence, PASS approved proof of age card.

- 42 The applicant must ensure that the amplified music system in use at the premises includes a noise limiting device which:
 - a. Measures the sound level in the premises by use of a tamper proof device permanently sited at the premises. Such sound pressure levels are to be measured in octave band frequencies of 16, 32, 63, 125,250 and 500 Hz
 - b. Immediately withdraws power to the amplifier in the event that preset sound levels of any or all of the individual octave bands which have previously been agreed by the Group Manager, Public Health and Nuisance at the London Borough of Barnet are exceeded. Such levels will be based upon inaudibility in residential properties between the hours of 2300 and 0700 hours. Outside of these times noise must not be at a level which causes a nuisance.
 - c. Is permanently fixed in the premises and cannot be altered, bypassed or tampered with in any way.
 - d. Is correctly installed by a competent person, being an electrician who is enrolled with NICEIC.
 - e. Includes electrical contact point switches fitted on all open able windows to the property; such switches to be fitted in series in a single electrical circuit loop such that in the event of the electrical contact switches becoming separated (by a window being opened) then the power to the amplifier is withdrawn immediately.
 - f. Includes electrical contact point switches fitted on all openable doors which are fire doors used other than to enter or leave the premises under normal circumstances; such switches to be fitted in series in a single electrical circuit loop together with the electrical contact switches fitted to the windows, such that in the event of the electrical contact switches becoming separated (by a fire door being opened) then the power to the amplifier is withdrawn immediately.
- 43 There shall be no external promotions at the venue. All functions at the premises shall be controlled by the premises licence holders and the Designated Premises Supervisor (DPS). This includes the advertising and promotion of events.
- 44 There shall be no direct access for the public via the intercommunicating doors between the bar/restaurant area and the club
- 45 The terminal hour for all licensable activities shall be no later than 1am (01:00hrs) on any Friday with the premises being closed and cleared by 1:30am (01:30hrs) of all persons with the exception of staff employed at the premises.
- 46 There shall be a 'calm down' period of 20 minutes in the night club prior to closing at 2.00am (02:00hrs)
- 47 All licensable activity in the restaurant/bar area of the premises will end 30 minutes prior to any current terminal hour of the club. The restaurant/bar area will also close 30 minutes earlier than any terminal hour for the club.



Re: Transfer of premises licence from Finbar Holian to Funky Brownz 2 Ltd

Further to your objection letter dated 17 February 2011, I write to as one of the existing Directors of Funky Brownz Ltd and soon to be Director of Funky Brownz 2 Ltd.

I have read all the grounds for review that you have provided and would like to reply to your concerns with the following.

Firstly, you mention that one of our branches in Haringey is 'apparently shut'. This statement is incorrect. We have been successfully operating in Haringey since August 2009, and have not been closed or 'shut' to date. Apart from this I can also claim that neither have we had any issues or incidents which have led to any concern for the police or council.

With regards to our Colindale branch, I have read your concerns regarding the two reviews. This branch has been in operation for the past 6 years.

The first review as you know was to do with noise nuisance. This problem was bought to our attention in September 2009 and was dealt with almost immediately. Since this time (2 and a half years), we have had no complaints or issues with anything to with any noise stemming from our establishment.

The second review was associated with crime and disorder which stemmed from a closure order in early 2009. When at the licence review we put forward our argument that the crime occurred to due to the promoting of the business by a third party. The committee at the time thankfully acknowledged that it was a bad error of judgement and due to the fact that we had never had any crime and disorder issues prior to this decided not to revoke our licence. Since then (2 years), we have carried on promoting our business in house and have been running a successful operation.

You may be aware that our Colindale branch is split in two sections. The first is a bar restaurant and second is the club, both of which have two separate entrances. It would be worth considering that both of these above reviews arose from the club side of our business. The style of business that we are proposing in Belmont Circle is very similar to that of the bar/restaurant in Colindale. I would like to stress that we are not going to be taking the club route at all.

The other concern that has been brought to my attention is that of the proposed DPS of the premises. I can confirm that Mr Shrayash Patel has formally withdrawn his application via email on 16th February, marked to the attention to Miss Forde. Nonetheless, Shrayash Patel has emailed Harrow Council again today re iterating the same and has asked for an acknowledgment of receipt. For your information, I will be making an application for DPS immediately.

I would like to take this opportunity to say that when we first opened our Colindale branch we were relatively new to the business. As such we incurred a few teething problems. Since then we have rectified any issues concerning the police and the council and have always done our very best to work closely with them. Our Haringey branch is proof that we are capable of opening and running a successful business with no issues. We do find it very unfair that we are penalised for the incidents that have taken place with our Colindale branch especially since that last incident took place 2 years ago.

I cannot stress enough that we are more than happy to work along side the police and the council to make sure that no issues are to arise with the opening of our establishment in the Harrow area. We want to work with the local community and business owners and bring a better and more upmarket atmosphere to the area.

I do hope that you are able to appreciate the above comments and hope that you will give them careful consideration before taking this to a licensing committee.
