387. Admission to County Schools

In accordance with the Local Government (Access to Information) Act 1985, cases P561 – P634 were admitted late to the agenda to allow the Panel to allocate an appropriate place to the applicants. It was noted that case numbers P560, P562, P608, P619 and P624 had been withdrawn as these pupils had been offered school places prior to the meeting.

A grid which set out the home to school distance for each pupil was circulated at the meeting. In addition, a number of letters from the headteachers of various schools which set out information about pupil numbers at their schools were circulated to the Panel for consideration.

On 6 November 2013, there were 70 children for whom admissions staff could make no reasonable offer of a school place. The School Placement Panel was requested to recommend to the Corporate Director of Children and Families to authorise the admission of these pupils to a school where no places existed in the relevant year group.
