453. Admission to County Schools

In accordance with the Local Government (Access to Information) Act 1985, cases P1164-P1186, circulated as supplemental agenda, were admitted late to the agenda to allow the Panel to allocate an appropriate place to the applicants. The following additional cases P1187-P1202 were tabled at the meeting and accepted as late cases.

The Panel also received a grid which set out the home to school distance for each pupil which was circulated at the meeting. In addition, a number of letters from headteachers and school representatives of various schools, which set out information about pupil numbers at their schools, were circulated to the Panel for consideration.

On 14 May 2014, there were 36 children for whom admissions staff could make no reasonable offer of a school place. There were also 4 children whose cases had been withdrawn, as they had been allocated school places. The School Placement Panel was requested to recommend to the Interim

Corporate Director of Children and Families to authorise the admission of these pupils to a school where no places existed in the relevant year group.
