## 316. Admission to County Schools

In accordance with the Local Government (Access to Information) Act 1985, cases P378-P412 were admitted late to the agenda to allow the Panel to allocate an appropriate place to the applicants. A grid setting out the pupil numbers and the distances to schools were also circulated.
