**RESOLVED:** That, having carefully considered all the relevant information including:

- written and oral representations by all the parties
- the Licensing Act 2003 and the steps that are appropriate to promote the licensing objectives
- the Guidance issued under section 182 of the Licensing Act 2003
- Harrow Council's Licensing Policy
- Human Rights Act 1998

the Panel agreed that the following modifications be made:

(1) the premises licence be modified by amending the hours that the premises are open to the public and the hours for licensable activities to the following:

Thursday – Saturday - 12:00 - 0:00

(2) the following condition be added to the premises licence:

A sound limiter shall be installed and fitted with electrical cut out devices connected to all external doors, windows and fire escapes in the licensed premises. This is to ensure that if the doors, windows or fire escapes are left open the amplified noise cuts out. The level of noise permitted by the noise limiter is to be agreed with the Environmental Health Department of the Council. The device and system will be fully maintained at all times to ensure correct operation. **Reasons:** The Panel considered that the decision promoted the licensing objectives of the prevention of crime and disorder, the prevention of public nuisance and public safety.
