# **Section 1 - Summary**

An application has been received for a variation to the premises licence for Dil Se Restaurant and Lounge, 56 – 60 Northolt Road, South Harrow HA2 0DW to allow hotel residents/guests to use its' restaurant facilities 24 hours a day and to change the licensable activities and hours for the premises. Representations including a petition have been received from local residents.

# **Section 2 – Report**

- 2.1 The applicant, Mr Jayesh Patel, has applied to extend the hours for licensable activities (see paragraph 2.3) and amend the licence conditions (see paragraph 2.10) for Dil Se Restaurant and Lounge, 56 60 Northolt Road, South Harrow HA2 0DW.
- 2.2 The effect of proposed variation is described as "the first floor restaurant is to be used as part of the hotel as now it has been taken over by the hotel operators. In order to allow the hotel residents/guests to use it at all times this variation is applied to open the

restaurant 24 hours a day. The variation also changes the hours of operation for the restaurant and licensable activities for the general public".

# 2.3 Licensable activities

The application has been amended since it was submitted in the light of representations made. The table below sets out the existing licensable activities and those applied for in respect of the proposed new licence:

# 2.4 Description of premises

The premises were described in the application for a new premises licence in 2012 as "a restaurant and bar situated on the first floor of the Euro Traveller next to South Harrow Police Station. The building is a 3\* hotel. The first floor is an ancillary bar/restaurant/lounge which is accessible also on the ground floor via a separate entrance for the public and residents of the hotel."

- 2.5 It is understood the licensed area has a capacity of about 250 people (although different capacities may apply for different types of events).
- 2.6 A layout of the premises is shown at appendix 1.

# 2.7 Licensing history

- Premises licence granted on 20 November 2012 to 3K Events Management Ltd.
- licence transferred to Warrison JR Ltd on 16 January 2014
- licence transferred to current premises licence holder on 27 August 2015

# 2.9 Details of application

## 2.10 Representations

Representations have been received from local residents living immediately adjacent to and immediately across Northolt Road from the premises. The representations are concerned about:

- · cars parking and blocking access to the residents' car parks
- litter and rubbish being left outside the residents' flat at Sherbourne House
- children's' sleep being disturbed by late-night noise
- anti-social behaviour and noise from people leaving the premises after midnight
- customers drinking longer if the hotel is open for 24 hours

Representations have also been made by Environmental Health and the Licensing Authority.

### 2.11 Conditions

The applicant had applied to delete conditions 1, 2, 4 and 6 in annexe 2 of the current licence. Environmental Health object to the deletion of those conditions (see appendix 3) and the applicant has subsequently agreed to retain conditions 1 and 2.

- 2.12 Condition 4 of the licence has been effectively replaced under the Licensing Act 2003 (Mandatory Licensing Conditions) (Amendment) Order 2014 in annexe 1 of the licence prohibiting irresponsible alcohol sales promotions, and there is no objection by the Licensing Authority to that being deleted from annexe 2.
- 2.13 The Premises Licence Holder has accepted the Licensing Authority's suggested condition in lieu of the existing condition 6 as set out in the summary at appendix 4.

- 2.14 At the time of writing the applicant has not accepted the other conditions proposed by Environmental Health, other than in relation to conditions 1 and 2 (see paragraph 2.11 above) and agreeing to close thirty minutes between the end of licensable activities and the premises closing.
- 2.15 Members will be aware that an operating schedule forms part of the licensing process. This document outlines what activities are proposed, the opening hours, and how the activities will be managed particularly in respect of the licensing objectives.
- 2.16 The most critical part of the operating schedule are the steps taken by the applicant to promote the licensing objectives. Applicants are always reminded to take careful consideration as to what is entered in this section as whatever is proposed will be converted into conditions on the licence. The Panel will be aware that breach of any licence condition is potentially a criminal offence, for which the maximum penalty before a magistrates' court is an unlimited fine and/or six months' imprisonment.
- 2.17 Conditions must be clear, unambiguous and capable of being understood and complied with by the licence-holder.
- 2.18 Applicants should give consideration to the local area and reflect this in their application (see para 8.33 of the statutory guidance). It should demonstrate an awareness of the local community, local crime and disorder issues, and the local environment.
- 2.19 Appendix 4 sets out the applicant's proposed times and what the conditions extracted from the operating schedule and representations would appear as on the licence should the Panel be minded to grant the licence application as sought.
- 2.20 The Panel has the discretion to add to or modify these conditions where it is appropriate to do so to promote the licensing objectives.

# 2.21 Officers' observations

In response to the representations, the applicant amended his application as he is entitled to do. One proposed amendment is "the restaurant will close at 0200 hours on days when there is a pre-booked party". This will be reflected in the premises opening and closing hours.

- 2.22 The applicant has confirmed the intention in this scenario would be for licensable activities to end at 0130 hours on the days there is a pre-booked party without any further application or consent from the licensing authority. If the Panel is minded to agree this proposed amendment, for the sake of clarity and enforcement, it is recommended that that a condition is included on the licence:
  - "(1) The restaurant will close at 0200 hours on days when there is a pre-booked party.
  - (2) No licensable activities may be provided after 01.30 hours on those days."
- 2.23 The Panel will be aware that providing late night refreshment to hotel residents is not a licensable activity, although the licence is needed for non-residents. The

- representations are predominately concerned with the sale of alcohol to, and the late night-dispersal of, non-residents.
- 2.24 The Panel should bear in mind the following paragraphs of the statutory guidance to the Act in relation to the representation about public nuisance:
  - 2.15 Public nuisance is given a statutory meaning in many pieces of legislation. It is however not narrowly defined in the 2003 Act and retains its broad common law meaning. It may include in appropriate circumstances the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises. Public nuisance may also arise as a result of the adverse effects of artificial light, dust, odour and insects or where its effect is prejudicial to health.
  - 2.16 Conditions relating to noise nuisance will usually concern steps appropriate to control the levels of noise emanating from premises. This might be achieved by a simple measure such as ensuring that doors and windows are kept closed after a particular time, or persons are not permitted in garden areas of the premises after a certain time. More sophisticated measures like the installation of acoustic curtains or rubber speaker mounts to mitigate sound escape from the premises may be appropriate. However, conditions in relation to live or recorded music may not be enforceable in circumstances where the entertainment activity itself is not licensable (see chapter 15). Any conditions appropriate to promote the prevention of public nuisance should be tailored to the type, nature and characteristics of the specific premises and its licensable activities. Licensing authorities should avoid inappropriate or disproportionate measures that could deter events that are valuable to the community, such as live music. Noise limiters, for example, are expensive to purchase and install and are likely to be a considerable burden for smaller venues.
  - 2.17 As with all conditions, those relating to noise nuisance may not be appropriate in certain circumstances where provisions in other legislation adequately protect those living in the area of the premises. But as stated earlier in this Guidance, the approach of licensing authorities and responsible authorities should be one of prevention and when their powers are engaged, licensing authorities should be aware of the fact that other legislation may not adequately cover concerns raised in relevant representations and additional conditions may be appropriate.
  - 2.18 Where applications have given rise to representations, any appropriate conditions should normally focus on the most sensitive periods. For example, the most sensitive period for people being disturbed by unreasonably loud music is at night and into the early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. This is why there is still a need for a licence for performances of live music between 11 pm and 8 am. In certain circumstances, conditions relating to noise emanating from the premises may also be appropriate to address any disturbance anticipated as customers enter and leave.
- 2.25 The Panel is entitled to take account of the prospective effect of the application when considering the representations. The Panel may wish to note however that none of the responsible authorities, particularly the police, have made representations concerning levels of crime or anti-social behaviour in the vicinity of the premises. The statutory guidance (at paragraph 2.1 and 9.12) suggests that licensing authorities should rely on the police as the primary source of advice on crime and disorder matters.
- 2.26 The representations are concerned about nuisance parking, without any direct evidence that Dil Se's customers are responsible for this at present. There are also concerns expressed about noise break-out from the premises, noise from people smoking outside the premises and dispersal noise under its' existing operating

- conditions. There are concerns about extending the licensable activities including alcohol sales to twenty-four hours and late night dispersal noise. The representation from Environmental Health proposes conditions to address those concerns.
- 2.27 Representation A is accompanied with videos and photographs from 2013, 2014, three from 2015 and from 2016. The premises licence holder has had the opportunity to view those videos and photographs prior to the hearing.
- 2.28 Representations refer to previous incidents since the premises opened in 2012. Whilst the Panel is entitled to take a prospective view of the likely effects of granting the application, it should not necessarily take into account events prior to August 2015 when the licence was transferred to the current holder on the principle that each application ought to be considered on its own merits.
- 2.29 The Panel will note that representation G is supported by a petition signed by seventy five people. The Panel is recommended to treat the petition organiser as the party to the hearing although he may call people to speak in support of the petition if the Panel thinks fit. Five of the petitioners have separately submitted representations against the application.
- 2.30 Representation G suggests that there is no requirement for children to leave the bar at a reasonable hour, thus undermining the child protection objective. The Panel's attention is drawn to section 145 of the Act which makes it illegal for unaccompanied children under 16 to be on the premises between midnight and 0500 hours when the premises are open for the supply of alcohol.
- 2.31 The Panel will be aware that they may only consider the representation in relation to the varied hours and conditions only. If the Panel refuses the variation the applicant retains the existing licence hours and conditions to which he is entitled.
- 2.32 These above comments are to assist the Panel in its decision-making process based on the evidence before it and the legislative requirements. It is for the Panel to decide how much weight and emphasis ought to be given to each representation.

# 2.33 <u>Licensing policy</u>

There are no implications in relation to the statement of licensing policy arising from this application.

## 2.34 Legal implications

The Licensing Panel is required to hold a hearing to consider any relevant representations made in relation to the premises licence application unless all parties agree that a hearing is unnecessary. The hearing must be held in accordance with the Licensing Act 2003 (Hearings) Regulations 2005.

- 2.35 The Licensing Panel is required to give appropriate weight to the representations (including supporting information) presented by all the parties, the Guidance issued pursuant to section 182 of the Licensing Act 2003, the Council's statement of licensing policy and the steps that are appropriate to promote the four licensing objectives.
- 2.36 Having considered those relevant matters, the Licensing Panel is required to take such of the following steps (if any) as it considers appropriate for the promotion of the licensing objectives –

- (1) to modify the conditions of the licence
- (2) to reject the whole or part of the licence

and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added (section 35(4) of the Act).

- 2.23 It should be noted that
  - clear reasons should be given for the decision.
  - any additional or modified conditions should be practical and enforceable
  - the applicant and any person who made relevant representations would have the right of appeal to a magistrates' court on one of the grounds provided in schedule 5 to the Licensing Act 2003.
- 2.24 In addition to determining the application in accordance with the legislation, Members must have regard to the common law rules of natural justice by ensuring that every party has a fair hearing, they are not judges in their own cause and they do not make a decision until they have heard all of the evidence.
- 2.25 The Panel must also act proportionately to apply the European Convention for the Protection of Human Rights and Fundamental Freedoms implemented under the Human Rights Act 1998, particularly articles 6 (relating to the right to a fair trial); article 1 (prohibition against discrimination); article 8 (protection of private and family life); and article 1 of the First Protocol (protection of property). No decision may be arbitrary or unreasonable.
- 2.25 Under section 17 of the Crime and Disorder Act 1998 the Panel has a duty to (a) have due regard to the likely effect of crime and disorder, and (b) to do all that it reasonably can to prevent crime and disorder, when exercising its powers under the Licensing Act.

# **Financial Implications**

2.26 There are no financial implications.

# **Appeals**

2.27 If any party is aggrieved with the decision of the licensing panel on one of the grounds set out in schedule 5 to the Licensing Act 2003, they can appeal to a magistrates' court within 21 days from notification of the decision.

# Annex 1 - Mandatory Conditions

## Mandatory conditions where licence authorises supply of alcohol:

- 1 No supply of alcohol may be made under the premises licence
  - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended
- 2. Every supply or sale of alcohol made under the premises licence must be made or authorised by a person who holds a personal licence.

## Mandatory condition where licence requires door supervision:

Where one or more individuals are required to be at the premises to carry out a security activity, such individual(s) must be licensed by the Security Industry Authority.

#### The Licensing Act 2003 (Mandatory Licensing Conditions) (Amendment) Order 2014

- 1. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
- (a)games or other activities which require or encourage, or are designed to require or encourage, individuals to—
- (i)drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii)drink as much alcohol as possible (whether within a time limit or otherwise);
- (b)provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c)provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d)selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e)dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).



- 2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 3. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
  - (a)a holographic mark, or
  - (b)an ultraviolet feature.
- 4. The responsible person must ensure that—
- (a)where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
  - (i)beer or cider: 1/2 pint;
  - (ii)gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii)still wine in a glass: 125 ml;
- (b)these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c)where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

# **Mandatory Condition order 2014**

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1—
- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
- (b) "permitted price" is the price found by applying the formula—

P = D + (DxV)

where—

- (i) P is the permitted price,
- (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
  - (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

### Mandatory conditions where licence authorises exhibition of films:

(1) The admission of persons under the age of 18 years to exhibitions of films must be restricted in



accordance with any recommendation made by the British Board of Film Classification, except where condition 2 applies.

(2) The admission of persons under the age of 18 years to exhibitions of films must be restricted in accordance with any recommendation made by the relevant licensing authority regarding the film in question

### Annex 2 - Conditions consistent with the Operating Schedule

- 1. Appropriate automatic noise control device must be fitted to all amplified sound equipment. The device must be:
- a) Set so that the volume of any amplified sound emanating from the premises does not cause a public nuisance. A Compliance Certificate must be supplied to the licensing authority for the installation of the unit for approval before any regulated entertainment is carried out.

The installation must be carried out by a competent/qualified person. The compliance certificate must contain the following.



- b) The devices must be fitted to all power outlets (i.e. to the main distribution unit) and externally opening window and doors to the premises.
- 2. The Premises Supervisor must ensure that any amplified sound from the premises does not cause a public nuisance by ensuring that amplified sound is inaudible at the boundary of any premises where the occupiers are likely to be sensitive to noise.
- 3. All members of staff will be appropriately trained in their job function. Records of the training will be made available to the Licensing Authority or Police upon request.
- 4. No promotions involving alcoholic drinks being sold at lower prices than the Licensee would normally charge shall take place in connection with any public entertainment event held on any day without the prior agreement of the Licensing Authority who shall first consult the Police. Any application for an event involving such a drinks promotion shall be made at least 14 days prior to the event. Where drinks promotions have been agreed they shall not be varied without prior reference to the Licensing Authority.
- 5. A 'Challenge 25' policy will be operated at the premises, whereby any person attempting to purchase alcohol (or other age restricted products) and who appears to be under the age of 25 years, will be asked to provide proof (i.e. passport, driver's licence or some other such accredited form of photo identification) that they over the age of 18 years. Notices will be displayed advising customers that the scheme is in operation. A record of age related refusals of sale will be kept and will be made available to officers of the police or local authority upon request.
- 6. The CCTV system to be maintained and operated in good order and to the satisfaction of the Metropolitan Police's reasonable requests as documented in the Harrow Police Security Recommendations document. The medium upon which the images are recorded will be clearly identifiable, stored securely and retained for a period of not less than 31 days if analogue and not less than 14 days if digital, and will be made available to Council officers and Police on request.
- 7. All windows and doors will be closed when regulated entertainment is taking place.
- 8. Measures such as signage and DJ announcements will be taken to ensure customers leave the premises quietly and minimise disturbance to residents in the area.
- 9. No consumption of alcohol in the designated smoking area in the car park.

This variation is to extend the existing hours for licensable activities for non-residents at the hotel and to delete four existing licence conditions.

The licensing authority does not object to the concept behind the application providing appropriate controls are in place to promote the licensing objectives as follows:

#### Prevention of crime and disorder

The licensing authority believes the proposed replacement of condition 4 with the proposed wording is too ambiguous and may also delay the investigation of offences by the police if written requests must be given by the police. It suggests the following condition ought to be incorporated in the licence:

- (1) The CCTV system to be maintained and operated in good order in accordance with the Home Office Operational Requirements CCTV Manual 2009 (Publication 28/09).
- (2) Images recorded will be clearly identifiable, stored securely and retained for a period of not less than 31 days
- (3) Images and recordings will be made available to police and licensing authority officers in a format suitable of being viewed away from the premises within 24 hours of being requested.
- (4) No image or recording shall be provided in accordance with sub--condition 3 unless the police or licensing authority officer requesting it has entered his reasons for doing so in a register maintained by the Premises Licence Holder to meet his obligations under the Data Protection Act 1990.

### Prevention of nuisance/public safety

Complaints have been made to the licensing authority about noise from patrons leaving the premises leaving late at night. There is also concern about patrons leaving nearby licensed premises and who might then wish to gain entry to the applicant's premises late at night. I refer to the application to vary a Premises Licence under the Licensing Act 2003, relating to the above named premises.

The Domestic, in its capacity as a responsible authority, is making a representation to this application, in relation to the licensing objective 'Prevention of Public Nuisance'.

In preparing this representation I, Jo Smith, visited the premises on the 3<sup>rd</sup> August 2016. Dil Se is located on Northolt Road, a busy main road with several commercial elements on the ground floor and residential above. Residential developments are next door (Osbury Court, 52 Northolt Road) behind and opposite the venue. The nearest residential accommodation is Osbury Court, 52 Northolt Road, next door to Dil Se.

The Premises wishes to extend their opening hours until 1am Monday – Thursday, 2am Friday and Saturday, and 3am on Sunday Nights. Currently their operating hours are:

Monday - From: 10:00 To: 23:00
Tuesday - From: 10:00 To: 23:00
Wednesday - From: 10:00 To: 23:00
Friday - From: 10:00 To: 23:00
Saturday - From: 10:00 To: 23:00
Saturday - From: 10:00 To: 23:00
From: 10:00 To: 23:00
From: 10:00 To: 23:00

The grounds for this objection are:

- The premises wishes to remove certain conditions relating to the Prevention of Public Nuisance, namely conditions 1 and 2, listed below:
  - An appropriate automatic noise control device must be fitted to all amplified sound equipment. The device must be:
  - a) Set so that the volume of any amplified sound emanating from the premises does not cause a public nuisance. A Compliance Certificate must be supplied to the licensing authority for the installation of the unit for approval before any regulated entertainment is carried out.

The installation must be carried out by a competent/qualified person. The compliance certificate must contain the following.

5 minute LAEQ

Frequency analysis between 200Hz - 30Hz

- b) The devices must be fitted to all power outlets (i.e. to the main distribution unit) and externally opening window and doors to the premises.
- 2) The Premises Supervisor must ensure that any amplified sound from the premises does not cause a public nuisance by ensuring that amplified sound is inaudible at the boundary of any premises where the occupiers are likely to be sensitive to noise.

The removal of these conditions would not prevent Public Nuisance, but create further disturbances. There have been no assurances made by the management of the premises to ensure residents would not be disturbed by patrons leaving the premises.

• We have no confidence in the management adhering to the licensing hours currently permitted as we have received complaints and time stamped videos showing patrons leaving at approx. 2am and later.

- The premises was initially let to a separate company from the Eurotraveller Hotel. Noise complaints had arisen and as such the owner of the hotel brought the management of Dil se back under their control. However the management of the restaurant and banqueting area is such that they have breached the terms of their licence on several occasions, and as a result have been warned by the Licensing Team.
- We have an ongoing complaint from residents regarding the noise from patrons leaving the premises, and noise from patrons in the premises where they have been smoking on the ground floor. However these complaints have not as yet been witnessed by an officer.
- There does not appear to be a limiter in use at the premises, and currently any hired DJ's are not required to route their sound systems through the limiter or the Banqueting Suite's equipment.
- The speakers within the premises are not fitted on acoustic mounts, thus allowing music noise to travel through the structure of the building, disturbing both quests of the hotel and neighbouring premises.

Should the Licensing Sub-Committee be minded to grant the licence the following actions and conditions are recommended:

- 1. To retain conditions 1, 2, 4 and 6.
- 2. The 24 hour usage for hotel guests only shall apply to the serving of soft drinks and hot food only. This will not apply to regulated entertainment or alcohol.
- 3. All doors and windows to the premises shall be kept closed after 21.00 hours when regulated entertainment is taking place, except for access and egress.
- 4. All doors used as fire exits only shall be fitted with audible and/or visual alarms that operate when doors are opened.
- 5. Any patrons queuing/congregating outside the premises shall be properly supervised by SIA door supervisors.
- 6. There shall be no admission or re-admission to the premises after 23:00 hours, except for customers exiting in order to smoke.
- 7. Customers shall be encouraged to disperse quietly and avoid congregating outside the premises at closing time.
- 8. A period of at least 30 minutes shall be provided between the end of regulated entertainment/sale of alcohol and closure, to encourage patrons to leave gradually and minimise public nuisance.
- 9. Clear and legible notices shall be displayed in a prominent position near the exit door(s) requesting that customers leave quietly to avoid disturbing local residents.
- 10. Clear and legible notice shall be displayed in a prominent position in any external areas where customers are permitted to smoke or drink, requesting that they keep noise to a minimum to avoid disturbing local residents.
- 11. The designated premises supervisor or his/her representative shall conduct regular assessments of the noise coming from the premises on each occasion there is regulated entertainment, and shall take steps to reduce the level of noise where it is likely to cause a disturbance to local residents. A written record shall be kept in a log book and shall include the time and date of the checks, the person making them and the findings, including any remedial action.
- 12. A sound limiting device shall be installed in accordance with the manufacturer's instructions, and shall be attached to all sound amplification equipment used on the premises. The device shall be located in a lockable cabinet and set at a level to the satisfaction of the Environmental Protection Unit (EPU). The keys shall be held by the designated premises supervisor or other authorised manager and shall not be available to any other person. The limiter shall not be altered without prior agreement from the EPU. The sound limiting device shall be designed to activate a visual warning and prevent any increase in volume once the pre-determined sound limit has been reached.
- 13. Obtain a written report from an acoustic engineer who is a member of the Institute of Acoustics. The report should identify the type of regulated entertainment to be carried out and recommend any active or passive measures required to prevent airborne or structural noise and vibration transmission from adversely affecting local residents. A copy of the report shall be provided to the Domestic Environmental Health Team. All recommended works shall be completed to the satisfaction of the Domestic Environmental Health Officer within two months from the date of the acoustic engineer's report.

14. A record shall be kept of all complaints relating to noise or nuisance and incidents or crime and disorder taking place on or in the immediate vicinity of the Premises, which shall be available for inspection by the Licensing Authority and the Police at all times when the Premises are open.

I would therefore invite the Licensing Sub-committee to consider this representation when making their decision regarding this application.



Dear Sir or Madam,

I am writing to make a representation under the Licensing Act 2003 for the premises: Dil Se Restaurant & Banqueting, 56-60 Northolt Road, South Harrow, HA2 0DW with licence number LN/000005974. I am aware that they have made an application to vary their licence to extend their licensing hours and to remove certain conditions on their licence.

As a resident living in the vicinity of the premises, I must object to any extension of the licensing hours beyond the current 11pm on the basis of the prevention of public nuisance and the prevention of crime and disorder.

Dil Se is a bar/restaurant attached to the Eurotraveller hotel which advertises itself as an event venue for up to 250 people [1]. It is surrounded by developments such as Grange Court, Osbury Court, Sherbourne House & Padda Court with a total of 93 residential addresses between them.

If their licensing hours are extended it will inevitably lead to noise in the early hours which will disrupt the lives and sleep of the many families living nearby. In fact, despite their current licensing hours, they have a long history of holding late night events without a temporary event notice. Because of this, I have direct experience of the effects of late opening.

Incidents that have affected me run from 21/1/2012 through to 30/7/2016. During that time, the premises licence has changed hands several times along with the name. For example, in 2014 it was closed for several weeks by bailiffs before re-opening as Kaama. Similarly, it was closed for most of the first half of 2015 then re-opened under the name Aarti. Most recently, it was closed for much of the first half of this year. While these periods of closure have provided relief, this has always proved temporary as the late-night events resume. The changes of licensee mean that, for some of the incidents the applicant was the licence holder [2], while for others they were the landlord of the licence holder.

### During these late-running events:

Often, extra audio equipment such as amplifiers and speakers are bought in which apparently bypass whatever noise control devices are installed. These are loud enough that I have to keep all windows closed in Summer. Even then, the music is clearly audible inside my property and loud enough to interfere with watching television, sleeping, etc.

- The front-door is usually propped open as customers gather outside to smoke and drink [3].
   As well as the noise from these crowds throughout the evening and into the night, the open door increases the noise due to loud music.
- When the event ends in the early hours, the noise from crowds leaving wakes me up.
   Depending on the event, this has been as late as 4am [4]. As they gather outside to wait for taxis or lifts, there are frequently problems due to drunkenness including public urination [5].
- On several occasions, the police have attended in force to deal with crowds gathered outside [6].

I have previously contacted the licensing department about these issues and am aware that others have too. Through them, I know that Licensing Officer Peter Coates witnessed late opening at the premises on 13/12/2013, that they applied for a TEN on 24/10/2014 which was vetoed but that the event went ahead regardless [7] and that the licence holder has been called in for interview several times. This has resulted in several changes of DPS and temporary respite from late-night nuisance, but they have always reverted to exceeding their licensing hours again.

I notice that the application also proposes the removal of licensing conditions (1) & (2) related to automatic noise controls and the audibility of amplified sound at the boundary of other properties. Given the existing problems with late night disturbance from amplified music, removal of these conditions would serve only to increase the public nuisance.

I also wish to object to the proposed removal of condition (4) related to promoting alcohol sales through reduced pricing. Despite this condition, the premises has previously advertised "happy-hour" and similar promotions [8]. The previous problems with public drunkenness and disorder would be aggravated by its removal.

Finally, I have serious concerns about the proposal that the bar be open to hotel guests and serving alcohol 24 hours a day. Guests already have 24-hour access to alcohol through room service and there are no licensing conditions either existing or proposed to enforce the restriction to hotel guests.

Whilst I understand the need for the licensee to be able to run their business, the proposals in the application are more suited to a nightclub than a hotel restaurant. The application does not include anything that would address the current problems, but only proposes the removal of restrictions and extension of licensing hours. It is because of the effect on myself and my neighbours of previous, unauthorised, late-night events that I am objecting to the application. Please find enclosed a list of photographs and videos in support of this.



I have recently become aware that the above premises is seeking to extend its hours of operation including the period when alcohol may be served.

Having reviewed the application and following discussion with my neighbours I wish to oppose the application and trust that the Council's Licensing Panel will take the contents of this letter into account when considering the application.

The application is in effect a hybrid application in that it is seeking to provide:

- facilities for residents of the hotel
- · extended operating hours
- extended hours for the sale of alcohol
- · extended hours for amplified music.

While the provision of restaurant and bar facilities for residents of the hotel would appear to be reasonable, the hours requested seem excessive when compared with many major hotel chains where late night food and drink is generally available through room service.

Extending the operating hours will result in the current disruption to residents' sleep being prolonged, with customers leaving the premises at times of up to 3am, assuming, unlike recently, any new restrictions are observed.

This venue has a history of night time nuisance, dating back to at least September 2012, prior to the previous operator, a time when the applicant was managing the premises. The police have had to attend on a number of occasions.

The legislation banning smoking has also had an adverse impact on local residents as customers exit to the front and rear of the building to smoke. Inevitably this generates noise as customers laugh and talk, often with their drinks in hand and

doors propped open enabling amplified music to be heard a considerable distance away. Under the revised permitted hours requested in the application this would place an intolerable burden on local residents disrupting their sleep especially on schooldays for the estimated 50 children who reside within a couple of hundred metres of the site.

While parking is not a matter for consideration under the Licensing Act, the hotel currently has very limited parking facilities with only six spaces for residents and staff. The service road fronting the venue is in large part subject to restricted parking provision for police vehicles only and, in consequence many hotel guests and those attending venue events, use the Council's carpark situated behind Grange Court. It can be assumed that late night visitors to the bar and restaurant facilities will do the same.

The most direct pedestrian access to this car park from Dil Se is via one of two footpaths, one located between Sherbourne House and 27 Northolt Road, the other situated between 27 Northolt Road and Grange Court. Customers leaving the venue late at night will inevitable generate noise as they return to their vehicles and drive away. This will have a particular adverse impact on those older people residing in the Council-owned Alma & Grange Courts (housing with support for the over 60s).

The enclose petition includes signatories on behalf of the local supported housing whose residents are frequently inconvenienced by patrons of the Dil Se parking in, or blocking, their parking spaces along with the excessive noise as revellers arrange their journeys home.

There will also be an increase in noise to the front of the venue as some customers leave by taxi or minicab.

Allowing the extension of hours, particularly at the weekend, will mean that the licensing hours for the venue will be out of kilter with the vast majority of local public houses. This will inevitably lead to the Dil Se becoming the late night drinking venue of choice for the wider area, with late night drinkers adjourning to the Dil Se after other licensed premises close. Indeed, late nigh drinkers could be attracted from neighbouring boroughs.

There appears to be no consideration by the applicant as to the requirements of the Licensing Act 2003 to protect children from harm with the exception of the three points listed in Section (e), Annexture 1 of Premises Licence No LN/000005974/2014/4. There is no provision to require young children to vacate the bar at a reasonable hour. Should the Panel agreed the amended hours applied for in this application, non-resident children could remain in the bar until the early hours of the morning, even during term time.

In summary, I believe that the extension of licensing hours applied for are excessive and will exacerbate the existing nuisance and generate a further reduction in the living and working amenity of the area.

  A record shall be kept of all complaints relating to noise or nuisance and incidents or crime and disorder taking place on or in the immediate vicinity of the Premises, which shall be available for inspection by the Licensing Authority and the Police at all times when the Premises are open.

#### Protecting children from harm

16. [Proposed by the Licensing Authority and accepted by the applicant]
The Premises Licence Holder will ensure that the premises has a documented and recorded policy in relation to child safeguarding by ensuring staff are aware of the Metropolitan Police's Operation Makesafe; displaying appropriate literature in the premises; and being aware of how to report any possible concerns.
