Section 2 – Report

- 2.1 An application has been received from Harrow Trading Standards to review the premises licence of Good Morning Superstore, 262 Streatfield Road, Harrow, Middlesex HA3 9BY (appendix 1).
- 2.2 <u>Description of premises</u>

The premises are a small, typical local convenience store serving a range of goods including age-restricted products such as tobacco, alcohol and lottery tickets situated on the Streatfield Road shopping parade.

2.3 <u>Licensing history</u>

A premises licence was first granted on 21/02/2007. It was transferred to new premises licence holders in 2010, 2013 and 2014.

The licence was transferred to the current licence holder, Mr Amrik Singh Arora, on 24/09/2014 (appendix 2). A location map is also provided at appendix 3. The Panel will note that the premises licence is issued to Premier, trading at the same address although the review application names Good Morning Superstore Ltd. The premises are currently trading as Good Morning Superstore Ltd with Mr Arora named as the premises licence holder. There is no requirement for the licensing authority to be notified of a change in name of the premises.

- 2.4 <u>Designated premises supervisor (DPS)</u> Mr Amrik Singh Arora has been the DPS since 24/09/2014.
- 2.5 The panel might wish to note that the previous premises licence holder and designated premises supervisor, Mrs Rajeswary Tharmaseelan, is still employed at the shop.
- 2.6 <u>Details of the application</u> Received: 26/09/2015 Application advertised: 26/09/2016 – 24/10/2016

In addition to Trading Standards serving a copy of the review application on the premises licence holder, the licensing authority delivered a letter by hand to the premises advising him of the application on 27/09/16. The licensing authority wrote to the premises licence holder on 10/10/16 advising him of the hearing.

2.7 <u>Representations</u> No other representations have been received.

2.8 Officers' observations

The review application refers to paragraph 11.27 of the statutory guidance. The full section of that part of the guidance is set out below:

Reviews arising in connection with crime

11.24 A number of reviews may arise in connection with crime that is not directly connected with licensable activities. For example, reviews may arise because of drugs problems at the premises; money laundering by criminal gangs, the sale of contraband or stolen goods, the sale of firearms, or the sexual exploitation of children. Licensing authorities do not have the power to judge the criminality or otherwise of any issue. This is a matter for the courts. The licensing authority's role when determining such a review is not therefore to establish the guilt or innocence of any individual but to ensure the promotion of the crime prevention objective.

11.25 Reviews are part of the regulatory process introduced by the 2003 Act and they are not part of criminal law and procedure. There is, therefore, no reason why representations giving rise to a review of a premises licence need be delayed pending the outcome of any criminal proceedings. Some reviews will arise after the conviction in the criminal courts of certain individuals, but not all. In any case, it is for the licensing authority to determine whether the problems associated with the alleged crimes are taking place on the premises and affecting the promotion of the licensing objectives. Where a review follows a conviction, it would also not be for the licensing authority to attempt to go beyond any finding by the courts, which should be treated as a matter of undisputed evidence before them.

11.26 Where the licensing authority is conducting a review on the grounds that the premises have been used for criminal purposes, its role is solely to determine what steps should be taken in connection with the premises licence, for the promotion of the crime prevention objective. It is important to recognise that certain criminal activity or associated problems may be taking place or have taken place despite the best efforts of the licence holder and the staff working at the premises and despite full compliance with the conditions attached to the licence. In such circumstances, the licensing authority is still empowered to take any appropriate steps to remedy the problems. The licensing authority's duty is to take steps with a view to the promotion of the licensing objectives in the interests of the wider community and not those of the individual licence holder.

11.27 There is certain criminal activity that may arise in connection with licensed premises which should be treated particularly seriously. These are the use of the licensed premises:

- for the sale and distribution of drugs controlled under the Misuse of Drugs Act 1971 and the laundering of the proceeds of drugs crime;
- for the sale and distribution of illegal firearms;
- for the evasion of copyright in respect of pirated or unlicensed films and music, which does considerable damage to the industries affected;
- for prostitution or the sale of unlawful pornography;
- by organised groups of paedophiles to groom children;
- as the base for the organisation of criminal activity, particularly by gangs;
- for the organisation of racist activity or the promotion of racist attacks;
- for knowingly employing a person who is unlawfully in the UK or who cannot lawfully be employed as a result of a condition on that person's leave to enter;
- for unlawful gambling; and
- for the sale or storage of smuggled tobacco and alcohol.

11.28 It is envisaged that licensing authorities, the police and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence – even in the first instance – should be seriously considered.

2.9 In addition, paragraph 11.17 of the statutory guidance (Powers of a licensing authority on the determination of a review) states:

11.17 The licensing authority may decide that the review does not require it to take any further steps appropriate to promote the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular period of time. It is expected that licensing authorities will regard such informal warnings as an important mechanism for ensuring that the licensing objectives are effectively promoted and that warnings should be issued in writing to the licence holder.

2.10 Licensing policy

There are no implications in relation to the statement of licensing policy arising from this application.

2.11 Legal implications

The Licensing Authority is required to hold a hearing to consider the review application and any relevant representations made. The hearing must be held in accordance with the Licensing Act 2003 (Hearings) Regulations 2005.

- 2.12 The Licensing Panel is required to give appropriate weight to the review application, representations (including supporting information) presented by all the parties, the Guidance issued pursuant to section 182 of the Licensing Act 2003, the Council's statement of licensing policy and the steps (if any) that are appropriate to promote the four licensing objectives.
- 2.13 Having considered those relevant matters, the Licensing Panel can take such of the following steps (if any) as it considers appropriate for the promotion of the licensing objectives
 - 1. to modify the conditions of the licence;
 - 2. to exclude the licensable activity from the scope of the licence;
 - 3. to remove the designated premises supervisor;
 - 4. to suspend the licence for a period not exceeding 3 months;
 - 5. to revoke the licence

and for this purpose the conditions of the licence are modified if any of them are altered or omitted or any new condition added.

2.14 If the Panel takes a step mentioned in 1 or 2 of paragraph 2.13 above, it can specify that the modification or exclusion is to have effect for a period up to three months if it considers this to be appropriate.

2.15 It should be noted that -

- clear reasons must be given for the decision;
- any additional or modified conditions should be practical and enforceable;
- the applicant for the review, the premises licence holder and any person who made relevant representations would have the right of appeal to a magistrates' court on one of the grounds provided in schedule 5 to the Licensing Act 2003.
- 2.16 In addition to determining the application in accordance with the legislation, Members must have regard to the
 - common law rules of natural justice (i.e. ensuring a fair and unbiased hearing etc);
 - provisions of the Human Rights Act 1998;
 - considerations in section 17 of the Crime and Disorder Act 1998.
- 2.17 The Panel must also act appropriately with regard to the European Convention for the Protection of Human Rights and Fundamental Freedoms implemented under the Human Rights Act 1998, particularly articles 6 (relating to the right to a fair trial); article 8 (protection of private and family life); and article 1 of the First Protocol (protection of property).
- 2.18 The Panel, when exercising its powers, must consider section 17 of the Crime and Disorder Act 1998 which states:

'without prejudice to any other obligation imposed on it, it shall be the duty of each authority to which this section applies to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.'

Financial Implications

2.19 There are no financial implications.

Appeals

2.20 If any party is aggrieved with the decision of the licensing panel on one of the grounds set out in schedule 5 to the Licensing Act 2003, they can appeal to a Magistrates' Court within 21 days from notification of the decision.

Mr Arora is the Company Director of Good Morning Superstore Ltd. We believe the business is failing to promote two of the licensing objectives, namely the prevention of crime and disorder and public safety.

The business's current licensable activity is the sale of retail alcohol.

On 16th April 2015, as part of a routine inspection, Trading Standards officers and Her Majesty Revenue and Customs (HMRC) visited Good Morning Superstore Ltd at 262 Streatfield Road, Harrow, HA3 9BY. Whilst there the HMRC officers seized 564 litres of beer, 270 litres of wine and 13.7 litres of spirits, which the business could not prove they have paid any duty on. The Trading Standards officers confiscated tobacco products which consisted of 33 packets of cigarettes, 5 packets of smoking tobacco and 104 packets of chewing tobacco which did not display the correct statutory health warnings on them as required by the Tobacco Products (Manufacture, Presentation, and Sale) (Safety) Regulations 2002. These Regulations make it an offence for tobacco products to not have the health warnings in the correct format and this wording must be in english. All these products were in possession for sale to members of the public. None of the tobacco products seized had english labelling on them and were therefore not made for the UK market. We therefore believe due to the quantity of items found that these products have been smuggled illegally into the country to be sold on in UK shops. (See attached documents 1 & 2)

Mr Arora was interviewed under caution on the 11th May 2016 and stated that he purchased the products from a man who came into his shop selling these products and had no contact details for him. Mr Arora stated that three months prior to this, he had purchased the alcohol seized by HMRC from a different man. He also admitted he had the tobacco products as he knew it was wrong to sell them.

London Borough of Harrow Trading Standards Service, laid two informations at Willesden Magistrates Court with regards to the illicit tobacco seized from the company. One of the charges was for 38 smoking tobacco products and the other charge was for 104 chewing tobacco products failing to comply with the above Regulations. These charges were heard on the 3/11/15. Mr Arora, pleaded guilty on behalf of the company to these charges. The company was fined £200 and ordered to pay fines of £1021. (See attached documents 3)

On 24th February 2016, another joint inspection was carried out, with Trading Standards and HMRC officers at . Officers found a further 2386 litres of various brand/strength beer which the business could not prove they paid duty on. Ken Buzor, Fraud investigation Officer for HMRC, seized the alcohol as Mr Arora failed to give him any proof that duty had been paid on the alcohol. Mr Buzor has stated in his statement that the loss of revenue for the seized goods amounts to £2,654.42 Excise Duty, plus £817.26 VAT. (See attached document 4)

Good Morning Superstore Limited was also in possession of tobacco products, namely 13 packets of cigarettes,12 pouches of chewing tobacco which failed to display the correct statutory health warnings on them as the labelling was not in english. Trading Standards Officers have supplied statements, detailing the seizures and including photographs of the tobacco products. The illicit alcohol and tobacco were seized and removed from the premises by the officers. Once again none of the tobacco products seized had english labelling on them and were therefore not made for the UK market. We therefore believe that these products have been smuggled illegally into the country to be sold on in UK shops. (See attached document 5)

Mr Arora was interviewed under caution on 31/3/16 and gave a no comment interview to all questions including where he had obtained the products from. This Service wishes to remind the panel that they should draw their own inferences from this 'No Comment' interview.

Companies House records also show that they wrote to the company on the 5/7/16 given them notice that the company will be struck off the register and the company dissolved, two months from the 5/7/16. This is because it has failed to file any accounts with them. (See attached document 6).

It is in my professional opinion, the smuggled alcohol and tobacco products were in possession for sale and therefore this matter should be treated particularly seriously as per the guidance in paragraph 11.27 of the Home Office publication 'Amended Guidance Issued Under Section 182 of the Licensing Act 2003'.

Mr Arora the company director, holds a personal licence as he is the designated premise supervisor number Hounslow H03056.Good Morning Superstore Limited is very much aware of the law and has been prosecuted before.

The products were not labelled in english and therefore not made for the UK market. Tobacco products are highly regulated as to the amount of harmful chemicals in the products. This amount varies from country to country, and therefore undermines the public safety objective.

This Service is of the opinion that the appropriate and propionate response to this continued flouting of the laws is revocation of the licence. Please provide as much information as possible to support the application (please read guidance note 3)

I am employed by the London Boroughs of Brent and Harrow Trading Standards Service as a Senior Enforcement Officer. I am authorised to enforce various statutes including the Consumer Protection Act 1987 and the Consumer Protection from Unfair Trading Regulations 2008.

On 16th April 2015, whilst working in partnership with HM Revenue & Customs, HMRC officers along with my a colleagues Paul HAYWARD and Amar KARIA both with the London Boroughs of Brent and Harrow Trading Standards Service, to check for compliance of tobacco and alcohol being sold within the borough. At approximately 10 11:35am we entered Premiere Express, Euro Superstore situated at 262 Streatfield Road, Harrow, HA3 9BY. At the front of the shop to the left as we entered was displayed salt products by the Amazing Himalayan Salt Company. Mr HAYWARD informed me that he has had previous dealings with the company, however, he was not aware of them trading from this premises and he would like to speak with them. I, Ken Buzor, Fraud Investigation Officer of Her Majesty's Revenue & Customs, (HMRC) based at Custom House, 20 Lower Thames Street, London EC3R 6EE, WILL SAY as follows:

- On 24th February 2016, accompanied by other Officers of HMRC and Officers of Harrow Trading Standards, I attended GOOD MORNING SUPERSTORE, 262 Stratfield Road, Harrow HA3 9BY under the authority of section 112 of the Customs & Excise Management Act 1979 (CEMA). I entered the premises at 09:50 hours.
- The shop sales assistant, who identified himself to me as MR , was present throughout the visit. I introduced myself to MR and explained that the purpose of the visit was to conduct an inspection of tobacco and alcohol products in the shop.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children–

(a)games or other activities which require or encourage, or are designed to require or encourage, individuals to-

(i)drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii)drink as much alcohol as possible (whether within a time limit or otherwise);

(b)provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act); (c)provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less:

(d)provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-

(i) the outcome of a race, competition or other event or process, or

(ii) the likelihood of anything occurring or not occurring;

(e)selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

4.—(1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

5. The responsible person shall ensure that-

(a)where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

(i)beer or cider: ¹/₂ pint;

(ii)gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii)still wine in a glass: 125 ml

(b)customers are made aware of the availability of these measures.

Mandatory Condition order 2014

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purposes of the condition set out in paragraph 1-

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979(a);

(b) "permitted price" is the price found by applying the formula P D (DxV)

P D where—

(i) P is the permitted price,

(ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence— (i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a

club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994(b).

Mandatory conditions where licence authorises exhibition of films:

(1) The admission of persons under the age of 18 years to exhibitions of films must be restricted in accordance with any recommendation made by the British Board of Film Classification, except where condition 2 applies.

(2) The admission of persons under the age of 18 years to exhibitions of films must be restricted in accordance with any recommendation made by the relevant licensing authority regarding the film in question

Annex 2 - Conditions consistent with the operating Schedule

CONDITION 1: THE CCTV SYSTEM TO BE MAINTAINED AND OPERATED IN GOOD ORDER AND TO THE SATISFACTION OF MET POLICE CRIME PREVENTION OFFICER'S REASONABLE REQUESTS. THE MEDIUM UPON WHICH THE IMAGES ARE RECORDED WILL BE CLEARLY IDENTIFIABLE, STORED SECURELY, RETAINED FOR A PERIOD OF NOT LESS THAN 31 DAYS, AND IT WILL BE MADE AVAILABLE TO COUNCIL AND POLICE OFFICERS ON REQUEST.

CONDITION 2: THE PREMISES WILL ONLY ACCEPT ANY TRADE DELIVERIES OR RUBBISH COLLECTIONS DURING NORMAL WORKING HOURS.

CONDITION 3: THE DPS SHALL ENSURE THAT THE EXTERIOR OF THE PREMISES IS CLEAR OF LITTER.

CONDITION 4: THE PREMISES SHALL OPERATE A "CHALLENGE 21" POLICY FOR SALE OF ALCOHOL.

CONDITION 5: THE PREMISES WILL KEEP A REFUSAL REGISTER, ALL REFUSALS BY ANY MEMBER OF STAFF OR THE DPS WILL BE RECORDED. THE REGISTER WILL BE KEPT ON THE PREMISES FOR A MINIMUM OF 24 MONTHS AND MADE AVAILABLE ON REQUEST TO THE POLICE, LOCAL AUTHORITY LICENSING OFFICER & TRADING STANDARDS OFFICERS.


