RESOLVED: That, having taken into account the following,

- Written and any oral representations by all the parties. This included the viewing of a video titled 'Spice Rack Customers' that was a late submission by representatives of Elm Park Residents' Association. The video purported to show the behaviour of individuals and the disturbance being caused to residents of Elm Park, which the applicant's representative did not object to but considered to be irrelevant to the application. The Panel agreed the video was not relevant as it purported to relate to customers of other premises;

Summary of applicable mandatory conditions:

- 1. No alcohol to be sold unless under the supervision of a designated premises supervisor who holds a premises licence.
- 2. Requirement for any door supervisors to be licensed by the Security Industry Authority.
- 3. Mandatory conditions prohibiting irresponsible alcohol sales, requiring free potable water and requiring premises to have proof-of-age policy.

Existing conditions:

Conditions consistent with Operating Schedule None.

Conditions attached after a previous hearing by the licensing authority.

- 1. Maximum number of patrons accommodated at any time should not exceed 150**;
- 2. Only food refuse to be place in the external refuse bins after 9 pm and all other rubbish is to be dealt with next morning;
- 3. Prominent, clear and legible notices to be displayed at all exits requesting the patrons to respect the needs of local residents and to leave the premises and the area quietly.

** = The condition relating to the capacity limit was deleted as this was now dealt with under different provisions.

ADDITIONAL CONDITIONS:

Prevention of public nuisance

- 1. The Premises Licence Holder shall ensure that notices were displayed at each exit from the premises reminding patrons to leave quietly and to respect nearby residents;
- 2. The Premises Licence Holder shall ensure that staff were pro-active in informing customers to leave quietly, such as through the use of announcements by DJs and door supervisors;
- 3. The Premises Licence Holder shall take all reasonable steps including the use of notices, and conditions on contracts for the hire and use of the premises, to encourage patrons to park or to be collected by taxi/private hire vehicle from the car park at the rear of the premises;

Public Safety

4. On Days (Friday and Saturday nights) where a part booking was taken beyond 0100, SIA registered staff would be employed at a ratio of 1:100.

REASONS:

The Panel considered that the decision promoted all the licensing objectives and that the measures taken above were appropriate and proportionate in the circumstances to promote all the licensing objectives.

Additional Matters: The Panel noted that during the meeting, the Applicant offered to meet with the Objectors if they ever considered there was any issue with the Premises and therefore, whilst not part of this decision, the Panel hoped that if there was ever such an issue the parties would meet to discuss the same.

Right to appeal

Any party aggrieved with the decision of the Licensing Panel on one or more of the grounds set out in Schedule 5 to the Licensing Act 2003 may appeal to the Magistrates' Court within 21 days of notification of this decision.
