#### 8. National updates

• 2021 Census data (previously circulated: David reported that the census data reflects broad trends but no major differences from the 2011 Census apart from a significant growth in the Muslim population. At the moment, Harrow SACRE has only one Muslim representative in group A although Fatima is also well qualified to represent Islam in addition to being a teacher representative. She will make an approach to the Islamic school with a view to appointing another Muslim representative.

National developments in Education since the last ASC
Lisa gave a very clear account of national developments in education
since the last ASC. The overall picture conveys a shortage of RE
teachers, lack of training (the government has missed its recruitment
target for 9 out of 10 years), insufficient allocation of time and lack of
funding. Despite this, parental regard for RE remains high.
We hope that the launch of the updated AS will stimulate greater
interest in RE and professional development and that in Harrow at
least, some of these issues can be addressed in order to create a more
positive scenario than the national situation.

# 9. News from Faith Groups relating to schools

- **Jain:** Varsha has represented Jainism at a Junior Assembly at Longfield.
- Judaism: the Mosaic Jewish Community building is now open on Stanmore Hill and in the early stages of making a home in the wider community of Stanmore. It houses three denominations, Liberal, Masorti and Reform and has a Community Development Rabbi, who is organising visits into the building and into schools.
- **Hinduism:** Swaminarayan parents have been requesting special leave of absence to attend an important celebration from Tuesday 18 – Wednesday 26 April celebrating 200 years of Shree Narnarayandev; these requests have met with a mixed response from head teachers. Alison explained that although head teachers were asked to look sympathetically on such requests in the Days of Religious Observance Guidance, this document is for guidance only and the ultimate decision is down to each head teacher.
- **Resources for Schools:** at the last meeting, members discussed compiling a list of resources for schools which would include places of worship that can be visited (or museums containing objects of religious interest), both locally and nationally; names of local contacts could be included where known. Heena again put in a plea for such a list. Alison asked the faith representatives and the C of E representatives to send their suggestions to her and she would collate the list.

#### 1. Feedback from RE Teachers Network meeting

Alison reported back from the RE Teachers network meeting in January. Teachers had compared the Harrow ASC with the Hounslow syllabus: Lesley has advised that it is possible to draw on this with proper attribution. Teachers commented on the syllabus. Alison thanked David for attending this meeting.

For the next part of the meeting, the committee was divided into break-out rooms:

- Break-out room 1: teacher representatives and C of E representatives; Look at the aims.
- Break-out room 2: faith representatives and councillors. Look at the faith descriptions in the "Religions and Worldviews" section and update in the light of the new Census information.

#### 2. Report Back

Mary reported back from Room 1. Lisa highlighted the discussion to refine the aims and update the focus on learning about and learning. The group discussed wording to replace 'tolerance' and to use 'critically' instead of 'seriously'. Mary will send revised wording to Alison.

#### Action: Mary

Alison reported back from Room 2. She explained changes required for page 4 'Religion in Harrow'. Lisa explained how some language has changed since the last syllabus, for instance "sacred texts" has replaced "special texts". Members fully supported this change. There was a discussion regarding the naming of the Dharmic religions and the use of the phrase 'worldview traditions'. There was some ambivalence about whether the syllabus should open with the aims and statutory requirements instead of with the faith descriptions as in the previous syllabus. Members like the present opening which gives such a positive portrayal of Harrow's diversity; on the other hand, they were willing to adopt the change if this made the syllabus more accessible to teachers' requirements. Alison and Lisa are meeting on 27 March: they will make a decision about the order of the syllabus and incorporate the revisions that have been agreed. Members should email any suggestions to Alison by 20<sup>th</sup> March.
