## **Section 1 – Summary**

An application for a new premises licence under Section 17 of the Licensing Act 2003 (the "Act") has been received for IZZY FOOD CENTRE, 380 Kenton Road, Harrow, HA3 8DP.

Representations have been received from other persons including bodies representing local residents.

The representations express concerns about the possible undermining of one or more of the licensing objectives should the licence be granted.

## **Section 2 - Report**

- 2.1 This report asks the Sub-Committee to consider an application for a new premises licence.
- 2.2 C.B. Market Ltd (the "**Applicant**") submitted an application on 14 December 2023 for a new premises licence for IZZY FOOD CENTRE, 380 Kenton Road, Harrow, HA3 8DP (the "**Premises**"). A copy of the application is included as Appendix 1 to this report.
- 2.3 The period for representations for this application was from 20 December 2023 to 17 January 2024, As representations remain unresolved a hearing is required for the application to be considered by the Sub-Committee.
- 2.4 The applicant has applied for the following hours open to the public and licensable activities:

<sup>\*</sup>The applicant has applied to trade and sell alcohol for consumption off the premises for 24 hours a day 7 days a week. The application includes proposed conditions.

2.5 The application proposes Mr Claudiu Baroti, to be the Designated Premises Supervisor.

### Description of premises

2.6 Currently the Premises is under refurbishment and closed to the public. In the relevant section of the application, The Applicant describes the Premises as the following

"The premises will be used for the retail of Food and Drinks, hence an application is being made as we are planning to sell drinks for personal/at home consumption. We will not be offering a place for the consumption of these supplies."

The Licensing Authority understands the Premises will be a grocery store that includes the sale of fresh fruit, vegetables; and alcohol should a premises licence be granted.

2.7 A location map for the Premises is shown in Appendix 2.

### Representations

- 2.8 During the consultation period the Licensing Authority received 42 representations, with 41 of these objecting to the application and 1 in support.
- 2.9 The objections have been received from:
  - The London Assembly Member for Brent and Harrow
  - o 4 Councillors, including the 3 Ward Councillors for Kenton East
  - o 36 residents

The representation in support was received from a resident.

- 2.10 The representations objecting to the application reflect concerns with the upholding of all four of the licencing objectives, namely the prevention of crime and disorder, public safety, the prevention of public nuisance and the protection of children from harm. All the representations received are shown in Appendix 3 of this report. These representations remain outstanding these can be found in Appendix 3.
- 2.11 The Police have not submitted a formal representation but did agree conditions with the Applicant, which are shown in Appendix 4 to this report.
- 2.12 The Licensing Authority has advised of the possible ambiguity of these conditions and advised of amendments to these conditions, to further underpin the licensing objectives. These amendments have been agreed by the Applicant and the Police have also been informed of the amendments to the agreed conditions and they have not commented. The amendments to the conditions agreed between the Applicant and the Licensing Authority, are also shown in Appendix 4 of this report.
- 2.13 The Agent representing the Applicant has also sent an email, which includes crime statistics of the area and that can be found in Appendix 5 to this report.
- 2.14 Where a relevant representation is submitted under Section 35(3) of the Act the Authority must hold a hearing to consider such representations, unless the authority, the applicant and each person who has made such representations agree that a hearing is unnecessary.
- 2.15 Relevant representations mean those which are about the likely effect of the grant of the application on the promotion of the licensing objectives, and have been made in time, not withdrawn, and in the case of

representations made by a person (other than a responsible authority), are not considered by the Licensing Authority to be frivolous or vexatious.

### Officer Observations

- 2.16 Representations that have been received are mainly based on concerns with the upholding of the core licencing objectives, particularly with regard to street drinking, the potential for further crime and disorder, the potential for noise nuisance, litter and the proximity of the Premises to nearby schools as well as a general objection to a 24/7 alcohol licence. The received representations provide more details on this. The representations also raise other issues, such as traffic and other retailers selling alcohol, which are not relevant issues for the Sub-committee to consider.
- 2.17 Consideration should be given on how these issues could directly affect the licensing objectives.
- 2.18 The most critical part of the operating schedule are the steps proposed by the Applicant to promote the licensing objectives. Applicants are always reminded to take careful consideration as to what is entered in this section as whatever is proposed will be transferred into conditions on the licence
- 2.19 The Sub-Committee has the discretion to add or modify conditions in light of the representations where it is appropriate to do so to promote the licensing objectives. Any such conditions should be tailored to the size, type, location, characteristics and activities at the premises, and the Panel should be aware of any indirect costs that may arise from the imposition of conditions.
- 2.20 When imposing conditions relating to CCTV the Sub-Committee should bear in mind the Information Commissioner's guidance that such conditions should only be imposed where it is justified to do so and in order to meet the licensing objectives.

2.21 The Sub- committee's attention is drawn to section 2 of the current statutory guidance which refers to the licensing objectives: Revised guidance issued under section 182 of Licensing Act 2003 - GOV.UK (www.gov.uk)

### Harrow licensing Policy

2.22 The Licensing Authority's Statement of Licensing Policy sets out the matters that the Sub-committee may take into account when considering representations (although the Sub-committee is not limited to these matters).

### 3. Recommendation

- 3.1 The Licensing Sub- committee is required by the Act to take one of the options listed below as it considered appropriate for the promotion of the licensing objectives.
- 3.2 The steps are—
  - (a) To grant the licence subject to—
    - (i) conditions that are consistent with the operating schedule accompanying the application modified to such extent as the authority considers appropriate for the promotion of the licensing objectives, and
    - (ii) any condition which must under section 19, 20 or 21 of the Licensing Act 2003 be included in the licence;
  - (b) to exclude from the scope of the licence any of the licensable activities to which the application relates.
  - (c) to refuse to specify a person in the licence as the premises supervisor;
  - (d) to reject the application.

### 4. Legal implications

- 4.1 The Licensing Sub-Committee is required to hold a hearing to consider any relevant representations made in relation to a premises licence application unless all parties agree that a hearing is unnecessary. The hearing must be held in accordance with the Licensing Act 2003 (Hearings) Regulations 2005.
- 4.2 Under Part 3A of the Council's Constitution (18 May 2023), the Licensing Panel has the power to determine applications and to make Orders in respect of licences where objections have been received.
- 4.3 The Licensing Panel is required to give appropriate weight to the representations (including supporting information) presented by all the parties, the Guidance issued pursuant to section 182 of the Act, the Council's Statement of Licensing Policy 2022 and the steps that are appropriate to promote the four licensing objectives.
- 4.4 Having considered those relevant matters, the Licensing Panel is required to take such steps (as outlined in section 3.2) as it considers appropriate for the promotion of the licensing objectives.
- 4.5 It should be noted with all options that
  - clear reasons should be given for the decision.
  - any additional or modified conditions should be clear, practical and enforceable.
- 4.6 In addition to determining the application in accordance with the legislation, Members must have regard to the
  - common law rules of natural justice

- provisions of the Human Rights Act 1998
- considerations in section 17 of the Crime and Disorder Act 1998
- 4.7 By section 6 of the Human Rights Act 1998, the licensing Sub-committee is required to act in a way that is compatible with rights under the European Convention for the Protection of Human Rights. The following provisions of the European convention seem relevant: Article 6 (right to a fair trial) Article 14 (prohibition of discrimination) and Article 1 of the First Protocol (protection of property)
- 4.8 If any party wishes to challenge the decision of the Licensing Subcommittee on one of the grounds set out in Schedule 5 to the Act, they can appeal to a Magistrates' Court within 21 days from notification of the decision.

### 5 Financial Implications

5.1 There are no financial implications, other than a small fee income if the new licence is granted.

Strong management controls and effective training of all staff so that they are aware of the premises licence and the requirements to meet the four licensing objectives with particular attention to:

- a) no selling of alcohol to underage people
- b)no drunk and disorderly behavior allowed on the premises area
- c) no violent and anti-social behaviour allowed on the premises area.
- Designated premises supervisor confirmed it is obligated to be in day-to-day control of the premises, to provide good training for staff on the Licensing Act (Training Record), to make or authorize each sale
- Clear "Challenge 25" information to prevent the supply of alcohol to under-age drinkers.
- Roller metal exterior window shutter will be fixed to ensure that shop front is safe and secure at all times

As a licensed premises we know that it is necessary to carry out our functions or operate their businesses with a purpose of promoting these objectives. We promise to support these objectives through their operating schedules and other measures (including staff training and qualifications, policies).

### b) The prevention of crime and disorder

A clear and legible notice outside the premises indicating the normal hours under the terms of the premises licence during which licensable activities are permitted.

Clear and conspicuous notices warning of potential criminal activity, such as theft, that may target customers will be displayed.

Not selling of alcohol to drunk or intoxicated customers.

Prevention and vigilance in illegal drug use at the retail unit area.

Staff will be well trained in asking customers to use premises in an orderly and respectful manner and prevent drinking alcohol at the retail unit (ex. canned or bottled beer).

### c) Public safety

Well trained staff adherence to environmental health requirements.

Training and implementation of underage ID checks.

A log book or recording system shall be kept upon the premises in which shall be entered particulars of inspections made; those required to be made by statute, and information compiled to comply with any public safety condition attached to the premises licence that requires the recording of such information. The log book shall be kept available for inspection when required by persons authorised by the Licensing Act 2003 or associated legislation.

All parts of the premises and all fittings and apparatus therein, door fastenings and notices, lighting, heating, electrical, air condition, sanitary accommodation and other installations, will be maintained at all times in good order and in a safe condition.

### d) The prevention of public nuisance

Prominent, clear and legible notices will be displayed at all exits requesting the public to respect the needs of nearby residents and to leave the premises and the area quietly.

Deliveries of materials necessary for the operation of the business will be carried out at such a time or in such a manner as to prevent nuisance and disturbance to nearby residents.

The Licensee will ensure that staff who arrive early morning or depart late at night (ex. for unpacking, pricing newly delivered goods) when the business has ceased trading conduct themselves in such a manner to avoid causing disturbance

to nearby residents.

Customers will be asked not to stand around loudly talking in the street outside the premises.

Customers will not be admitted to premises above opening hours.

The movement of bins and rubbish outside the premises will be kept to a minimum after 11.00pm. This will help to reduce the levels of noise produced by the premises.

Any lighting on or outside the premises will be positioned and screened in such a way so as to not cause a disturbance to nearby residents.

### e) The protection of children from harm

"Challenge 25" sign which is a retailing strategy that encourages anyone who is over 18 but looks under 25 to carry acceptable ID (a card bearing the PASS hologram, a photographic driving license or a passport) if they wish to buy alcohol.

### NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

# Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office on line right to work checking service (see below).

- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the
  holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their
  stay in the UK.
- A current passport endorsed to show that the holder is exempt from immigration control, is allowed to stay

- A current Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland when produced in
  combination with an official document giving the person's permanent National Insurance number and their
  name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an
  official document giving the person's permanent National Insurance number and their name issued by a
  Government agency or a previous employer.

- A current passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to
  work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a
  licensable activity.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A current Residence Card issued by the Home Office to a person who is not a national of a European Economic
  Area state or Switzerland but who is a family member of such a national or who has derivative rights or
  residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder
  with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not
  subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity
  when produced in combination with an official document giving the person's permanent National Insurance
  number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, less than 6 months old, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK
  with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or
  reasonable evidence that the person has an appeal or administrative review pending on an immigration
  decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but
  who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in
  the UK including:-
  - evidence of the applicant's own identity such as a passport,
  - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
  - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
    - (i) working e.g. employment contract, wage slips, letter from the employer,
    - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
    - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
    - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

**Original documents must not be sent to licensing authorities. If** the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

### Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office on line right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <a href="https://www.gov.uk/prove-right-to-work">https://www.gov.uk/prove-right-to-work</a>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. - Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
  - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
  - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the
  audience does not exceed 500. However, a performance which amounts to adult entertainment remains
  licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
  - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
  - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
  - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
  - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.







I am writing to object to the application that has been made by C.B Market Ltd for the Premises known as Izzy Food Centre, 380 Kenton Road, Kenton, Harrow, Middlesex, HA3 8DP.

Firstly I would like to highlight that as disappointed as I am with the conversion of the class of use that is being made to this building highly impacting the local vicinity especially with the proposed hours it is shocking that they have applied for an 24/7 alcohol Licence.

Currently the vicinity of 380 Kenton Road and Kenton Park Parade is riddled with a number of Anti social issue relating to loitering, alcohol and drug abuse as well as littering the local authority no longer has the budget to clean up this area resulting in Local residents having to pick up and clean up after these people, if anything the area should be reviewed for a PSPO and not have an additional pressure placed by allowing an Alcohol sales permit.

We are surrounded by many businesses that already have a licence and are open till late so I do not feel that this will offer any added convenience to local residents, Within 2 - 3 mins walk in either direction from the applicants address you will find shops already serving Alcohol, according to my count four shops and a number of Bars and restaurants.

We are already experiencing a negative impact with Costcutter Located at 408, 412 Kenton Rd, Harrow HA3 9DW the number of people regularly congregating and making noise and leaving litter behind has clearly evident (mainly empty alcohol and food containers and broken alcohol bottles)

The thought of adding another Alcohol Premises Licence will only result in an increase in Crime and Disorder, cause increased Public Nuisance and impact Public Safety due to the issues we already encounter with Broken alcohol bottles and drug paraphernalia and congregation of groups around shops serving alcohol, The drug paraphernalia and broken bottles is directly linked to the sale of cheap alcohol sales this behaviour is not so evident from people leaving the Licenced restaurants in the local vicinity.

Another problem to take into account is the problems already faced in Woodcock park that lies directly across the road from the applicant's site. I'm sure the local park keepers and police will vouch for the number of issues faced in this park relating to

#### **Dear Harrow Licensing Team**

I would like to convey Harrow resident's concerns, in relation to the above application, as relayed to me. Many of the residents note that their concerns, though lodged, are not sure if they are registered.

Quite a few have concerns around the location of an all-day alcohol available location near a large residential area as well as the impact on nearby schools and the Temple goers - one of the largest worship group in Harrow. It is their concern that the license application as it stands is not suitable for the location.

To summarise, the concerns covered by residents are extensive and have been placed into their most likely category under the Licensing objectives that will likely be breached or not met.

#### 1, The prevention of crime and disorder

- a) This premise could potentially lead to spill over continued drinking once the other pubs and premises nearby close for the night.
- b) Increased street drinking can have the effect of higher levels of drink fuelled crime including knife crime.
- c) Police could be overstretched in case there are incidents as there already is a concern of much delayed police response to calls when incidents happen, even at present.

#### 2, Public safety

- a) There is also a lot of empty alcohol container waste nearby (can be misused for fights and for making noise)in the unkempt alleyway and other locations, this can only increase with the additional premises and unrestricted long hours of availability
- b) It is possible that there is a possible increased safety concern due to the increased drinking location wise, where drinking was to continue further away there is less lighting and influence of the license holder to influence unsavoury behaviour.
- c) Potential for public safety being compromised as It is not clear if the premises holds the various planning permission/licences and change overs to be able to use this premises as per their Licensing request.
- d) Potential for compromise of public safety as there is no street or external CCTV in the Vicinity to offer any safety assurance
- e) There is a bus stop just outside the premises and can potentially be used as an outdoor sitting for the alcohol drinkers, especially at night and could add to safety concerns for bus stop users.

#### 3, The prevention of public nuisance

- a) A lot of concern around possible noise due to increased coming and goings and especially at night and late evenings, the noise is amplified due to the quietness.
- b) A recurring concern was of possible increase in social gatherings nearby on street cornerswith the availability of alcohol at all hours, this is already happening and a concern

#### 4, The protection of children from harm

- a) There are schools nearby and there is a potential for children using various ruses including sending an eligible person to get them alcoholic drinks.
- b) Potentially, as the Licensed premises has all day opening hours the named license holder can possibly not be able to supervise effectively 24/7, leading to potential lapses in ensuring the licensing objectives are met at all times regarding protection issues.

Please accept this on behalf of the residents and I would also be seeking to voice these concerns on their or behalf , should any related meeting or forum be held to discuss the Licensing application.



- 7. **Footfall from Temple Worshippers and Nursery:** The specific section attracts significant footfall from worshippers of the nearby temple and the presence of a nursery, including diverse






#### June 2023 - Zero Incidents












