#### 269. Declarations of Interest

##### Agenda Item 8 – Admission to County Schools

## 273. Admission to County Schools

The School Placement Panel was requested to recommend to the Corporate Director of Children and Families that the admission of these pupils to a school where no places existed in the relevant year group be authorised.

Letters from the Executive Headteacher and the Associate Headteacher of Camrose Primary School and the Admissions Secretary of Grange Primary School were made available to the Panel.
