373. Admission to County Schools

In accordance with the Local Government (Access to Information) Act 1985, cases P322 – P492 were admitted late to the agenda to allow the Panel to allocate an appropriate place to the applicants. It was noted that case numbers P326, P333, P334, P335, P338, P342, P345, P346, P348, P353, P358, P359, P361, P362, P366, P378, P380, P383, P387, P390, P397, P398, P400, P408, P411, P412, P414, P417, P421, P423, P424, P427, P435, P437, P439, P440, P443 had been withdrawn as these pupils had been offered school places prior to the meeting.

On 25 September 2013, there were 135 children for whom admissions staff could make no reasonable offer of a school place. The School Placement Panel was requested to recommend to the Corporate Director of Children and Families to authorise the admission of these pupils to a school where no places existed in the relevant year group.

The primary and secondary headteacher representatives expressed concern at having to place pupils in classes that were already exceeding the maximum infant class size of 30. Some schools would be introducing bulge classes in September 2014 to accommodate the additional pupils, however, the panel was of the view that this was too long to wait for a solution. They commented that the current model of placing more pupils into already overcrowded schools was intended to be a short-term solution, but was proving unsustainable due to the high volume of primary school-aged pupils moving into Harrow.

The Admissions representative proposed expanding the list of schools for allocation to include all schools within two miles of the pupil's home. However, the headteacher representatives remarked that this would not have any effect on the overall number of school places currently available in the borough.

The chair remarked that this situation needed to be addressed as a matter of urgency.

RESOLVED: That

- (1) the chair to contact the Portfolio Holder for Children and Schools to discuss the concerns above with her;
- (2) the primary headteacher representative to also discuss the concerns above with fellow primary school headteachers;
- (3) the chair and primary headteacher representative to report back at a future meeting of the Panel.
