objecting to Parking Reviews on St. Andrews Drive, except for implementation of
parking restriction on this Road during School times and Cameras / speed limit / humps
to reduce speed**

We, the Residents of St. Andrews Drive, Stanmore HA7, have received the Belmont Circle Area Parking Review Questionnaire, and note that our Road, St Andrews Drive falls within the agreed Consultation Area.

Although St. Andrews Drive is only for consultation for Belmont Circle Area parking Review, we the following Residents of St. Andrews Drive, Stanmore, have signed a Petition here by objecting to Parking reviews like CPZ's, single/ double lines, Parking Bays or Permits, Pay & Display to be extended and introduced on our Road, EXCEPT for the following restrictions, which we request to be introduced whilst Traffic issues are being considered in our Area. .

Signatures in respect of the Petition from the Residents' (56 Residents) of the following Houses on St. Andrews Drive objecting to the above restrictions are provided in the attached Petition: We, the following Residents (56 Residents) of St. Andrews Drive enclose a signed Petition objecting to Parking reviews like CPZ's, single/ double lines, Parking Bays or Permits, Pay & Display to be extended and introduced on our Road and requesting for the following restrictions, to be introduced on our Road, whilst Traffic issues are being considered in our Area

Other Traffic Issues

1. **Cameras/ speed limits or humps:** The Residents have complained several times to the Councillors making personal visits to have Speed Cameras or speed limits or humps to be introduced on our Road as the cars are by passing the Honey Pot Lane dual carriage and using our road and speeding at high speed. It has become unsafe and dangerous to cross the Road and to come out of the drive on to the Road. Nothing has been done so far and we request this to be implemented.

2. **Parking Restriction on our Road only during School Times:** There are 3 Schools surrounding our Road. The Residents of St. Andrews Drive are unable to park outside their house as the Parking is being taken up by people from other areas coming to drop their children. The Cycle Lane on adjacent Wemborough Road outside the School is used by People from other areas who park their cars on that Road all day to go to the station. Since the cycle Lane near the School on Wemborough Road is taken up by people who park there to go to the Station, all the school parents use our Road to Park outside our houses during school times and we, the Residents request "No parking sign" during School times.

We do not understand the purpose of the Council by Introducing cycle Lane which the cyclists are not able to use and allowing the cars to be parked on the Road instead creating traffic jam.

We the Residents have, therefore signed this Petition (enclosed) for (i) implementation of safety on our Road whilst Traffic reviews are being considered, and strongly request that speed cameras/ speed limits or humps are considered to be placed on our Road as it has become very dangerous due to the high speed with which cars are driven on our Road. This also makes it unsafe and difficult to cross or come out of our Drive on to the main Road, and (ii) for parking restriction only during school times.
