





Canons Park Station Follow Up Parking Review

Public Consultation

IMPORTANT – THIS AFFECTS YOU



What is this about?

In April 2013 controls were introduced in the Canons Park Area to improve parking problems experienced from local development and increased commuter parking around Canons Park station.

Although these measures have largely been successful, the inevitable change in parking behaviour has highlighted further areas where problems have arisen.

As a result the council are now carrying out a follow up review in these areas, as agreed at the Traffic and Road Safety Advisory Panel (TARSAP) in October 2013.

This document forms the first part of the consultation process and will be distributed to all properties within defined areas agreed with ward councillors

The responses received from this consultation will determine which areas may be subject to further investigation and progress to the statutory consultation stage. It is important that you respond to this leaflet with your views so officers are able to clearly identify where problems exist and what measures you would support.

Options being considered

The enclosed plan identifies measures that may directly affect you. These proposals have been developed based on historical site knowledge as well as comments and suggestions received from residents and businesses since the introduction of controls in April 2013. Please refer to the plan contained within this document and consider how the proposals may impact you. The options included will consist of one or more of the below measures:

Do Nothing

Although you may currently experience parking problems, by introducing alternative or additional measures these controls are likely to affect when and how you and your visitors park in the area. When considering the alternative options it is important to consider whether the following options would improve controls in your street.

Permit Bays

Permit bays can provide a compromise between no restrictions and continuous waiting restrictions.

Parking bays are provided in safe locations along restricted sections of carriageway and allow residents and other permit holders (visitors, nurses, businesses) the option to park in the area during the hours of control.

It is important to note that if you do not wish to purchase a permit you are not required to do so, however you will not be able to park in the permit bays during the control times. The annual cost of resident permits are:

- £64.90 for the first vehicle
- £97.30 for second vehicle
- £129.80 for third vehicle
- £162.20 for fourth and any further vehicles

The charge for visitor's permits is £16.20 for a book of 10 permits, with a 50% reduction for senior citizens or those receiving mobility allowances. If you display a Blue Badge, you do not need a permit to park in a bay and for residents who drive an environmentally friendly vehicle permits are free.

Single Yellow Line Controls

Many of the roads surrounding Canons Park station are currently controlled by a continuous single yellow line waiting restriction during the hours of 2-3pm Monday to Friday. Although these controls deter many of the commuters parking throughout the day, it removes all on

street parking during this time including residents, visitors and customers. This may also affect you if you have insufficient off street parking for additional vehicles, visitors, carers or servicing vehicles during the hours of control.

Pay and Display

Pay and Display (P&D) parking is considered at locations where there is a short term parking requirement and an increased turnover of vehicles is desired, most notably in close proximity to shops.

A statement issued by the Leader of the Council on 3rd February 2014 announced that a scheme would be rolled out across the borough offering one 20 min free parking period per day at on street parking locations (not car parks) within Harrow. This would require motorists to enter their vehicle registration into a keypad on the pay and display machine and software/online communication would prevent abuse.

If a driver wants to park for over 20 min then they need to pay for the full period i.e. they don't get the first 20 min free.

Dalkeith Grove & Surrounding Roads Parking Review

Public Consultation

IMPORTANT – THIS AFFECTS YOU



What is this about?

On the 8th October 2013 a petition from residents living on Dalkeith Grove was presented to the Traffic and Road Safety Advisory Panel (TARSAP) highlighting congestion issues on Dalkeith Grove. It stated the problems experienced are:

"At school drop off and pick up times the road is incredibly congested and with cars parked on both sides of the road there is only space for one car to pass down the middle of the road. With cars coming from both directions the road often becomes impassable as most drivers are reluctant to wait and let other cars go. In order to get the traffic moving the cars then resort to driving along the pavements often hooting at pedestrians to move out of their way. This is a daily occurrence on Dalkeith Grove on weekdays and with schoolchildren walking along the pavements this is just a tragic accident waiting to happen."

As a result of the petition and known problems in the area the panel recommended that officers carry out a public consultation to seek the views of residents. This document therefore forms the first part of the consultation process and will be distributed to all properties within the highlighted area on the attached plan.

The responses received from this consultation will determine which areas may progress to the statutory consultation stage. It is important that you respond to this leaflet with your views so officers are able to clearly identify where problems exist and what measures you would support.

Observations and Options to be considered

Dalkeith Grove (Between Du Cros Avenue and Dover Court)

The petition submitted to TARSAP indicated residents felt that the current problems result from long term commuter parking and therefore supported a single yellow line, restricting parking for one hour during the afternoon. It was anticipated that this would prevent commuters to London parking all day, therefore resolving the issues experienced.

Officers have subsequently observed parking habits and vehicle movements during numerous site visits and have found that there is limited commuter parking taking place. Observations showed that vehicles arrive throughout the day and that the road is generally clear before 11am, other than at the peak school period in the morning. The vehicles that arrive after this time tend to come from a variety of different users including resident visitors, school users, day trippers to London and local workers.

It was also noted that outside peak school traffic hours there are no frequent problems with congestion and dangerous driving.

In summary, officers felt that the observed dangerous driving results from parents dropping off and collecting their children at peak school hours, not commuter parking.

Many of these vehicles were observed parking inconsiderately, blocking private accesses and creating long sections of carriageway with no passing places. It is at this time when the congestion and safety issues occur. A single yellow line preventing parking for one hour would therefore not resolve this issue.

Officers proposals include:

- Introduction of short sections of double yellow lines on alternating sides of the carriageway preventing parking on both sides of the carriageway 'At Any Time'. This ensures vehicles will be able to pass at all times reducing the likelihood of congestion.
- Introduction of "School Keep Clear" markings at the pedestrian entrance into NLCS to improve pedestrian visibility.
- Extension of "School Keep Clear" markings opposite the vehicular entrance of NLCS to improve access

An indicative plan of how this may look is enclosed with this document. Please note exact locations of proposed measures are to be finalised during detailed design.

Dalkeith Grove (All), Dovercourt Gardens, Heronslea Drive and Pangbourne Drive All properties located within the consultation boundary will have the opportunity to indicate their support for inclusion within the Stanmore CPZ, Zone H. This option provides a compromise between no restrictions and continuous waiting restrictions.

Parking bays are provided in safe locations along restricted sections of carriageway and allow residents and other permit holders (visitors, nurses, businesses) the option to park in the area during the hours of control. The hours of control for the Stanmore CPZ Zone H are:

Monday to Saturday 10am-11am AND Monday to Saturday 3pm-4pm

It is important to note that if you do not wish to purchase a permit you are not required to do so, however you will not be able to park in the permit bays during the control times. The annual cost of resident permits are:

- £64.90 for the first vehicle
 £129.80 for third vehicle
- £97.30 for second vehicle
- £162.20 for fourth and any further vehicles

The charge for visitor's permits is £16.20 for a book of 10 permits, with a 50% reduction for senior citizens or those receiving mobility allowances. If you display a Blue Badge, you do not need a permit to park in a bay and for residents who drive an environmentally friendly vehicle permits are free.
