**Hours required for "Hours premises are open to the public" and "Late night refreshment" and "Supply of Alcohol" and "Provision of facilities for dancing" and Performance of Dance" and "Films" and " Indoor Sporting Events" and " Live Music"**

This premises is situated in a quiet road set slightly apart from the main town area with residential premises nearby.

The premises has come to police attention regarding incidents of crime and disorder and for this reason the door supervisors condition remains on the public entertainment licence and negotiation resulted in comprehensive CCTV for the premises and its cur tillage. The most recent crime allegations were recorder on 1<sup>st</sup> July following a fight at the premises.

The terminal hours sought for this particular premises are not suitable on Sunday through to Wednesday with regard disturbance and nuisance to the public and with regard available police resources. I request that the closing hours be fixed for these days as midnight and the other hours for other activities be set at 2330hrs.

The minimum requirements conditions that police would expect are the provision of door supervisors, no drinks promotions and correctly installed and functioning CCTV, both within and immediately outside the premises

**Hours required for “non standard timings”**

Any Special Order of Exemption granted for this premises in the past four years have generally been for only a further one (1) hour. These premises applied for and were granted Xmas eve and extensions over the last recorded years. New Years Eve has been de-regulated or granted. No further Xmas or other type of Bank holiday ( May, Easter, August Bank Holidays etc) have ever been sought.

An application was received for the Football World Cup in 2002 and applications for the Rugby World Cup the following year. There are large screens to display broadcasts or pre-recorded media.

This information is indicative to the panel of the lack of extended hours the premises has had over the last 4 years should they wish to measure extension of hours against problems/complaints.

The 2003 Act provides a replacement for what are currently known as ‘extensions’, granted by the Police for special occasions, this being a Temporary Event Notice (TEN’s). Applications may be made to the Licensing Authority for different trading hours under this section of the Act, but only up to twelve occasions a year and not these extra being requested here. **Notwithstanding that there has been some ‘guidance’ by ACPO in relation to unofficial agreements between the industry representatives and local police this will NOT be agreed to in this borough.**

St Patrick’s day and St George’s day have been regularly celebrated in the locality by other premises and there would be no Police objections to the additional hour requested.

**However I further object to the additional hours requested for the following days:**

- **Burns Night**
- **St David’s Day**
- **Halloween**
- **Valentines Night**
- **Additional hours evenings preceding working days**

Historically no previous applications have been made for extensions to the permitted hours for these dates. They are not significant dates of note for this area or for these particular premises and whilst they may be speculative I consider that the others sought and not opposed (Good Friday etc) combined with the applicants ability to request temporary event notices will place sufficient number of extended hours on this premises to test the patience of the local residents and stretch police resources beyond limit..

Whilst the requirement for the event being special has been removed under the new legislation some basis of actual need for these dates should be forthcoming, and details provided of the measures the applicant will take to ensure the four licensing objectives are met. This would allow for Police resources to be suitably deployed to cover these hours rather than speculative planning for an event that may not take place.

All security measures such as this must comply to Crime Reduction Unit guidance. I request that the applicant contact the police Crime Reduction officers and that such an officer be allowed full access to all areas of the premises in order to review all security measures and that the applicant agree to any reasonable recommendations forthcoming in his report. This is to prevent crime and disorder.

Police would ask that the applicant accept a condition that the Designated Premises Supervisor or at least a Licensee in his/her absence agree to the condition that they continue to participate in the pub watch scheme in the area. .

I request it be made a condition that any S.34 AWP machine be either emptied at night or fitted with appropriate recommended security device ( e.g. a 'boot' or metal roller shutter) .

Regarding prevention of public nuisance I suggest that a condition be imposed that notices will be displayed asking customers to respect neighbours when leaving the premises.

I also request the panel examine the disturbance to residents by use of the exterior areas of the premises and consider, should extended hours be given to the premises that an earlier condition be placed on the use of the exterior areas.

In order to protect children I ask that a non-smoking area for children is not only provided but is enforced and that the panel consider the use of smoke extractors as a condition.

Similarly, experience shows that a condition of use of a noise limiter on entertainment equipment is a sensible tool to prevent public nuisance through noise.

Regarding under age drinking I request a 'challenge under 21' policy be adopted.

Toughened glass should be a condition of a licence given to a premises granted extended hours.
