### **Section 1 – Summary and Recommendations**

## **Section 2 – Report**

#### Introductory paragraph

As part of the Spending Review 2010, the Government announced that it would localise support for Council Tax from 2013/14, reducing the grant by ten per cent. Local authorities were required to set up localised Council Tax Support (CTS) Schemes to provide support to low income households with council tax for implementation from 1 April 2013.

The Scrutiny Leadership Group decided to undertake a review of Harrow's current CTS Scheme. The CTS Scheme Challenge Panel took place on the 27<sup>th</sup> October 2014 and the main aims were to:

- explore the impact on Harrow's residents of the introduction of the local council tax support scheme and the contribution it may be making to household debt problems
- understand how residents affected by the scheme are managing to make their Council Tax payments
- consider the findings of the CTS consultation to inform the development of the new scheme
- consider other schemes both London wide and nationally in relation to lessons learnt and how the findings can influence the development of the new scheme

The panel invited and heard evidence from Council officers, the Portfolio Holder, local voluntary organisations and charities. Ward councillors were also requested to submit anecdotal evidence based on cases regarding CTS from their constituents.
