## Section 1 – Summary

This information report is presented to members to provide an update on progress with the 2014 /15 traffic and parking schemes programme of works. This includes schemes funded by Transport for London (TfL) and schemes included in Harrow's Capital Programme. The information contained in this report reflects the latest position at the time of writing this report.

## Section 2 – Report

### General

- 2.1 This information report provides members with an update on the current programme of transport schemes and initiatives funded in the 2014/15 programme. This includes schemes funded by Transport for London grant and the Harrow capital programme. **Appendices A and B** provides a summary of progress with all the schemes within the current programme.
- 2.2 More detail on certain schemes is provided below in the body of the report where they have reached the public consultation, statutory consultation or implementation stages and any other specific issues of interest to members.

### Harrow Capital 2014/15

#### Parking management programme

- 2.3 At the last panel meeting in October the North Harrow and Queensbury controlled parking zones were recommended for implementation and the Portfolio Holder has subsequently agreed these decisions.
- 2.4 The statutory consultation results for controlled parking zones in Belmont Circle, Pinner, Welbeck Road area and Canons Park area will be reported to this meeting and are included in the agenda.

#### Localised Safety Parking Schemes Programme

- 2.5 This programme is concerned with isolated and localised sites where minor parking problems and issues occur. Typically remedial measures consist of proposals for single or double yellow lines at junctions, bends and narrow sections of road in order to improve vehicular access or improve road safety.
- 2.6 These measures also reinforce the well-established principles set out in The Highway Code. This is an on-going rolling programme of works and members will be advised of the locations included in the programme during the course of the year.

2.7 A statutory consultation was undertaken on the 11<sup>th</sup> September 2014 for “at any time” waiting restrictions (double yellow lines) proposals at the following locations:

- Buckingham Road junction with Salisbury Road
- Drummond Drive junction with Gordon Avenue
- Kings Road (opposite 253)
- Sudbury Hill (opposite Chasewood Park)
- Twyford Road (between no's 1 & 15)
- Warneford Road junction with Waghorn Road
- Langland Crescent junction with Streatfield Road
- Warneford (at 2 points outside The School House)
- Morley Crescent West junction with Streatfield Road
- Moorhouse Road junction with Waghorn Road
- Rayners Lane (both sides near Eastleigh Avenue)

2.8 The objections and comments were discussed with Portfolio Holder for Environment, Crime and Community Engagement at a meeting held on 22<sup>nd</sup> October 2014 and she agreed that the double yellow line proposals could be implemented. Works have now been issued for implementation.

#### **Works funded by section 106 developer contributions**

##### Krishna Avanti School Area, Camrose Avenue – Parking Review

2.9 Following a recent statutory consultation on the proposed scheme the objections and comments were discussed with the Portfolio Holder for Environment, Crime and Community Engagement at a meeting held on 22<sup>nd</sup> October 2014. She agreed that the parking proposals could be implemented and works have now been issued for implementation.

#### **Transport for London – Local Implementation Plan Programme 2014/15**

2.10 There is a budget of £120,000 in 2014/15 for two 20 mph zones in the streets surrounding Marlborough Hill and St Bernadette's Schools.

##### 20 mph zone - Marlborough Primary School

2.11 The results of the informal consultation were analysed and presented to the Portfolio Holder for Environment, Crime & Community Safety in August who agreed that officers undertake a statutory consultation. The statutory consultation commenced on 17<sup>th</sup> October and ended on the 5<sup>th</sup> November. No objections were raised and the scheme has now been issued for implementation. The works are scheduled for February / March 2015.

##### 20 mph zone - St Bernadette's School

2.12 The results of the informal consultation were analysed and presented to the Portfolio Holder for Environment, Crime & Community Safety in September who

agreed that officers undertake a statutory consultation. The statutory consultation commenced on 17th October and ended on the 5th November. No objections were raised and the scheme has now been issued for implementation. The works are scheduled for February / March 2015.

### Local Safety Schemes

- 2.13 This programme of work is focussed on reducing killed and seriously injured accidents throughout the borough and supports the objectives of the Mayor for London's Road Safety Plan to reduce Killed and Seriously Injured accidents by 40% by 2020. The sites which have been identified for treatment as follows :
- High Street / March Road - (3 serious, 8 slight)
  - Alexandra Avenue / Eastcote Lane – (4 serious, 3 slight)
  - High Road (Harrow Weald) – (4 serious, 14 slight)
- 2.14 Outline proposals are being designed for each of these sites and will be reported to a future meeting of the Panel.

### Bus Priority - Mollison Way phase 2 (Lawrence Crescent to Stag Lane)

- 2.15 The proposals for phase 2 are similar in nature to phase 1 and target traffic congestion along Mollison Way to improve bus journey times. Care has been taken to address traffic and pedestrian safety issues as well whilst minimising the loss of on-street parking space for local residents. Phase 2 is located in the section from the junction with Stag Lane to the junction with Constable Crescent. The proposals include the following measures:
- Inset parking bays: To widen the effective driving lane allow two large vehicles simultaneously pass each other, inset parking bays are proposed, wherever feasible on both sides of the road. These bays will allow parking whilst maintaining the two way traffic.
  - "At any time" (double yellow lines) waiting restrictions: these will be introduced at key locations to prevent obstructive parking and ensure that adequate road space is available for refuse and emergency vehicles. These waiting restrictions are proposed at locations where traffic congestion occurs on a regular basis when two buses or large vehicles pass each other simultaneously. The restrictions will prevent parking and provide road space to allow continuous and unobstructed traffic flow.
  - Trees, Lamp columns and other street furniture: In order to facilitate provision of inset bays, it is required to remove some of the existing trees along Mollison Way. Wherever possible, smaller trees will be relocated to nearby locations. Any trees removed will be replaced with new trees. Lamp columns and other street furniture affected by the proposals will be relocated to suitable locations.
- 2.16 During the implementation stage, the extent of inset parking bays may be subject to minor variations due to the presence of underground utilities and tree roots in the area.

- 2.17 The public consultation on the proposals was carried out in July 2014 and majority of the consultees were in support of the scheme. The Portfolio Holder was made aware of the outcome of this consultation and a decision was made to implement the proposals as consulted.
- 2.18 The council is now in a position to issue the works and implementation is programmed for this financial year.

#### Bus Priority - The Common / Common Road junction improvement

- 2.19 This scheme involves widening the carriageway in Common Road to incorporate a new left turn approach lane which will allow left turning vehicles including the 258 bus to avoid the queue for traffic travelling straight ahead and thereby improve junction capacity. The council is working in conjunction with the TfL signals unit to upgrade the signal equipment and review the signal timings to minimise delay at the junction as much as possible as a part of this project.
- 2.20 The works could not commence until British Telecom undertook diversionary works to their plant and this has now been completed.
- 2.21 The proposal includes introducing “at any time” waiting restrictions (double yellow lines) along Common Road and a statutory consultation on this part of the proposal will be undertaken in November.

#### Bus Stop Accessibility

- 2.22 The bus stop accessibility programme is recognised as a crucial element in the drive to improve the quality of bus services. The 2014/15 programme will include reviews of the following bus stop locations :
- Kenton Lane - outside the Duck in the Pond public house
  - Stanmore Broadway - westbound only.
  - Whitmore Road - westbound bus stop (WA)
  - High Road, Harrow Weald – northbound outside bus garage
  - The Ridgeway, North Harrow – bus stops (NL, NN and NP)
  - Kenton Road – eastbound between Hawthorne Rd and Elmwood Avenue and eastbound between Carlton Road and Mayfield Avenue.

#### Freight Strategy

- 2.23 The next phase of the freight management strategy is to consider implementing “lorry enforcement points” using weight limit restrictions over short sections of road at strategic locations on the highway network where it is not desirable for heavy goods vehicle traffic to use through routes which are not on the designated freight route network.
- 2.24 The “lorry enforcement points” will consist of regulatory signs at either end of the restricted section of road and warning signs placed in advance. Enforcement will be via a CCTV camera in order to enforce the lorry ban. This project is being developed by the Council’s engaged design consultant.

### Legible London

2.25 The pedestrian way finding signs artwork and site locations have been agreed with Transport for London. The sites are in the vicinity of the following underground stations:

- Stanmore
- Canons Park
- South Harrow
- Rayners Lane
- Sudbury Hill.

2.26 The installation of sign bases will commence shortly and the full sign implementation is scheduled for January / February 2015.

### Walking Projects

2.27 Two new zebra crossings are proposed for Camrose Avenue, Edgware and Marsh Lane, Stanmore and another scheme in Parkside Way which involves widening the existing pedestrian refuge close to Southfield Park to accommodate larger groups of pedestrians especially school children at peak times.

2.28 All schemes are currently being programmed for implementation.

### Station Road (A409 Corridor) between Greenhill Way / The Bridge Highway improvements

2.29 Station Road is a main highway corridor which runs through the heart of Harrow and carries significant amounts of traffic and generates large numbers of pedestrian movements. The council has been successful in securing £300k of funding from Transport for London (TfL) over three years to introduce highway improvements. The work in this year will focus on improving the public realm in Dominion Parade with a similar improvement in Central Parade in 2015/16.

2.30 Footway widths vary along this corridor and in the parades pedestrians often walk in the service roads because this is a more direct route. The proposals therefore improve pedestrian facilities, create a more pleasant shopping environment and reposition parking by making better use of the road space. The main aims of the scheme are as follows:

- Improve pedestrian facilities
- Create a more attractive environment
- Improve footway links between Wealdstone and Harrow town centres
- Rationalise existing parking
- Support local traders and businesses

- 2.31 Residents and businesses have recently been consulted regarding the proposals a copy of the leaflet can be see in **Appendix C**.

#### Cycling schemes

- 2.32 The existing path in Yeading Brook Open space, North Harrow is being converted to shared use to enable pedestrians and cyclists to use this facility in the park and provide a new north-south link. This will involve the widening of the path leading to the existing bridge over Yeading Brook, which will up replaced and upgraded. This work is almost complete.
- 2.33 The 2014/15 programme includes the following schemes which are currently in design:
- Roxbourne / Cannon Lane – route linking Yeading Walk to Hillingdon via Roxbourne Park
  - Yeading Walk east / west link linking Northumberland Road / Whittington Way.

#### Mayor for London's cycling vision – Harrow bid for quiet way cycle routes

- 2.34 Transport for London has recently announced the next round of Quiet Way cycle routes for investigation. In Harrow these are as follows:
- Ealing to Harrow Town Centre via Sudbury (Brent)
  - Harrow/ Brent boundary (Kenton Road) to Rayners Lane and on to West Ruislip and Ruislip Gardens
  - Harrow Town Centre to Harrow Weald via Wealdstone
- 2.35 These cycle routes are still being discussed with TFL and have yet to be clearly defined. TFL have asked the borough's to confirm their agreement with the routes and to suggest an order of priority. Officers recently met with representatives from WestTrans (West London sub regional partnership), Ealing and Brent Councils to discuss the cross borough cycle routes and TfL's proposals.
- 2.36 Harrow still has aspirations to consider other routes that were suggested to the Cycling Commissioner last year such as the Jubilee route from Stanmore underground station to Wembley Park following the Jubilee Line.
- 2.37 An original proposal to implement a cycle route from Stanmore (including the Belmont Trail) to the Thames will not be funded through the Quiet Ways programme. However, it is still under consideration as a project via TfL's Major schemes programme.

#### Local Transport Fund - Stanmore Hill / The Broadway, pedestrian phase

- 2.38 Officers met recently with representatives from the signals unit at TfL to consider the latest traffic simulation model for an all red phase to assist pedestrians at the junction. TfL have checked the model and have recommended some changes to

the proposed phases and some of the cycle times. This is necessary to balance out the capacity at the junction and to demonstrate that an all red phase can be introduced for pedestrians.

- 2.39 The detail of the model and the recommendations were also discussed with TfL's Forward Planning Team (FPT) who are responsible for making the final decision as to whether the proposed scheme can go ahead on the strategic road network. The Council is still awaiting detailed comments from TfL's Bus Performance Team and these will be passed on to the FPT for their consideration.
- 2.40 The panel will be advised of the outcome of the assessments in due course.

#### Local Transport Fund - Masons Avenue, amendment to existing waiting restrictions

- 2.41 Surveys are planned in Masons Avenue in November to establish parking patterns and their effect on congestion in the area. A proposed scheme will then be developed by January 2015 for statutory consultation.

#### Local Transport Fund - St Pauls Avenue 20 mph zone

- 2.42 Detailed proposals are being developed by the council's engaged transport consultant to introduce a 20mph zone in St Pauls Avenue, Kenton. The outline design will be ready for consultation by February 2015.
- 2.43 Implementation of the scheme is planned for 2015/16 subject to the Panel agreeing the use of the Local transport Fund for this purpose.

#### Local Transport Fund – Roxeth School

- 2.44 The main aim of the proposal is to reduce congestion outside the school entrance in Brickfields at school opening and closing times.
- 2.45 An outline scheme design is currently being developed. Officers are engaging with the school to discuss the development of the proposal.

#### School travel plan highway schemes

- 2.46 As a part of the school expansion proposals approved by Planning Committee there are some agreed highway works required to facilitate development.
- 2.47 There is a proposal at Bentley Wood School to implement an area for parents to drop-off and pick-up pupils from Clamp Hill during the peak hours inside the school grounds. Council officers are working with Keepmoat, who are overseeing the main school works, to develop a detailed scheme.
- 2.48 The proposal involves modifying the existing school entrance in Clamp Hill and to create a new drop off / pick up area and access to exit onto Clamp Hill from the school grounds. To prevent parents turning right when exiting the drop off area a median strip will be constructed on Clamp Hill to oblige drivers to turn left into

Clamp Hill from the new access (towards the roundabout on Uxbridge Road) which will be safer for traffic.

- 2.49 This proposal was recommended in the Transport Assessment because it would reduce the volume of traffic accessing the school via the Uxbridge Road and residential streets leading to the school. The design of the scheme is on-going.

### **Section 3 – Further Information**

- 3.1 A regular update is provided at every meeting on progress with the annual programme of traffic and parking schemes. Future reports will provide information to members about any consultations, statutory consultations, portfolio holder decisions and implementation issues since the previous meeting.

### **Section 4 – Financial Implications**

- 4.1 Any schemes and works programmes mentioned in this report are being taken forward using identified resources and funding from TfL Grant, S106 contributions from developers and Harrow Capital in 2014/15.

### **Section 5 - Equalities implications**
