The Hatch End Library should be part of a future Centre of Excellence for the written, visual and performing arts. Is it not

therefore inadvisable to now close the Hatch End Library endangering the planned Arts Centre cost savings?"

The sole value of Gayton Road Library would be in excess of £1.5 million pounds. Also the costs for the new library would be

covered by the development."
