Annex 1 – Mandatory Conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply or sale of alcohol shall be made under the premises licence
 - I. at a time when there is no designated premises supervisor in respect of the premises licence
 - II. at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended
- (2) Every supply or sale of alcohol made under the premises licence must be made or authorised by a person who holds a personal licence

Appendix A - Premises License Annex 2 – Conditions consistent with the operating Schedule

- 1. DPS is to be employed at the premises to ensure all sales of alcohol can be made first hand: in the absence of the DPS then a Personal Licence holder will be on the premises.
- 2. The premises will operate a 'Challenge 21' policy, whereby any person wishing to purchase alcohol, and who appears to under the age of 21 years, will be asked to provide proof (i.e. passport, driving licence or other such accredited form of photo identification) that they are over 18 years of age: notices will be posted advising patrons that such a scheme is being operated and a record of age related refusals of sale will be kept and be made available to officers of the police or local authority upon request.
- 3. CCTV will be installed, operated and maintained according to the reasonable specification of the Metropolitan Police Crime Prevention Officer: images will be securely stored, kept for a minimum of 31 days and made available to officers of the police or local authority upon request.
- 4. A monitored Central Station Alarm, with one fixed and one remote panic button, will be installed, operated and maintained according to the reasonable specification of the Metropolitan Police Crime Prevention Officer.
- 5. A time delay safe is to be installed on the premises.
- 6. An indelible ink staining (smoke-note or similar) will be installed.
- 7. A till guard is to be fitted over the till to prevent easy access to cash.
- 8. The letter box will be blanked to prevent attempted arson.
- 9. The back door is to be fitted with with 2 5-lever mortice locks.
- 10. A 180 degree door viewer is to be fitted to the rear door.
- 11. A minimum of three staff will be present from 2300 until the premises is closed.
