But examples of scenario that sometimes occurs is a family becoming overcrowded because they have moved to smaller accommodation when they don't need to, either because their previous accommodation remained available, or alternative suitable sized accommodation was available. Or overcrowding caused by inviting another household (who are non-dependents) to move into their home.

Given this seeming inability to properly maintain its current housing stock, do you think that the Council will really be able to effectively manage rental properties through its proposed, armslength private rental sector company?"

Written Response:

The reason there is an outstanding need for investment in the Council's commercial heating systems is that this type of work was outside the Governments Decent Homes Standard-and so not something that limited funds allowed us to invest in under that regime. Since moving away from these requirements in 2012 we have been able to rectify most of the outstanding issues, caused by historic inadequate investment, and indeed the stock is in a much improved condition and customer satisfaction has significantly improved. Putting things right with the communal heating systems will be a priority with the new contract.

The Grange Farm properties are in need of regeneration not because of the Council's inability to maintain them but because the non-traditional construction used to build these homes gave them a relatively short life. The cost of bringing the existing properties up to an acceptable standard would be very high, and their life would only be extended for a few more years-so demolition and re-build will both give the Council a more valuable asset and provide homes that meet resident's needs for many years to come. Managing homes for private letting is outside the constraints of Central Government's funding regimes-so these problems will not be encountered by the arms-length company.

Written Response:

The Council's equality objectives include 'a workforce that is reflective of the diverse community we serve' and over many years and successive administrations we have continued to improve the representation of BAME staff, which now stands at its highest recorded level at over 43% of the workforce. However, like the majority of organisations including those in the public sector, representation of BAME staff is lowest in the higher pay bands (Percentage of top 5% earners from BME

communities = 16.67%) and this is something we want to improve.

The Council's current Equality in Employment Action Plan identifies 'Under representation of BAME employees and employees with disabilities at higher levels in the workforce' as a priority issue. The Councillor will be aware, from the report to the Employees' Consultative Forum, that the Plan includes specific actions to address this priority that were agreed by the Council's Corporate Equality Group, which includes representatives from community groups including Harrow Equalities Centre and progress against the plan is regularly monitored by the Group.

The Councillor will also be aware that members of the Employees' Consultative Forum, which was attended by the Leader of the opposition, have been asked to consider and comment on the data reported and provide any feedback on issues to prioritise for action from January 2016, we welcome feedback from opposition members on this important issue.
