
Equality Impact Assessment Template

 Stage 1: Overview 1. What are you trying to do? (Explain your proposals here e.g. introduction of a new service or policy, policy review, changing criteria, reduction / removal of service, restructure, deletion of posts etc) 	 This proposal is one of the projects falling within the Transforming Adults Social Care workstream under 'Project Infinity' and as such should not be viewed in isolation but instead as a complete package of savings proposals. In the last MTFS £500k of savings were achieved from this budget through re-providing the service through Personal Budgets and the closure of routes. The next stage of Savings looks to build on this and unlock further savings from the budget. As of 2015/16 Special Needs Transport (SNT) service (managed by Children Services) to Adults compromises of :- 11 bus fleet routes 2 private hire taxi routes The vehicles are leased from Fraikin and the Council is part way through an 8 year contract. Early return of the vehicles will result in the Council incurring an early termination payment. From September 2018 the early termination payment disappears. This is a factor that will need to be managed in conjunction with Children's services and project Phoenix.
