CURRENTLY CHILDREN WAITING FOR SCHOOL BUSES IN MOLLISON WAY ARE SUBJECTED TO PERSONS STANDING AT THE BUS STOP DRINKING ALCOHOL AT 7.15 AM. A NEW OUTLET ALMOST ADJACENT TO THE BUS STOP ~~WILL~~ IS LIKELY TO INCREASE THIS IF THEY ARE ALLOWED TO SELL ALCOHOL FROM 6 AM.

GROUPS OF ADULTS, MAINLY MEN, GATHER OUTSIDE THE CURRENT 6 OFF LICENSES IN MOLLISON WAY DRINKING IN THE STREET, WHICH PEOPLE WITH YOUNG CHILDREN HAVE TO WALK PAST. AT ONE OUTLINE IT IS OFTEN THAT PEOPLE ARE HEAVILY INTOXICATED. MOLLISON WAY IS A DESIGNATED DRINKING EXCLUSION ZONE WHICH IS NOT BEING ENFORCED BY HARROW COUNCIL OR METROPOLITAN POLICE. ANOTHER OFF LICENSE ~~WILL~~ IS LIKELY TO INCREASE THIS PROBLEM.

IN AND AROUND MOLLISON WAY, STREETS AND GARDENS GET LITTERED WITH EMPTY ALCOHOL CANS AND BOTTLES, ANOTHER OUTLET WITH SUCH LONG OPENING HOURS IS LIKELY TO INCREASE THIS PROBLEM.

AS OTHER LICENSED PREMISES CLOSE AT AROUND 11/12 PM, ALLOWING THIS APPLICATION TO REMAIN OPEN FOR THE SALE OF ALCOHOL UNTIL 2 AM WILL ENCOURAGE MORE ON STREET DRINKING AND LITTERING, ALSO INCREASING NOISE.
