Question: "The residents of Weighton Road are concerned with the

vehicles parked almost all the time on Double Yellow lines on entering Weighton Road from the High Road, Harrow Weald, which is obstructing vehicles turning in to Weighton Road and

vehicles coming out to go to High Road.

I have explained in my email of 18 May 2018 quoting the Highway Code concerning vehicles parked or waiting on Double

Yellow lines.

My question is: Would the Council put 'No Waiting at Any Time' sign and also install a camera to deter the drivers to wait or park

their vehicles on Double Yellow Lines?

Offenders can be caught on camera and Council would have more income. When 'No Right Turn' from Weighton Road came into effect, a man from the council used to sit in his tiny car with a surveillance camera to catch offenders turning right. This lasted only a couple of weeks. While the surveillance vehicle was parked on the double yellow lines, nobody dared to park their

vehicles there.

As per the Highway Code Rule 238 it stipulates 'NO WAITING

PARKING AT ANY TIME'."

Question: "Would you please outline the current legal position for residents

of Weighton Road, Harrow Weald, re damage to grass verges.

Back in February 27 households received a letter saying that damage had been noted to the grass verge outside their property and that they had three weeks to apply for a vehicle crossing extension. If they did not apply they faced the threat of possible prosecution by the Authority, thus increasing any associated costs to the case. This angered and upset a large number of residents who had not done the damage. Weighton Road is very narrow and a lot of the damage had been done by builders, delivery drivers, large lorries etc.

Also in this letter it stated that there was a new Council Protection Order which allows them to issue a Fixed Penalty Notice of £100 to anyone seen driving over a grass verge. How will this be monitored and how can residents prove that they haven't done the damage?"

Question: "I wish to express concerns that have been raised regarding the

trees in Harrow Weald Recreation Ground adjacent to Weighton

Road.

Concerns were first raised in a meeting that residents had with an officer, Mr Bradshaw, in February 2017. General concerns are still ongoing. There are now other particular concerns. A complaint has been made about tree roots coming into the garden at 31 Weighton Road. The tree behind numbers 23 and 25 Weighton Road has grown bigger. Parts of the tree are now falling off. The tree behind 25 and 27 Weighton Road was partially cut down after concerns were raised that it was unsafe at the base. It has since grown again. Four sycamore trees have died and could be dangerous. The trees behind 21 Weighton Road, and continuing adjacent to Weighton Road, are very close to the garden fences and are in varying states of growth or decay. I believe that they present a hazard, both to property and to life and limb. There are dangers of parts of the trees coming loose, or of a whole tree being blown down in bad weather.

After the meeting with the officer residents were given various options as to what could be done. With one exception we voted to have the trees cut down. I believe that concerns about the trees now need to be urgently addressed. I would like to ask what steps Harrow Council plan to take to address the

Work has carried on and the laybys have been replaced with grass verges which is the last thing we need after all the trouble we've had with residents being threatened with prosecution due to damage

to grass verges.

The other problem is that as the kerb is a lot higher than before the kerb stones at the edge of the vehicle crossings that slope down are also higher and residents are finding that they are bumping over these when turning in and out of their drives. We have asked for someone to come and look at this but no one

has.

Why have the two laybys been removed and replaced with grass

as the two laybys were useful on our narrow road?"

Further, if they then call again afterwards - to report the bin has still not been collected - this call then seems to be registered as a separate complaint and not tied into the initial call. They are given another reference number. Can this really be the case: if so - what are you doing to improve the service for Residents?"
