## **Section 2 – Report**

#### Introductory paragraph

Ofsted have introduced a new framework of assessment for Children and Young Peoples services – Inspection of Local Authority Children's Services (ILACS). This requires Local Authorities to produce an annual self-assessment highlighting achievements, strengths and challenges. This will also replace the Children's Services Plan which has reported to Cabinet on an annual basis.

In January 2017, Harrow Children's Services were considered **Good** by Ofsted. The self-assessment builds on this success to highlight achievements and challenges to support our improvement journey

The four main challenges are:

- 1) Develop further through MASH and FRT pathways for families accessing suite/full range of early support services
- 2) Extend partnership working with young people vulnerable to sexual/criminal exploitation and violence through the Violence, Vulnerability and Exploitation strategy and using a contextual safeguarding approach
- 3) Further integrating our service and offer to Children Looked After and Care Leavers 16 and older to enhance the young person's journey through pathway planning and transition into adulthood
- 4) Improve the education outcomes in attendance, progress and attainment for Children Looked After

The inspection framework involves the leadership of councillors and senior managers in terms of safeguarding children and corporate parenting and it is important that the self - assessment and plan are owned by the whole Council

This also incorporates the Council's priorities in making a difference for the vulnerable, making a difference for communities and making a difference for families
