### To whom it may concern,

As local residents to the above for some 50 years, my wife and I would like to register our objections to the above application for the following reasons.

- a) The location is completely unsuitable for such a facility, for the following reasons. It is situated directly below residential flats, directly next to residential houses, all of whom have no off-street parking facilities and therefore the small service road in which the applicant is located, is constantly completely full of cars, particularly at night when the residents are at home.

  Therefore there is no available parking facility available whatsoever, other than in Whittington Way itself which is on a bus route, there is also a bus stop located directly outside the premises, which
  - itself which is on a bus route, there is also a bus stop located directly outside the premises, which would make it extremely difficult and dangerous for the buses to stop if there are cars parked on Whittington Way.
  - This is going to be exacerbated with the proposed Tesco facility nearby.
- b) The proposed licensing hours merely extend and increase the burden on an already overstretched and understaffed Police Force and Ambulance Service having to cope with all the problems created by alcohol which are only too well known to those having to deal with the consequences. Clearly any such activity licensed to 2.30am is going to result in noise and disturbance as they leave the premises, which is totally unacceptable to the residents in the immediate vicinity, and residents who have right to a good undisturbed night's sleep when they have to go to work the next day.
- c) The concept that there is a demand for the provision of eating facilities until 2.30 am for most people is doubtful, therefore one assumes that the main activity will be drinking, which is well provided for by the Public House directly opposite, with more than its own adequate off street parking provision, well manged, closes at a reasonable hour, allowing the local residents to their entitlement of a full night's sleep.
- d) This will be prevented if this application is granted.

The area surrounding Biancas Kitchen is a quiet residential area, the licensing hours proposed seem excessive to the stage where it would draw the wrong kind of crowds, disrupt the public and create an unsafe, unfriendly and threatening environment.

There are already both on-licenses and off-licenses in the area, not only is there not a need for another one (given the pub which is directly opposite it), but an extension of licensing hours until 2am, 7 days a week, is frankly ridiculous.

There is no reason why this kind of area would need somewhere with an alcohol license with those hours or frequency. Similarly, with only a small amount of space, patrons would inevitably spill out into the street. This would result in a disturbance in the early hours of morning and an unsafe and threatening environment to both patrons and local public alike.

Please consider reducing the licensing hours Sunday-Thursday to a more reasonable time (10-11pm) and putting measures in place to ensure that nothing can spill out into the street.
