1. Summary of proposal, impact on groups with protected characteristics and mitigating actions (to be completed after you have completed sections 2 - 5)

a) What is your proposal?

Design and deliver 20 family units as part of the regeneration strategy. In addition to delivering new homes, the project will provide a safe, car-free, playable mews street to further strengthen the family and community quality of the new development.

The development of the Waxwell Lane project programme will be supported by:

- Producing a business case for the development
- Producing an options appraisal to find the most viable option
- Engaging in a tailored consultation process with key stakeholders

The Council is committed to the development having a positive impact on Pinner; the extended consultation process is designed to ensure that the project matches local expectations for the provision of context-sensitive design, appropriate public realm and ongoing support of Bridge Street businesses as far as possible, and through range of mechanisms beyond what the car park currently provides (i.e. support beyond the provision of car parking spaces).

As such the new development provides opportunities for construction jobs and apprenticeships for young people with in the construction delivery phase aswell as support from the design team in providing work experience and school workshops

A percentage of the scheme has been apportioned to include two wheelchair accessible homes; to address the need for more housing for the elderly community. Aswell as some units having the capacity to be easily adapted for wheelchair users

Based on consultation with the local community it was important that the scheme provided a central car-free mews street creating a safe space for children to play with soft landscaping, trees and play equipment.

Disability

A percentage of the scheme has been apportioned to include two wheelchair accessible homes; to address the need for more housing for the elderly community. Aswell as some units having the capacity to be easily adapted for wheelchair users

Following early concerns from residents and associated planning risk that the development does not provide sufficient parking for future residents, the masterplan was developed in order to ensure that the design provides parking in a 1:1 ratio to the 20 units, including a disabled bay each for the two M3 units.

b) Summarise any potential negative impact(s) identified and mitigating actions

Stretching from summer 2016 to winter 2017 a series of public consultation events were held to gather views of the community on the development of the car park and to keep Pinner residents and businesses informed of the process and proposals. Officers have also been liaising with the immediate neighbours of Waxwell Lane Car Park, such as OLM Montessori School and St. Luke's Catholic Church, to ensure the development has minimal negative impact.

There has been extensive amount of engagement with the neighbouring school on site to understand and reprovide a safe and suitable alternative for pick up and drop off for school children. The staff at the school have also been reprovided with parking facilities at the Love Lane Car Park.

The Highways team also are in the process of assessing the need for a zebra crossing to the school

A reprovision to Love Lane carp park for parents and their children have been agreed upon by both parties

The fire exist for school will be maintained to facilitate evacuation in time of fire.

The loss in town centre car parking poses an impact on neighbouring streets as new homes with potential cars come into the area. As such the projects was revised to include 1:1 parking provision for each new home aswell as 2 disabled bays.
