### Addendum Item 1: Additional Transportation link details

Whilst this application has been proposed as a car free development, with 13 proposed cycle spaces. The additional details are to justify the car free development, by means of other sustainable modes of transportation to the application site. From Officers site visit on 16/04/2019 can also conclude the following:

#### **BUSES**

The <u>Love Lane Bus Stop D</u> is right outside the site, and it serves routes:

- H11: Harrow Bus Station to Mount Vernon Hospital (via Pinner Station and Northwood Station)

(Buses from 06:00 to 00:32, 4 buses per hour)

- H12: Stanmore Station to South Harrow Bus Station (via Hatch End Station, Pinner Station and Rayners Lane Station)

(Buses from 06:00 to 00:24, 3 buses per hour)

- H13: St Vincent's Nursing Home to Ruislip Lido (via Northwood Hills Station, and Pinner Station and Ruislip Manor Station)

(Buses from 06:00 to 00:03, 3 buses per hour)

The Pinner Station / Bridge Street Stand Z1 is right outside the site, and it serves route:

- 183: Golders Green Station to Pinner Station (via Hendon, Edgware Rd, Kingsbury, Harrow Town Centre, W and N Harrow)

#### **RAIL**

<u>Pinner Underground Station</u> (Metropolitan Line) is within 4 minute walk of site. Services every few minutes, from approximately 05:30 to 00:30, with access to the entire Underground network.

#### **CYCLING**


Suitable and sufficient protected Cycle Spaces are to be provided on the site, and would be conducive to cycle access.

#### **PULIC CAR PARKS**

- Chapel Lane 154 Spaces Permanent access 4 minute walk of site
- Pinner Station X Spaces Permanent access 5 minute walk of site
- Love Lane 183 Spaces Permanent Access 5 minute Walk of Site
- Waxwell Lane 111 spaces Permanent Access 4 minute Walk of Site

The Biodiversity Officer confirmed that subject to the requested conditions, the loss of one parking space to provide additional space for soft landscaping, the submission of a revised soft and hard landscaping plan for the approval of the Local Planning Authority and the provision of green roofs for the refuse and cycle stores, no additional mitigation or financial contribution would be required. Therefore, on this basis, the proposal complies with the National Planning Policy Framework (2018), policy 7.19 of the London Plan (2016), policy CS1 of the Core Strategy (2012) and policies DM1, DM20, DM21 and DM22 of the Harrow Development Management Policies Local Plan (2013).
