



I wish to object to the license application on the following grounds:

1) Public nuisance

The late opening hours (22:00 and 23:00) has the potential to create public nuisance within the residential development during unsociable hours. Residential units are located immediately opposite the premises.

The walkway immediately in front of the premises is covered, providing good shelter in all weathers. This provides good conditions for groups or individuals to gather and loiter.

There are seating areas within the private gardens of the development. Many of these areas are not enclosed and may encourage gatherings of non-residents wishing to consume their alcohol shortly after purchase. Compromising the enjoyment of the gardens for whom they are intended (the residents of Stanmore place). Furthermore, the upkeep of the gardens is funded by the residents through the annual service charge.

No litter bins exist within the grounds of the estate which will likely lead to increased litter. Litter picking is performed by Stanmore Place staff which is funded by the Stanmore Place residents through their annual service charge.

The security guard mentioned in the application is funded by the residents of Stanmore Place through our annual service charge. I don't believe it's appropriate for the business to rely on a resource which they do not fund or manage.

2) Many existing licenced premises already in close proximity. There are already **four** premises licensed to sell alcohol in close for consumption off the premises within close proximity to Stanmore Place. Three exist on Station Parade, less than 100m from Stanmore Place. The fourth exists on Honeypot Lane, approximately 300m from Stanmore Place.

On a minor point, there appears to be a discrepancy with the application in that the drawing only shows 9 CCTV cameras whereas the application suggests 12 will be installed.


