<b>Options considered:</b>	<p>1) Monday – Friday 8am – 6.30pm.</p> <p>Benefits - These restrictions would prevent all day parking up to and including early evening. It would be easier for residents to find parking during Monday to Friday when returning from work.</p> <p>Dis-benefits – There would be a wider period of control requiring residents and their visitors to display their permits to park during the controlled hours.</p>
<b>Any other option identified by the Portfolio Holder:</b>	None
<b>Decision:</b>	<p>That: the objections submitted during the statutory consultation and notwithstanding the objections, the Authority would be complying with its duties arising under section 122 of the Road Traffic Regulation Act 1984 in authorising that the Traffic Management Order be confirmed and agree that the measures in the following locations be implemented as follows:</p> <ol style="list-style-type: none"> <li>1) a new CPZ, in the form of resident parking bays, operational Monday to Saturday, 8am to 6:30pm, on the south-eastern side of Northolt Road between property numbers 345 – 391;</li> <li>2) two (2) pay and display parking bays adjacent to the existing loading bay outside 387/389 Northolt Road. These two (2) bays are to have the same operational hours (Monday to Saturday 10am to 6.30pm) as the existing pay and display bays outside numbers 393 – 399; and</li> </ol>

	3) residents and businesses within the agreed consultation area be informed of the PH's decision.
<b>Reasons for Decision:</b>	To act in accordance with the results of the statutory consultation that was undertaken in direct response to residents and businesses requests for changes to the existing parking arrangements in their area.
