As such, condition 27 is unnecessary and can be removed and the following conditions renumbered:</p> <p><u>27. Obscure Glazing</u></p> <p>Any window(s) located in the stairwell facing the side boundary of the approved development shall:</p> <ul style="list-style-type: none">a) be of purpose made obscure glass,b) be permanently fixed closed below a height of 1.7 metres above finished floor level, and shall thereafter be retained in that form. <p>REASON: To safeguard the amenity of neighbouring residents.</p>

This charge is levied under s.206 of the Planning Act 2008 Harrow Council, as CIL collecting authority, has responsibility for the collection of the Mayoral CIL The Provisional Mayoral CIL liability for the application, based on the Mayoral CIL levy rate for Harrow of £60/sqm is ~~£12,240~~ £20,138.18.

Hotels (Use Class C1), Residential Institutions except Hospitals, (Use Class

C2), Student Accommodation, Hostels and HMOs (Sui generis) - £55 per sqm;

Retail (Use Class A1), Financial & Professional Services (Use Class A2), Restaurants and Cafes (Use Class A3) Drinking Establishments (Use Class A4) Hot Food Takeaways (Use Class A5) - £100 per sqm

All other uses - Nil.
