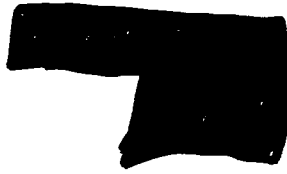
I am writing to register my objection to the I-Foundation's plan for a Hindu school

As a resident in Notholme Gardens, we would like to put our objections in writing. We do not agree with the proposal of the new Hindu School development on the above site.

This borough has very few green field sites, your proposal is yet just another way to reduce the amount of green we have, and create another concrete, polluted area. Increasing traffic, a danger to my children in terms of safety and further, parking congestion (to which we are not prepared to pay for parking permits. Harrow already takes far too much by means of council tax, and we would refuse to pay any more especially on something that has been severely objected). Parking can be an issue at the best of times, especially when the ground is used on the weekends for football. It may just be tolerable on the weekends, but it would not be for 7 days a week.

The proposed development will absorb at least 50% of the current playing field. With a new school, you also potentially introduce weekend activities, weddings and hire of the school halls for other functions. This, again, will introduce more traffic and possible noise. If we wanted that, we would not have moved to this area.

There are plenty of brown field sites within the Borough of Harrow where this school could be sited, thus preserving green sites from damaging environmental effects, and also to preserve our (resident) "quality of life".

Should you not be focusing your money and attention on matters which are more important? We already have 4 schools within the area, surely another is not needed? Would you not look at improving those schools we have and bringing them to a better academic level? Improve parks and leisure centres.

We urge you to protect the environment, resident life, safety and levels of traffic. This should be your concern.

Re: William Ellis Playing Field, Edgware.

I am writing on behalf of the William Ellis Action Group which represents a large proportion of the local residents living in and around the area of William Ellis Playing Field.

As you are no doubt aware the proposal by the I-Foundation to purchase public land at William Ellis playing field to facilitate the building of a new school has met with vigorous and determined opposition from the residents of Edgware and users of the ground. Your representative present at the recent public meeting called by Harrow Council will have experienced at first hand the feelings this proposal has generated.

I have to emphasise that the William Ellis Action Group and local residents are not opposed to the building a Hindu faith school in the borough of Harrow. Our objections are based solely on the choice of a green field site for the development. The proposal to build on green land is extremely contentious and local residents cannot understand how an organisation which expresses an environmentally friendly approach in its ethos and philosophy can pursue such a course of action.


Needless to say both Harrow Council and the I-Foundation have come in for withering criticism from the community for the way in which this matter has been handled. Keeping the residents of Edgware (and local councillors) in the dark combined with a reluctance to come forward with information has led to outrage and genuine anger, especially as the I-Foundation committed to 'vigorously' engage with the local community; there was no evidence of this in reality. Clearly in the eyes of the I-Foundation and Harrow Council the people of Edgware are not as deserving as those who live in Pinner! The local community has been badly served by both organisations who are now viewed with great suspicion and mistrust. Neither have any credibility.

The proposal would mean that Belmont United, who have been established on the site for more than ten years, would be deprived of half its playing area. The impact of this loss on both the club and local community would be huge. The loss of playing and training opportunities to young people each year would run into thousands and this at a time when the government are seeking to improve the health of young people and offer them more opportunities to play sport. The building of the school would do immense damage to both of these objectives.

The environmental damage of the proposal cannot be underestimated. There is absolutely no benefit to anyone of building on a green field site when other options exist. This scheme does nothing to enhance the environment or lives of local people, it only serves to destroy green land and reduce open space still further, not something the I-Foundation should want to inflict on people given its ideals and commitment to the environment. Not only are local residents, young people and those who use the ground going to suffer but the developed land is lost to future generations. Add to this the attendant impact of pollution, noise, traffic and loss of quality of life and it is plain to see the William Ellis site is quite unsuitable for the development proposed.

In the circumstances we strongly urge the I-Foundation to think again and seek an alternative brown field site or buildings of a similar nature that can be converted or renovated to the desired standard. This environmentally friendly approach would be fully supported by the William Ellis Action Group. However it must be recognised that given the way the community has been so badly treated continued pursuit of the William Ellis option will only serve to harden attitudes even further.
