DISCUSSION PAPER DEVELOPING AN ACTION PLAN

Our report makes a large number of recommendations to improve resident involvement in Harrow. Their adoption will certainly involve some extra work for HFTRA, individual Tenant and Residents Associations and Council staff in the coming months.

However, we believe it is essential to start strengthening participation in Harrow as quickly as possible. We have set out a potential action plan below. We suggest it should be seen as a template for discussion, rather than a prescriptive document. Page numbers in brackets refer to the page in our report where we made the original recommendation.

Any final action plan must be one that all the partners feel they can deliver. However, we have assumed that residents and other stakeholders will want to see initial progress made as quickly as possible, so we have included reasonably challenging deadlines that we feel should be achievable.
