Section 2 - Report

Following completion of the 2007 Annual Report on Safeguarding, the areas adopted in relation to the Adults and Housing Transformation Programme "Your Future, Our Future", and following the recent (Jan 08) CSCI Inspection, an Action Plan was developed to set out Harrow's commitment to safeguarding our vulnerable groups together with how we will deliver on these aims and objectives.

Financial Implications

While the Action Plan can be delivered within existing resources we are seeking a financial contribution from statutory partner agencies to support some of the work and infrastructure of the safeguarding agenda.

Performance Issues

The current CSCI Independence, Well-being and Choice inspection regime, means that safeguarding is now high on the national agenda. As a result local authorities are required to demonstrate a pro-active approach, ensuring that safeguarding has a high profile and is delivered within a multi-agency framework.

As such it is essential to achieving a good star rating for the Council.

Risk Management Implications

The core principles of Harrow's Safeguarding Adults Policy and Procedures are around safeguarding vulnerable adults from harm, exploitation and abuse - central to this theme is that of risk management.

The ethos in adult services is to support individuals to maximise independence, choice and control over their lives and the services they receive. Inherent within these principles are also risk and risk management issues.

The current agenda for example around Self Directed Support affords individuals greater choice and control over their lives; this potentially involves taking (and being supported to take) risks.

The balance therefore is around supporting people to take those risks, ensuring that appropriate safeguards are in place to manage those risks, while also ensuring that a process is in place for dealing with issues should they arise.
