Section 1 – Summary and Recommendations

This report sets out information requested by the committee on: (1) the numbers of children with special needs statements; (2) the numbers of children at school action plus; (3) the number of requests for statutory special needs assessments; and, (4) the use of the advisory service for parents.

Section 2 – Report

Background

A group made up of members of the former lifelong learning scrutiny subcommittee carried out a review in this area in 2002-03 that reported to the committee in April 2003.

1 **The numbers of children with special needs statements:** The review referred to above concluded that whilst the distribution of special needs statements across mainstream schools was not even, the spread was not unreasonable and significant variations were in the main accounted for by the additional resourcing for meeting specialist needs in particular schools. A report submitted to the Children and Young People Scrutiny Sub-Committee on 13 February 2007 provided information for the period January 2002 until January 2006.

Appendix 1 shows the number of special needs statements (S) for mainstream schools in Harrow and the percentage (% NOR S) this represents of the number of pupils on roll taken from the Schools Census for the period January 2007 until January 2008 that is the latest date this information is available currently. There are expected variations both within and between schools over this period; as a general rule those schools with the highest numbers and proportion of special needs statements are the additionally resourced schools.

The overall percentage of Harrow pupils with special needs statements attending all types of primary schools in January 2007 is 1.7% compared to an average for England of 1.5%. For secondary age pupils the overall percentage is 2.7% that is significantly higher than the average for England of 2.1%.

The authority performs highly in producing special needs statements within the statutory timescale and best value performance indicator data for 2007-08 is as follows:

- BVPI 43a: the percentage of all statements prepared within 18 weeks excluding those involving other agencies 98.7%;
- BVPI 43b: the percentage of all statements prepared within 18 weeks including those involving other agencies 97.4%.

This has now been replaced by National Indicator 103 Special Education Needs - statements issued within 26 weeks. The performance data for 2008-09 is as follows: quarter 1 100%; quarter 2 96.8%.

2 **The numbers of children at school action plus:** Appendix 2 shows the number of children at School Action Plus (P) for mainstream schools in Harrow and the percentage (% NOR P) this represents of the number of pupils on roll taken from the Schools Census for the period January 2007 until January 2008 that is the latest date this information is available currently. Again there are expected variations both within and between schools over this period, reflecting the different needs of children and young people.

The overall percentage of pupils at School Action Plus in Harrow schools in January 2007 is 5.8% that is extremely close to the average for England of 5.9%. In secondary schools the overall average in Harrow of 6.5% is significantly higher than the average for England of 5.1%.

3 **The number of requests for statutory special needs assessments:** The local authority received 200 requests for statutory special needs assessment in the period September 2006 - September 2007 and 175 were agreed. In the period from September 2007 - September 2008 the local authority received 196 requests for statutory special needs assessment and 138 were agreed. There has been a noticeable increase in the number of early years requests and for a large proportion of the requests that were not agreed, it was considered further intervention at Early Years Action Plus was appropriate and statutory assessment not necessary.

The decision to make a statutory special needs assessment is made in the light of all the circumstances of each individual case by the SEN Assessment and Review Panel, comprising local authority officers together with headteachers, special needs co-ordinators and other professionals such as paediatric therapists. This process is regarded as good practice and helps to support consistent and transparent decision-making by the local authority.

4 **The use of the advisory service for parents:** In the academic year 2007-08, Harrow Parent Partnership Service supported the parents and/or carers of 311 children and young people with special educational needs in the age range 0-19 years, in both Harrow and out-borough schools. The local authority has a service level agreement with the London SEN Mediation Service in order to meet its statutory requirement to offer independent disagreement arrangements to help prevent or resolve disagreements between parents, whose children have special educational needs, and the local authority or the school.
