# APPENDIX ONE REPORTS FROM THE SCRUTINY POLICY AND PERFORMANCE LEAD COUNCILLORS

#### **CHILDREN AND YOUNG PEOPLE**

The Scrutiny Lead Members for Children and Young People, Councillor Margaret Davine and Councillor Janet Mote, met on 30 October 2008.

## Issues discussed and key points arising

#### **Care Matters**

Lead members discussed the Care Matters update report that will be presented at the forthcoming Children and Young people focused Overview and Scrutiny meeting on 25 November 2008. The lead members decided that the details of the report presented would dictate whether further work will be carried out through either a challenge panel, light touch review or in depth review.

**Recommended action:** To decide on further action following the receipt and discussion of the update report at the Overview and Scrutiny meeting.

#### Children's Trust

The lead members received a briefing from the Children and Young People's Directorate on the key issues under consideration as part of the plans to develop a formal Children's Trusts in the borough.

**Recommended Action:** Lead members to monitor progress on steps taken towards the development of a formal Children's Trust and report to Overview and Scrutiny any need for in depth investigation.

#### Adoption Inspection

Lead members decided that they would look further into the council's adoption procedures and after care following the presentation of an inspection report at Adoption Panel. The lead members are particularly concerned with the council's follow up and after care procedures, community partnerships and split procedures.

A number of the Adoption Panel members are also due to stand down having come to the end of their term on the panel, in order to avoid a sudden loss of expertise, lead members will be exploring whether there is a possibility that the process can be staggered in future.

**Recommended Action:** Lead members to obtain and read full Adoption Inspection report and discuss with the Director of Children's Services.

#### Obesity Review Update Report

The 6 month Obesity Review update report was presented at the Performance and Finance Committee meeting on 29 October 2008. Lead members felt that there should be a greater emphasis on reinforcing the recommendations that arise from reviews. It was proposed that some work needs to be done on improving the procedures/ processes used by Overview and Scrutiny following the endorsement of recommendations arising from reviews. There is a need to improve the monitoring of implementation and follow up reporting with reminders being issued 2 months before review date.

**Recommended Action:** Overview and Scrutiny members and officers to consider how the monitoring of the implementation of recommendations can be improved.

#### Transition from Children and Young People to Adults

The lead members discussed the council's performance in respect of the transition from Children's care to Adults. The inspection of October 2008 in particular highlighted the need to develop a better link and transition from Children to Adults and especially for those with disabilities and learning difficulties. Lead members feel that perhaps a link officer is required to bridge the gap for continuity and progression.

**Recommended Action:** To be raised and discussed at meeting with the Director of Children's Services.
