### To the Chief Executives of London Boroughs within the jurisdiction of the Valuation Tribunal

Dear Chief Executive

As you are aware, there is a statutory duty placed on us to appoint Members to the Valuation Tribunal.

Regulations now provide that this is a joint process between the Local Authority and the President of the Tribunal. Previous discussions with your Authority have indicated that both the Tribunal and your Authority are prepared to make these appointments in a reasonably informal manner and provided you are happy to continue in that vein we can achieve this process by an exchange of letters.

I attach as an appendix a list of those Members to this Tribunal that are presently appointed. Those Members whose term of office expires on 31<sup>st</sup> December 2006 do not require further consideration at this stage. For those Members whose term of office expires on 31<sup>st</sup> March 2004 we need to decide whether to re-appoint them or not. Some of these Members reach the statutory retirement age in the very near future and I have indicated such. Some Members have failed to respond to requests for information or have not made an attempt to take part in the work of the Tribunal. The President does not propose to suggest re-appointment of those Members. As to the others, I have indicated in bold type those Members that the President has decided he wishes to appoint and I would be grateful for your agreement to their re-appointment.

The President suggests that all those Members be appointed for a term of office expiring on 31<sup>st</sup> December 2009.

The Tribunal is at present under-complement and this is deliberate policy in line with the available workload and possible wasteful expenditure in appointing members that are not required. We are mindful however that following this appointment round we will have a complement of Members that may be under strength if Revaluations planned in 2005 and 2007 generate more appeals than are currently estimated. We intend to keep this area under regular and constant review and will approach you again in the event that additional Members are required.
